Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kykenkee 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. DESCRIPTION OF PLAN

The following description of the Kykenkee 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide employees of Kykenkee, Inc. (the Company or the Sponsor) the opportunity to accumulate savings that provide benefits in the event of retirement, disability or death. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration

The Plan is administered by the Company. On December 31, 2020, Empower Annuity Insurance Company of America (EAICA) acquired the retirement business of Massachusetts Mutual Life Insurance Company (MassMutual). As the Plan held a contract which was issued by Talcott Resolution Life Insurance Company (TRLIC) and administered by MassMutual, this product is now considered provided by EAICA. As such, EAICA assumed custodial responsibilities of the group variable annuity contracts and fixed account held by the Plan. Empower Retirement is the recordkeeper for the Plan.

Eligibility

Participation in the Plan is voluntary. All employees of the Company become eligible to participate in the Plan after attaining 21 years of age and completing 12 months of service. Nonresident aliens who have no earned income from sources within the United States are excluded. Participants can enter the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following date after meeting eligibility requirements. Upon enrollment, participants direct their contributions to various investment options offered by the Plan.

Contributions

Each year, eligible participants may contribute pretax deferrals or Roth after-tax deferrals up to 100% of their eligible compensation, as defined in the Plan not-to-exceed the amount allowed for income tax purposes. Participants may also rollover contributions from other qualified defined benefit or defined contribution plans. Catch-up contributions are permitted under the Plan and are subject to employer match.

The Sponsor contributes a safe harbor matching contribution equal to 100% of the first 4% of participant-eligible compensation. The Company may also make a discretionary additional matching contribution. For the year ended December 31, 2024, there were no discretionary contributions made to the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses, as applicable. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants are fully vested in their contributions, the Sponsor's safe harbor contribution, the Sponsor's discretionary profit-sharing contribution and the earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement (age 62), or separation from service, a participant or their beneficiary may receive their vested balance in either a single lump-sum distribution, a direct rollover into a qualified retirement plan or individual retirement account, monthly installments, or defer receiving payments until age 73. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be cashed out. In-service distributions are available upon reaching age 59½, for financial hardships as defined by the Plan, and from rollovers or after-tax accounts.

Administrative Expenses

The Company pays substantially all administrative costs of the Plan, except for recordkeeping fees, investment advisory fees, and various fees associated with these activities, which are paid by the participants.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. A participant may only have one loan outstanding at a time. Loans are secured by the balance in the participant's account and bear interest at rates as noted within the Plan document. Loan repayments are made through payroll deductions, generally over periods ranging up to five years unless it is for the purchase of a primary residence.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments include a fixed account and variable annuity contract in which the Plan invests in pooled separate accounts. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fixed annuity account which is stated at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the custodians of the funds. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.

If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Pooled Separate Accounts (PSA): The Plan entered into a group annuity contract with TRLIC, in which the Plan investments are held in a PSA held by TRLIC. The PSA is broken into sub-accounts which are used to determine designated underlying mutual funds offered under the Plan. These investments are PSAs that are valued based upon net asset value (NAV) as provided by the custodian of the funds. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. There were no Level 1 or Level 3 investments as of December 31, 2024 and 2023.

5. GROUP ANNUITY INVESTMENT CONTRACT

The Plan is funded with a group annuity contract originally issued by TRLIC. The contract offers a fixed investment option through TRLIC. As described in Note 2, the contract meets the fully benefit-responsive investment contract criteria; and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value for the fixed option represents amounts contributed or transferred to the fixed option less any withdrawals or transfers out, plus all accrued interest. The fixed option earns interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by TRLIC. Interest rates for new contributions are declared prior to the beginning of a calendar quarter and are applicable to all contributions received in that quarter until the end of the calendar year next following the current year. The fixed option is backed by TRLIC's general account. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory requirements.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. PARTY-IN-INTEREST TRANSACTIONS AND RELATED PARTY TRANSACTIONS

The Plan's investments are held under the Contract with EAICA. The Contract includes an executed separate account rider whereby the contract offers individual separate accounts and a fixed income account to participants. As such, these transactions qualify as party-in-interest transactions. In 2024, the Plan paid recordkeeping fees to Empower Retirement Services and investment advisory fees to Raymond James. These expenses are reflected in administrative expenses within the statement of changes in net assets available for benefits for the year ended December 31, 2024.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Company contributions.

8. TAX STATUS

The Plan has adopted a prototype plan document sponsored by Great-West. The prototype plan document received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The prototype plan document has been amended since receiving the opinion letter. However, Great-West and the Company believe that the prototype plan document is currently designed and operated in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that most likely would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
