In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **Caruso Homes Employee 401(k) Plan**'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters – Supplemental Schedules Required by ERISA**

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 – Description of The Plan

The following description of Caruso Homes Employee 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan sponsored by Caruso Homes, Inc. (the “Company”). The Plan was originally formed on September 1, 2014, and has been subsequently amended and restated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

T. Rowe Price is the Plan’s custodian and recordkeeper. The Plan adopted Reliance Trust Company as trustee for the years ended December 31, 2024 and 2023.

#### Eligibility

The Plan covers substantially all employees of the Company who have 90 days of service and have attained twenty-one years of age. Prior to December 20, 2020, eligibility was 30 days of service and attainment of age twenty-one. Participants can enter the plan the first day of the month coinciding with or next following date eligibility requirements are satisfied.

#### Contributions

Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan permits Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a discretionary matching contribution equal to a uniform percentage of salary deferrals. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions equal to 25 percent of the participants deferral up to \$1,250. The Company may also elect to make a discretionary profit-sharing contribution on behalf of eligible participants as defined in the Plan. Participants must be employed by the Company on the last day of the Plan year to receive the discretionary profit-sharing contribution. During the year ended December 31, 2024, the Company made no profit-sharing contributions. Contributions are subject to certain Internal Revenue Services (IRS) limitations.

The Company also has the option to make contributions to the Plan on behalf of all participants which shall be treated as Qualified Nonelective Employer Contributions (“QNEC”) to the extent such contributions may be used to meet the nondiscrimination requirements of the Internal Revenue Code (the “Code”). During the year ended December 31, 2024, the Company made \$3,585 in QNEC contributions.

### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the value of the account balances or as an equal dollar amount based on the number of Participants in the Plan as defined in the Plan provisions. Participant accounts may also be charged for individual expenses such as distribution and participant loan origination fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions and the QNEC contribution plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on a two-to-six-year graded vesting schedule as follows:

Years of Vesting Service	Vesting Percentage
Less than Two Years	0%
Two Years but less than Three Years	20%
Three Years but less than Four Years	40%
Four Years but less than Five Years	60%
Five Years but less than Six Years	80%
Six or More Years	100%

Year of vesting service means a vesting computation period during which a participant completes 1,000 hours of service during the Plan year and considers Breaks in Service as defined in the Plan provisions.

Participants become fully (100%) vested upon employee death, disability or attainment of Normal Retirement Age while an employee.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may have one loan outstanding. The loans are secured by the balance in the participant's account and bear interest at market rates as determined by the plan administrator. On December 31, 2024 and 2023 the interest rates for outstanding loans range from 7.25 percent to 9.50 percent and from 4.25 percent to 8.50 percent, respectively. Principal and interest is paid ratably through payroll deductions for a term of not greater than five years unless for the purchase of a participant's primary residence.

### Payment of Benefits

The Plan provides benefit payments to participants upon termination of employment, death, hardship, attainment of age 59 1/2, normal retirement, or plan termination. On termination of employment other than

death, for vested balances less than \$5,000, a participant may elect to receive payment in the form of a single lump-sum and for vested balances greater than \$5,000, a participant may elect to receive distribution in:

- a single lump-sum
- partial withdrawal or installments but only with respect to minimum required distributions, over a period of not more than the participant's assumed life expectancy.

On death, for vested balances less than \$5,000, a participant's beneficiary will receive payment in the form of a single lump-sum and for vested balances greater than \$5,000, a participant's beneficiary may elect to receive distribution in:

- a single lump-sum
- partial withdrawal or installments that do not exceed the limitations on when the entire death benefit must be paid as described in the Plan provisions.

Terminated participants with vested account balances less than \$1,000 will automatically receive a lump sum distribution directly to the participant.

In-service withdrawals are permitted at age 59½, subject to provisions described in the Plan provisions. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, there were \$34,266 and \$17,562 of unapplied forfeitures, respectively. These accounts will be used to reduce future employer contributions or pay reasonable Plan expenses. During the year ended December 31, 2024, the Plan applied \$9,717 in forfeitures to reduce employer contributions.

#### **Note 2 – Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### **Use of Estimates**

The preparation of the financial statements in accordance with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value based on quoted market prices of the underlying investment securities held by each investment fund. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Benefits Paid

Benefit payments are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Individual fees charged directly to the participant's account are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, the report date of these financial statements, the date these financial statements were available to be issued.

### Note 3 – Certified Investments

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplement schedule, including investments held at December 31, 2024 and 2023, and net appreciation of investments and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Money Market Fund and Registered Investment Companies

Valued at the daily closing price of the shares as reported by the fund. The money market fund and registered investment companies held by the Plan is open-ended funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. The Plan's money market fund and registered investment companies are Level 1 within the fair value hierarchy.

### **Note 5 – Related-Party Transactions and Party in-Interest Transactions**

Certain Plan investments are managed by T. Rowe Price. T. Rowe Price is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain accounting and administrative functions of the Plan are performed by employees of the Sponsor at no cost to the Plan.

### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

### **Note 7 – Income Tax Status**

The Plan has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement plan is qualified under section 401(a) of the IRC and, therefore, the related trust is intended to be exempt from federal income taxes under the applicable sections of the IRC. The Plan has been amended since the date of this opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying modified cash basis statements of net assets available for benefits.
