INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of  
Disability Rights Texas 401(k) Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Disability Rights Texas 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Disability Rights Texas 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Disability Rights Texas 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Disability Rights Texas 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Disability Rights Texas 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS**  
**December 31, 2024 and 2023**

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Disability Rights Texas 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all eligible employees of Disability Rights Texas (the Company). The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). Employees who are 21 years of age, have completed twelve (12) months and 1,000 hours of service can make deferral contributions to the Plan and are eligible to participate for employer contributions. The trustee for the Plan is Empower Annuity Insurance Company. The Board of Trustees is responsible for oversight of the Plan.

**Tax Status of the Plan.** The Internal Revenue Service (IRS) has determined and informed the Company by letter dated September 18, 2010, that the Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America ("US GAAP") requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Contributions.** Each year, eligible employees may contribute up to 100% of total compensation on a pre-tax basis up to the annual IRS maximum limit. Additionally, participants aged 50 years or above are eligible to make additional catch-up contributions. A portion of the employee contribution may be designated as Roth 401(k) after-tax contributions. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan automatically deducts a set percentage for employee deferrals into the Plan unless the employee opts out and changes the deferral to a different rate including 0%. Each plan year on January 1, the deferral percentage will increase by 1% until it reaches a limit of 10%, then the automatic deferral amount will be either 10% or the greater of the employee's selected deferral rate. The automatic deferral amount was 10% in 2024 and 10% in 2023. Each year, the employee is required to opt out of the minimum deferral amount.

The Company is not required to make a matching contribution. The Company makes an elective contribution for all qualified employees. An employee does not have to make a salary reduction contribution to participate in the Company's contribution. In order to be eligible for employer contributions, a new participant must have completed 1,000 hours of service in the first twelve-months eligibility computation period. The Company's contribution is allocated among employees based on the employee's compensation as compared to total compensation for all employees for the year. Each year, the Company makes a discretionary contribution to the Plan. The employer contribution rate was 7% for the years ended December 31, 2024 and 2023.

## **NOTE 1 – DESCRIPTION OF THE PLAN, Cont'd**

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants.** The Plan Administrator adopted a participant loan program as part of the Disability Rights Texas 401(k) Plan with an effective date of October 18, 2016. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the participant's highest outstanding loan balance in the previous twelve months and the existing loan balance, even if all or a portion of this amount has been repaid. The loans are secured by the balance in the participant's account.

The interest rate on the loan is based on the prime rate of interest published by The Wall Street Journal for lending institutions as of the date of the loan, plus 1 percent. Principal and interest is paid ratably through monthly payroll deductions.

**Vesting.** Participants are immediately 100% vested in their salary reduction contributions plus actual earnings thereon. Under the prior vesting schedule (which applied to the Company's contribution for all employees hired after January 1, 2003, and before January 31, 2008), participants were fully vested after six (6) years of service. Participants hired on or after January 31, 2008, are fully vested after five (5) years of service.

**Payment of Benefits.** Participants are entitled to receive a lump-sum distribution of their vested accounts upon termination of employment, disability, death, or in the event of financial hardship. Distributions are federally taxable to participants when received and distributions prior to age 59 ½ may result in a 10% federal income tax penalty. The Plan does provide for benefit payments in the event of hardship as defined in the Plan.

**Plan Termination.** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine. However, under the Collective Bargaining Agreement with the Communication Workers of America, the Company has agreed to continue the Plan.

**Administration.** Administrative and recordkeeping services, including maintaining participant records and allocating the Plan's income and contributions, for the year ended December 31, 2024, were provided by The Allocation Company. Administrative and record keeping fees charged by third-party administrators comprised of legal, advisory, and audit expenses are paid by the Company. Such fees and expenses approximated \$20,025 and \$21,975 for the years ended December 31, 2024 and 2023, respectively.

**Forfeited Accounts.** Forfeitures of the Company's discretionary contributions are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$100,724. For the years ended December 31, 2024 and 2023, forfeitures of the Company's discretionary contributions accounts of \$118,792 and \$0, respectively were allocated to plan participants.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with US GAAP.

**Use of Estimates.** The preparation of financial statements in accordance with US GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Cont'd**

**Investment Contracts.** Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. Using a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset quarterly, fair value of the investment contract, prior to contract termination, equals the contract value; therefore, there is no adjustment to contract value included in the Statement of Net Assets Available for Benefits.

**Investment and Securities Transactions.** The Plan's investments consist of participant directed investments in numerous mutual funds and fixed income annuities and are held by the Plan Trustee, Empower Annuity Insurance Company. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income are reported on the accrual basis. Net appreciation includes the Plan's realized gains and losses on investments bought and sold as well as unrealized appreciation and depreciation on investments held at year end.

**Notes receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Subsequent Events.** The Plan has evaluated subsequent events in accordance with the provisions set forth in FASB Accounting Standards Codification ("ASC") 855 "*Subsequent Events*", as amended by FASB ASC No. 2011-09 through September 27, 2024, the date the financial statements were available to be issued and has determined that no events have occurred that require additional disclosure.

## **NOTE 3 – INVESTMENTS**

The Plan's management has elected the method of compliance permitted by 29 CFR2920.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Empower Annuity Insurance Company for the year ended December 31, 2024 and 2023 as being complete and accurate and was not subject to any auditing procedures performed by the independent public accountants:

- Total investments as shown in the accompanying statements of net assets available for benefits of \$21,214,937 and \$17,667,579 as of December 31, 2024 and 2023, respectively.
- Net investment gain as shown in the accompanying statement of changes in net assets available for benefits of \$1,468,238 for the year ended December 31, 2024.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **NOTE 4 – FAIR VALUE MEASUREMENTS, Cont'd**

**Mutual Funds.** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Fixed Annuities.** The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. Using a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset quarterly, fair value of the investment contract, prior to contract termination, equals the contract value.

**Collective Trust Funds.** Investments measured using net asset value as a practical expedient are not categorized within the fair value hierarchy.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – KEY GUARANTEED PORTFOLIO FUND**

In 2013, the Plan entered into a benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company. This is reported on the Statement of Net Assets Available for Benefits as Fixed Annuities. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statement of Net Assets Available for Benefits at fair value. Using a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset quarterly, fair value of the investment contract, prior to contract termination, equals the contract value; therefore, there is no adjustment to contract value included in the Statement of Net Assets Available for Benefits.

The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 and 2023 is 1.41% and 1.23%, respectively.

#### **NOTE 6– FINANCIAL INSTRUMENTS**

The Plan's investments consist primarily of mutual funds investments held by the Plan's Trustee, Empower Annuity Insurance Company as of December 31, 2024 and 2023. The fair value and historical cost of the investments at year-end are as follows:

**NOTE 7 – BENEFITS PAYABLE**

Obligations for benefits payments to terminated employees are not reflected as liabilities of the Plan in accordance with guidance for accounting and disclosure by employee benefit plans. At December 31, 2024 and 2023, there were no allocations of net assets for benefits for terminated employees.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities held with Empower Annuity Insurance Company. Such investments are exposed to various market risks. It is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balance and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE 9 – ERISA BONDING REQUIREMENTS**

ERISA, Title I, Section 412, requires that every fiduciary and every person who handles fund or other property of a plan be bonded. The Plan is required to have a bond equal to the lesser of 10% of the value of the Plan assets at the beginning of the year or \$500,000. The Plan held a bond in the amount of \$500,000 during the year ended December 31, 2024.
