## Independent Auditors' Report

### 1. Description of Plan

Effective October 1, 2003, International Rescue Committee, Inc. (the "IRC"), adopted the IRC 403(b) Retirement Savings Plan (the "Plan").

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of the IRC except those employees who are non-resident aliens, Puerto Rican employees, leased employees and AmeriCorps members. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

Each year, participants may contribute up to 50% of their annual compensation on a pre or after tax basis up to the applicable dollar amount which is established annually by the Internal Revenue Service ("IRS"), as defined in the Plan document. The Plan has an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants will have their deferral rate set at 3% of their eligible compensation and their contributions will be invested in a target date fund that has a targeted retirement date nearest to the participant's attainment of age 65. Annually, the auto enrollment deferral rate will be increased by 1% each year until a maximum of 15% has been reached which applies to all participants contributing at least 1% unless they opt out. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to the statutorily permitted amount.

Participants may also rollover or transfer amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one group annuity contract, and twenty-nine mutual funds as investment options for participants.

The IRC will make safe-harbor matching contributions for participants who make contributions up to 6% of their compensation. The rate of company matching contributions is 100% of the participant contributions up to 3% of compensation; plus 50% of the participant contributions on the next 3% of compensation.

### 1. Description of Plan *(continued)*

#### **Contributions *(continued)***

In accordance with the plan document, the IRC will make non-elective discretionary contributions for eligible employees who are enrolled in the Plan. The non-elective discretionary contributions are calculated each pay period based on a percentage of participant eligible compensation earned during such pay period and a participant's combined whole years of age and service as of December 31 of the immediately preceding year, according to the following schedule:

Under 35	3%
35-44	4%
45-54	5%
55-64	6%
65 and up	7%

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the IRC's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### **Vesting**

Participants are fully vested at all times in their contributions and IRC safe-harbor matching contributions. Participant's non-elective discretionary IRC contributions are vested in accordance with the following schedule:

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$218,906 and \$45,253. These accounts will be used to reduce future IRC non-elective discretionary contributions and pay Plan expenses. In 2024, employer contributions were reduced by \$1,931,388 and \$1,788 was used to pay Plan expenses from forfeited non-vested accounts.

#### ***Payment of Benefits***

Benefits are paid upon retirement (age 65), death, age 59 1/2 or other termination of employment. Upon retirement or termination of employment, a participant may elect to receive in cash or direct rollover a lump-sum amount equal to the vested value of the participant's account. If the account balance is below \$5,000, it will be paid in a single sum of cash. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by IRC and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

#### ***Other Income***

The Plan and Empower Annuity Insurance Company of America have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the ERISA Account. The ERISA Account is invested in the Empower PPSA and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The ERISA Account balance was \$126,340 and \$74,401 at December 31, 2024 and 2023. During 2024, administrative expenses incurred by the Plan were reduced by \$96,944 from the ERISA account.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. The Plan's investments, that were valued at fair value, were valued using level 1 inputs.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value, except for the group annuity contract which is recorded at contract value. The mutual funds are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and they are required to publish their daily net asset value and to transact at that price. These funds are deemed to be actively traded. The Empower PPSA is a group annuity contract that is valued at contract value which represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### ***Payment of Benefits***

Benefit payments are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses are paid by either the Plan or IRC, as provided by the Plan's provisions. Expenses paid by IRC are excluded from these financial statements. Investment transaction fees are included as reduction to net appreciation in value of investments which are allocated to each participant's account.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 19, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower"), qualified institutions.

### **4. Group Annuity Contract**

Participants can invest in a benefit responsive group annuity contract with Empower Annuity Insurance Company of America called the Empower Principal Preservation Separate Account (“PPSA”). The PPSA is a stable value product that provides protection from Empower’s general account and guarantees principal and accumulated interest. The PPSA invests in a broadly diversified portfolio of fixed income instruments (primarily in intermediate-term bonds, private placements and commercial mortgages). The interest crediting rate is announced in advance and is guaranteed for a six-month period for which a minimum rate will apply. Distributions resulting from a participant’s termination of employment, retirement, disability or death, hardship withdrawals and minimum required distributions are always paid in full without any restrictions or fees. Generally, participants may not directly transfer amounts from the PPSA to a competing fund. A transfer out of the PPSA must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### **5. Plan Termination**

Although it has not expressed any intent to do so, the IRC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of a plan termination, participants would become 100% vested in their IRC contributions.

### **6. Tax Status**

IRC has adopted a volume submitter plan document which is intended to satisfy the Internal Revenue Service’s final 403(b) regulations. The volume submitter plan document preparer received an opinion letter dated September 21, 2022. The IRC believes that the Plan, is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain investments are managed by Empower. Empower are the trustees as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of IRC, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### 8. Non-Exempt Party-In-Interest Transactions

During the 2024 Plan year and prior, the Employer failed to remit to the Plan certain participants' contributions amounting to \$19,834 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer has calculated and remitted lost earnings for the \$19,834 of delinquent contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
