### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of **ASHA 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### 1. Description of the Plan

The following description of the ASHA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan that became effective on January 1, 1982. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and it covers all employees of American Speech-Language-Hearing Association (“ASHA”, “Company” or “Plan Sponsor”). Employees are eligible to participate in the Plan from the first day of employment except for leased employees, non-resident aliens, Puerto Rican employees, interns and independent contractors, as defined in the Plan.

#### *Trustee, Custodian and Recordkeeper*

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a member of the Principal Financial Group (collectively, Principal) is the trustee, custodian and recordkeeper of the Plan. The administrator of the Plan was the Company. Principal held all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Retirement Plans Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### *Contributions*

Participants may elect to defer a maximum of 90% of their calendar-year compensation, as defined, up to the maximum allowable by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees who are eligible and do not specifically decline enrollment are automatically enrolled in the Plan as a participant with a deferral election of 3%. Roth deferrals are also permitted. The Plan does not permit In-Plan Roth Rollover contributions.

All employees receive a quarterly employer discretionary non-elective contribution of 3% of their base salary for the portion of the year in which they were eligible to participate in the Plan. This contribution totaled \$946,780 for year ended December 31, 2024.

The Plan also contributes an employer match provision of up to 2.5% of eligible pay. This contribution totaled \$729,685 for the year ended December 31, 2024. Employees first become eligible to receive the employer contribution semi-annually, the first day of the first month and of the seventh month of plan year.

Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of employer contributions and investment earnings and charged with an allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as

defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### ***Investment Options***

Participants direct the investment of their employee and employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and guaranteed income funds as investment options for participants.

### ***Vesting***

Participants vest immediately in their contributions plus actual earnings thereon. Prior to January 1, 2017, employer contributions were 100% vested after an employee completes five years of vesting service or upon reaching normal retirement age of 65. As defined by the Plan, a year of vesting service meant the vesting computation period during which an employee completes at least 1,000 hours of service, without regard to whether the employer continues to employ the employee during the entire vesting computation period. Effective January 1, 2017, employer contributions vest after three years of vesting service.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$643 and \$76, respectively. These accounts can be used to pay administrative expenses or to reduce future employer non-elective and matching contributions. During 2024, employer contributions were reduced by \$68,743 from forfeited non-vested accounts.

### ***Distributions of Benefits***

Benefit payments are made in the form of participant directed lump-sum withdrawals upon severance from employment, retirement, death, or disability or upon attainment of age 59½, as applicable. Benefits may be paid in cash, rolled over to another qualified retirement plan or IRA, or remain in the Plan until the participant chooses to take a distribution. For vested account balances less than \$5,000 and greater than \$1,000, benefits may, at the option of the participant, be paid as a cash distribution, rolled over to another qualified retirement plan or IRA, or if no election is made transferred to an individual IRA. Vested account balances less than \$1,000 will be paid to the individual as a cash distribution.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Hardship withdrawals can be made from all or any part of a participant's vested account resulting from elective deferral contributions and matching contributions.

Withdrawals after age 59½ can be made at any time of an amount which is equal to any whole percentage (not exceeding 100%) of vested account balances attributable to elective deferral contributions and rollover contributions, including earnings. Employer contributions are available for in-service withdrawals.

### *Notes Receivable from Participants*

Participants in the Plan may borrow from the Plan. Loan amounts must not exceed the lesser of 50% of the participant's account balance, reduced by the highest outstanding loan balance from the prior one-year period, or \$50,000. Loans are only permitted from a participant's elective deferral and rollover account balances. Generally, a loan term is up to five years, unless the loan is for a primary residence, in which case the loan term may be up to 10 years. The loans are secured by the balance in the participant's account. The loans bear interest at a rate based on the rates available for similar loans from commercial lending institutions. Loans are repaid via regular payroll deductions. Participants are allowed one loan outstanding at any given time.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make certain estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan invests in the Principal Fixed Income Guaranteed Option, a fully benefit-responsive group annuity contract (see Note 5).

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Employer discretionary non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Benefit Payments**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Fees related to participants-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. Substantially all other expenses of the Plan are paid by the Company and are excluded from these statements.

### **Revenue Credits**

The Plan's trust agreement with Principal provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. During 2024, the Plan received credits of approximately \$45,690, which were used to pay administrative expenses. Revenue credits are presented in other income in the statement of changes in net assets available for benefits. There were no unallocated revenue credits at December 31, 2024 and 2023.

## **3. Concentration of Significant Investments**

The Plan's significant investments are as follows:

December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### 5. Fair Value Measurements

The fair value hierarchy provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds:* Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing net asset value as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore classified as Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Investment Contract With Insurance Company

The Plan entered into a benefit-responsive investment contract, the Principal Fixed Income Guaranteed Option, with Principal. Under this contract, contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that the probability of any events that would limit the Plan's ability to transact at contract value with participants are remote.

### 7. Related Party and Parties-In-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Principal by participants. The Plan also receives revenue credits from Principal. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to Principal. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 8. Tax Status

Effective January 1, 2022, the Plan adopted the Prudential Pre-Approved Defined Contribution Plan ("Pre-Approved Plan"). The IRS ruled on September 16, 2022, that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 10. Operational Compliance

For one payroll period in May 2024 and one payroll period in June 2024, it was discovered that certain Plan provisions were not properly applied in the daily operations of the Plan. Due to a system issue within the plan record keeper's platform, the updated deferral records for a specific pay period were not transmitted to the Company. As a result, the Company was unable to withhold the updated deferral elections for certain eligible participants who made changes during these pay periods. This issue was recognized and communicated with the record keeper and the Company immediately processed the updated deferral elections in the next pay period. The Company also corrected the error utilizing the IRS self-correction program without filing a formal submission with the IRS, which is permitted. In accordance with the IRS correction programs (under the IRS Employee Plans Compliance Resolution System or EPCRS), the Company corrected the missed employer match for the affected participants but it did not make a Qualified Nonelective Contribution (QNEC) for missed salary deferrals, which is acceptable, since the correct employee deferrals were processed within 9.5 months of the plan year the failure occurred and the plan sponsor provides a notice to the affected participants no later than 45 days after the date the correct deferrals begin.

### **11. Plan Termination**

Although ASHA has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **12. Subsequent Events**

The Plan Administrator has evaluated subsequent events and transactions through September 4, 2025, the date the financial statements were available to be issued.
