Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i - Schedule of Assets Held (At End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE A – DESCRIPTION OF PLAN

The following description of the Child Saving Institute Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees, as defined by the Plan, of Child Saving Institute, Inc. (the Employer). Prior to January 1, 2023, the Plan had eligibility requirements of age 19 and six months of service. Effective January 1, 2023, the Plan was amended to remove age and service requirements. Participants are automatically enrolled in the Plan at a rate of 2% (employees have the option to change this rate as desired). In addition, the Plan has an automatic increase of elective deferral rates on February 25th of each year in 1% increments, up to a maximum elective rate of 10%; the increase shall apply to all participants who have been enrolled in the Plan for at least six months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Entry dates are the first day of each month following the month that all eligibility requirements are met. The Child Saving Institute Retirement Plan Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investments performance, and reports of the Employer's Board of Directors.

Contributions

Participants may contribute up to 75% of their pre-tax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans. Participants direct the investment of their employee and Employer contributions into various investment options offered by the Plan. Contributions are subject to certain dollar limitations, as imposed by the Internal Revenue Service (IRS).

Prior to January 1, 2023, the Employer provided a discretionary matching contribution each year. Effective January 1, 2023, a safe harbor matching contribution provision was added for the Company to match 200% of the first 1% of eligible compensation and 100% of the next 3% of eligible compensation.

In addition, the Employer may make additional discretionary matching contributions. There were no discretionary contributions made to the Plan for the years ended December 31, 2024 and 2023.

NOTE A – DESCRIPTION OF PLAN (Continued)

Participant's Accounts

Each participant's account is credited with the participant's contributions (including rollovers) and allocations of (a) the Employer's contributions and, (b) Plan earnings (losses) on the participant's and Employer's contributions, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions (including rollovers) plus actual earnings thereon. Effective January 1, 2023, participants are also immediately vested in the Employer safe harbor matching and discretionary matching contributions plus actual earnings thereon. Participants also become 100% vested in their entire account balance on or after their early and normal retirement age or upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through regular payroll deductions over a period not to exceed five years, unless the purpose of the note is to purchase a principal residence, in which case the maximum loan period is ten years. At December 31, 2024 and 2023, interest rates were between 4.25% to 9.50%.

Payment of Benefits

Upon termination of service, due to death, disability, retirement or for other reasons, a participant can elect to receive the value of his or her vested account balance, as defined by the Plan. The Plan also permits in-service distributions when the participant reaches age 59 ½ or due to hardship, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts total \$19 and \$0, respectively. These accounts will be used to reduce future Employer contributions to the Plan. During the years ended December 31, 2024 and 2023, the Employer used \$577 and \$10, respectively, for forfeitures to reduce Employer contributions to the Plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note D for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants or distributions are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

Income Taxes

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

NOTE D – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a hierarchy of three levels of inputs that may be used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Mutual Funds: Valued at fair value as determined by quoted market prices in active markets, which represents the net asset value (NAV) of shares held by the Plan at year end.

Common Collective Trust: Valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments of the fund less its liabilities and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – RELATED PARTY TRANSACTIONS

Plan investments are held in accounts managed by Fidelity and therefore, these transactions qualify as party-in-interest transactions under ERISA. The Plan has a number of service providers which qualify as parties-in-interest. Fees paid by the Plan to parties-in-interest amounted to \$51,329 and \$42,762 for the years ended December 31, 2024 and 2023, respectively.

NOTE G – INCOME TAX STATUS

The Plan has adopted a pre-approved plan document. The pre-approved plan document has received an opinion letter from the IRS dated June 30, 2020 as to the volume submitter plan document’s qualified status. The volume submitter plan document’s opinion letter has been relied upon by this Plan. Although the Plan has amended the volume submitter plan document, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
