### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

## **Note 1. Plan Description**

The Kelly Box and Packaging, Corp. 401(k) Savings Plan is a defined contribution plan covering employees of Kelly Box and Packaging, Corp. (the Company or Plan sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

### Eligibility

All employees are eligible to participate in the Plan following one year (1,000 hours) of service and having attained 21 years of age. Employees may enter the Plan on January 1, April 1, July 1, and October 1, after reaching the eligibility requirements.

### Contributions

Participants may elect to contribute between 1% and 100% of eligible pre-tax compensation up to the statutory dollar limit established by the Internal Revenue Code. The Company may make a discretionary match or profit sharing contribution as determined by the board of directors. The match contribution is capped each year at \$1,250 per participant. For 2024, total Company contributions were \$266,489.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Participants have the option of investing in a variety of mutual funds and a money market fund offered through Charles Schwab Trust Bank. All amounts in participant accounts are participant-directed; however, if a participant does not choose an investment allocation, the Plan provides for a default investment option.

### Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of Prime plus 2% (determined at origination). Only one loan is allowed to be outstanding per participant. Generally, loans are limited to a maturity period of five years. Loans for the purchase of a principal residence are limited to ten years. Loans outstanding at December 31, 2024, mature through 2033 and bear interest at a range of 5.25% to 10.50%.

## **Note 1. Plan Description (Continued)**

### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution's plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

### Benefit Payments

Benefits under the Plan are payable in the form of installments, partial withdrawals or as a lump sum. Benefits are payable when a participant retires, dies, or otherwise ceases to be an employee. Participants who are still active may also receive lump sum benefit payments upon attaining age 59 1/2 or for hardships. Additionally, rollover contributions are available for distribution at any time.

### Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeitures are used to reduce future Company contributions. At December 31, 2024 and 2023, forfeitures of approximately \$0 and \$7,500 were available to reduce future Company contributions. During the Plan year ended December 31, 2024, approximately \$30,000 of forfeitures were used to reduce Company contributions.

### Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of plan termination, participants will become fully vested in their accounts.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

## **Note 2. Significant Accounting Policies (Continued)**

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan will be deemed distributed and the loan balance will become taxable to the participant.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Payment of Benefits

Payment of benefits to participants are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation in fair value of investments.

### Subsequent Events

The plan administrator has evaluated events and transactions for possible recognition or disclosure through September 24, 2025, the date the financial statements were available to be issued.

## **Note 3. Information Certified by Charles Schwab Trust Bank**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Charles Schwab Trust Bank and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income as shown in the accompanying statement of changes in net assets available for benefits, including dividend and interest income, net realized and unrealized appreciation in investments and interest income on notes receivable from participants.

## **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## **Note 4. Fair Value Measurements (Continued)**

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund and mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 5. Transactions with Parties-In-Interest**

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in money market funds and mutual funds affiliated with the trustee. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

## **Note 6. Income Tax Status**

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, stating that the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor and plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **Note 7. Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
