## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Burrtec Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed audit of the financial statements of the Burrtec Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## **NOTES TO FINANCIAL STATEMENTS**

December 31, 2024 and 2023

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Burrtec Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **(a) GENERAL**

The Plan is a defined contribution 401(k) plan which covers all full-time employees of Burrtec Waste Industries, Inc., Burrtec Waste Services, LLC, Yucaipa Disposal, Inc. and Burrline, LLC (the Burrtec entities), and Burrtec Waste and Recycling Services, LLC, Burrtec Environmental, LLC, and Burrtec Recovery and Transfer, LLC (the Desert entities) (collectively, the company). Employees are eligible after completion of three months of service and age eighteen or older. Leased employees and employees under collective bargaining agreements are exempt from the Plan. The Plan is subject to ERISA.

The Plan became effective on June 1, 1992 and was most recently amended and restated on July 1, 2022 to include employees of Burrtec Kern, LLC as well as to satisfy the requirements of the cycle three restatement.

#### **(b) CONTRIBUTIONS**

In accordance with the Plan Adoption Agreement, the Company, for each plan year, will determine the amount of the matching contributions to be made, if any. Participants may contribute up to 50% of pre-tax annual compensation, subject to Internal Revenue Service (IRS) regulation limitations, which was \$23,000 in 2024. Participants who have attained age 50 by the plan year end may also make additional catch-up contributions up to a maximum of \$7,500 during the year ended December 31, 2024. Employees who meet the eligibility requirements will be automatically enrolled at 3% of pre-tax compensation.

The Company may make discretionary matching contributions based on employee elected deferrals at a rate declared annually by the Company. For participating employees of the Burrtec entities, the company contributed an amount equal to 50% of the first 6% of each participant's contribution for the year ended December 31, 2024. For participating employees of the Desert entities and Burrtec Kern, the company contributed an amount equal to 100% of the first 3% and 50% of the next 3% of the participant's contribution for the year ended December 31, 2024.

#### **(c) PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, the company's matching contributions, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **NOTE 1 - DESCRIPTION OF THE PLAN** (continued)

#### **(d) VESTING**

Participants are immediately 100% vested in both their voluntary contributions and the company's matching contributions plus earnings thereon.

#### **(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow up to 50% of their vested account balance. Notes receivable from participants may be made for a minimum of \$1,000 and a maximum of \$50,000. The Plan requires an interest rate commensurate with the prevailing interest rate charged on similar commercial loans under like circumstances by persons in the business of lending money. Notes receivable from participants are secured by their vested interest in the Plan and they may have a maximum of two loans outstanding at a time. Notes receivable from participants must be repaid within five years unless it is for the purchase of a principal residence, in which case, it can be repaid within thirty years. At December 31, 2024, interest rates on notes receivable from participants ranged from 4.25% to 10.50%. Principal and interest are paid through payroll deductions. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **(f) PAYMENT OF BENEFITS**

On termination of service, a participant may elect to receive a single lump-sum payment of the value of his or her account, equal installments or an annuity for a period not exceeding life expectancy. Benefits are recorded when paid. There were no pending benefit claims for participants separated from service that have not yet been paid as of December 31, 2024.

#### **(g) ADMINISTRATIVE EXPENSES**

The Plan incurs fees and administrative costs which are assessed by a third-party administrator. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain distributions are charged directly to the participant's account and are included in administrative expenses.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **(a) BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared under the accrual method of accounting.

#### **(b) USE OF ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the reporting period. Although the Plan administrator believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

#### **(c) RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including an investment under a common collective trust and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the financial statements.

#### **(d) INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **(f) SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events and transactions occurring subsequent to the statements of net assets available for benefits date for December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through September 24, 2025, the date the financial statements were available to be issued. No such material events or transactions were noted to have occurred.

### **NOTE 3 - INVESTMENTS**

The Plan's funds are maintained by Ascensus Trust Company (Ascensus). The Plan's funds are credited with contributions and actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of December 31, 2024 and 2023 are the values as reported to the Plan by Ascensus.

The following was certified as to being complete and accurate by Ascensus:

- Investment accounts and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Supplementary schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and statement of changes in net assets available for benefits and the supplementary schedule of assets (held at end of year) as of December 31, 2024.

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options maintained by Ascensus. Participants may change their investment options at their discretion.

### NOTE 4 - FAIR VALUE MEASUREMENT

The Plan adopted a fair value measurement accounting standard for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following table presents information about the Plan's assets that are measured at fair value on a recurring basis at December 31, 2024 and 2023, and indicates the fair value hierarchy of the valuation techniques utilized to determine such fair value:

The following is a description of the valuation methodologies used for assets measured at fair value.

- **Mutual Funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.

### NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain investment instruments are managed by Ascensus. Ascensus is a trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the assets will be allocated to each participant in the proportion each account balance bears to the total of all account balances.
