### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Paragon Technology Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Paragon Technology Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution safe harbor plan, which provides retirement benefits to qualified employees of the Paragon Technology Group, Inc. and NuVision System Management, Inc. (collectively, the Company) on a contributory basis effective January 1, 2004, and most recently amended March 23, 2021. Except for nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, and residents of Puerto Rico, all employees of the Company who have attained the age of 18 are eligible to participate in the Plan. Employees will become participants in the Plan on the first day of the month following the date they meet the participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Participants may voluntarily contribute up to 75% of their annual eligible compensation not to exceed annual IRS limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits set by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan document also includes an automatic deferral election that automatically contributes 3% of an employee's pretax compensation in the event he or she fails to decline participation. Unless the employee affirmatively elects otherwise, the automatic deferral percentage will increase by 1% annually until reaching 6%.

The Company will make safe harbor matching contributions in an amount equal to 100% of participant deferrals up to the first 1% of the participant's eligible compensation, and 50% of participant deferrals up to the next 5% of the participant's eligible compensation.

The Company may also make discretionary matching and nonelective contributions to the Plan. For the year ended December 31, 2024, the Company did not make any discretionary contributions to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company's contributions, as well as allocations of Plan earnings (losses) and administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual net earnings thereon. Vesting in Company safe harbor matching contributions, plus earnings thereon, is based on years of continuous service as follows:

In addition, upon reaching the Plan's normal retirement age of 65, death, or becoming permanently disabled while being employed by the Company, a participant will automatically become 100% vested in their entire account balance.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Participants or their beneficiaries are eligible for distributions upon the participant's retirement, termination, disability, or death. The Plan also allows for in-service withdrawals for hardships and participants who have reached the age of 59½. Distributions can be made in the form of lump sum or installment payments. Terminated, deceased, or disabled participants whose account balances do not exceed \$5,000 will be automatically distributed in the form of a lump sum. At all times, participants may withdraw in total or a portion of their rollover contributions.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Forfeitures**

Forfeitures resulting from termination of nonvested or partially vested participants may be used to reduce the Company's future contributions or Plan administrative expenses. Forfeitures of \$2,214 were used to pay Plan administrative expenses during the year ended December 31, 2024. Forfeitures of \$146,516 were used to reduce Company contributions during the year ended December 31, 2024. Forfeited nonvested accounts totaled \$174,279 and \$248,545 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFIED INVESTMENTS**

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;

inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 FAIR VALUE MEASUREMENT (CONTINUED)**

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* Self-directed brokerage accounts consist of cash, common stocks and preferred stocks. Cash is valued at a stable \$1.00 NAV, which is based on the fair value of the underlying investments. Common stock and preferred stock is valued at the closing price reported on the active market on which the individual securities were traded. Cash, common stock, and preferred stock are considered Level 1 investments.

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity, the trustee of the Plan as of December 31, 2024 and 2023. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 7 TAX STATUS**

The Plan adopted a non-standardized form of prototype plan sponsored by Fidelity. The prototype plan received a determination letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Paragon Technology Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution safe harbor plan, which provides retirement benefits to qualified employees of the Paragon Technology Group, Inc. and NuVision System Management, Inc. (collectively, the Company) on a contributory basis effective January 1, 2004, and most recently amended March 23, 2021. Except for nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, and residents of Puerto Rico, all employees of the Company who have attained the age of 18 are eligible to participate in the Plan. Employees will become participants in the Plan on the first day of the month following the date they meet the participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Participants may voluntarily contribute up to 75% of their annual eligible compensation not to exceed annual IRS limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits set by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan document also includes an automatic deferral election that automatically contributes 3% of an employee's pretax compensation in the event he or she fails to decline participation. Unless the employee affirmatively elects otherwise, the automatic deferral percentage will increase by 1% annually until reaching 6%.

The Company will make safe harbor matching contributions in an amount equal to 100% of participant deferrals up to the first 1% of the participant's eligible compensation, and 50% of participant deferrals up to the next 5% of the participant's eligible compensation.

The Company may also make discretionary matching and nonelective contributions to the Plan. For the year ended December 31, 2024, the Company did not make any discretionary contributions to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company's contributions, as well as allocations of Plan earnings (losses) and administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual net earnings thereon. Vesting in Company safe harbor matching contributions, plus earnings thereon, is based on years of continuous service as follows:

Vesting for all other Company contributions, plus earnings thereon, is based on years of continuous service as follows:

In addition, upon reaching the Plan's normal retirement age of 65, death, or becoming permanently disabled while being employed by the Company, a participant will automatically become 100% vested in their entire account balance.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Participants or their beneficiaries are eligible for distributions upon the participant's retirement, termination, disability, or death. The Plan also allows for in-service withdrawals for hardships and participants who have reached the age of 59½. Distributions can be made in the form of lump sum or installment payments. Terminated, deceased, or disabled participants whose account balances do not exceed \$5,000 will be automatically distributed in the form of a lump sum. At all times, participants may withdraw in total or a portion of their rollover contributions.

**Forfeitures**

Forfeitures resulting from termination of nonvested or partially vested participants may be used to reduce the Company's future contributions or Plan administrative expenses. Forfeitures of \$2,214 were used to pay Plan administrative expenses during the year ended December 31, 2024. Forfeitures of \$146,516 were used to reduce Company contributions during the year ended December 31, 2024. Forfeited nonvested accounts totaled \$174,279 and \$248,545 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFIED INVESTMENTS**

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;

inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* Self-directed brokerage accounts consist of cash, common stocks and preferred stocks. Cash is valued at a stable \$1.00 NAV, which is based on the fair value of the underlying investments. Common stock and preferred stock is valued at the closing price reported on the active market on which the individual securities were traded. Cash, common stock, and preferred stock are considered Level 1 investments.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity, the trustee of the Plan as of December 31, 2024 and 2023. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 7 TAX STATUS**

The Plan adopted a non-standardized form of prototype plan sponsored by Fidelity. The prototype plan received a determination letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
