**NOTE 1 PLAN DESCRIPTION**

The following description of the Schmidt Associates, Inc.'s 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to provide for the retirement of Schmidt Associates, Inc. (the "Company") employees. The Plan is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees are eligible to participate in the Plan the first day of the month following when they attain the age of twenty-one and have completed 60 days of consecutive service. The Plan includes an automatic enrollment provision for newly eligible participants. Participants who have not affirmatively elected to defer a percentage of salary upon becoming eligible will be deemed to have elected a 3% salary deferral election. The contributions will be invested in a target retirement plan based on the age of the employee. The participant has the option to make changes to the deferral percentage and investment allocation at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contribution, allocations of investment earnings and allocations of the administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant-directed.

Vesting

A participant is 100% vested in the value of his or her accumulated voluntary contributions, matching contributions, and rollover contributions at all times. A participant is considered fully vested in the Company's profit sharing contributions after five years.

Contributions

Participants may contribute to the Plan subject to limits imposed by Federal tax law. The Plan includes automatic enrollment for all newly eligible employees. The contributions made are participant driven and directed. The Company, at its discretion, may make a Matching, Qualified Matching, Profit Sharing, or top-heavy Contribution in an amount to be determined each year by the Employer.

Payment of Benefits

Upon termination of employment, death, disability or retirement, the participant may receive distributions as a lump sum, partial payments, or installment payments as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Forfeitures

Forfeitures are first used to reduce the Company's contributions. There were no forfeitures during the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023 forfeited nonvested account totals were \$1,335 and \$1,314, respectively.

Participant Loans (Notes Receivable From Participants)

Participant loans are permitted under the Plan. The maximum number of loans per participant is two with a minimum amount of \$1,000 per loan. Loans cannot exceed the lesser of \$50,000 or 50% of a participant's vested balance. All loans are to be repaid within five years (or ten years for loans used for a home purchase) with payments being made each pay period. The interest rate is determined at the time of the loan and is fixed at 1% over prime.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Concentration of Credit Risk

The Plan invests in mutual funds or stable value funds. Mutual funds consist of equity, fixed income, and cash equivalent investments. Mutual fund investments are not insured. Valuations of mutual funds with equity and fixed income securities are affected by market fluctuations in the underlying stocks and bonds in which the fund managers have invested.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. The Plan's interest in stable value funds is valued based on information reported by the investment advisor and the available financial statements of the fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year and the realized gain or loss on investments sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Reclassifications

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform with the presentation in the current year financial statement.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it has the right, by action of its directors, to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, amounts credited to participants' accounts will become fully vested and non-forfeitable.

**NOTE 4 PARTIES IN INTEREST**

There were no known prohibited transactions with known parties in interest as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in ERISA Sections 406 and 407(a) and Internal Revenue Code Section 4975(c).

Certain Plan investments are shares of mutual funds and units of stable value funds. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE 5 INCOME TAX STATUS**

The Company adopted a Volume Submitter Profit Sharing Plan, sponsored by Transamerica Retirement Solutions, LLC, with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020. The plan document has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

**NOTE 7 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Statement ASC 820, Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1**        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**        Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds* : Valued at the net asset value ("NAV") of share held by the Plan at year end.

*Stable value funds* : Valued based on the fair value of the underlying investments comprising the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 8 PLAN AMENDMENTS**

Effective February 1, 2024, the plan was amended with the following provisions:

After-tax Voluntary Contributions: Participants under the Plan may make voluntary contributions to the Plan on an after-tax basis.

In Plan Roth Conversions: The Plan allows an In-Plan Roth conversion feature. A portion of participant funds that are already in one or more tax-deferred accounts under the Plan can be converted from a pre-tax basis to a Roth tax basis. For tax purposes, such recharacterized amounts will be treated by the Plan as if such funds had been Roth deferrals.

In-plan Roth Rollover: If a participant is eligible for a distribution from an account and currently an employee, they may elect to roll over all or a portion of the distribution to a designated Roth contribution account in the Plan (referred to as an In-Plan Roth Rollover).

Effective June 28, 2024, the plan was amended with the following provisions:
