Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Aakron Rule Corp. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following is a brief description of the Aakron Rule Corp. 401(k) Profit Sharing Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan continues to be for the exclusive benefit of the employees of the following participating companies: Aakron Rule Corp., Wagner Pencil Company, Inc. and Cato Holdings, LLC (the “Plan Sponsors” or the “Company”). The Plan is a defined contribution plan covering all full-time employees of the Plan Sponsors who and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Effective January 1, 2024, the Plan was restated to allow eligible participants, upon achieving three months of service, to make both pre-tax and Roth contributions to the Plan up to 100% of eligible compensation, as defined in the Plan, not to exceed statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Company may make discretionary contributions to the Plan in an amount which the Plan’s Sponsors’ Boards of Directors deems advisable, subject to certain limitations. To be eligible for the discretionary contribution a participant must have one year of service (1,000 hours) and be employed on the last day of the Plan year. Employer contributions totaled \$349,842 and \$318,103 for the years ended December 31, 2024 and 2023, respectively. The Company may also make discretionary matching contributions. No matching contributions were made for the years ended December 31, 2024 or 2023.

Vesting – Participants are immediately vested in their voluntary contributions, rollovers and actual earnings thereon. Vesting in Company discretionary contributions and earnings thereon are 100% vested after three years of credited service.

Forfeitures – Forfeitures may be used to pay Plan administrative expenses or to be allocated to participants as additional contributions. There were no forfeitures allocated during the year ended December 31, 2024. Forfeitures of \$1,097 were available to be allocated to participant accounts at December 31, 2024. There were no forfeitures available as of December 31, 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and the allocation of the Company’s discretionary contribution plus the forfeitures of terminated participants’ non-vested accounts based on the participant’s proportionate share of the total compensation paid during the year to all employed participants in the Plan on the last day of the Plan year end. Plan earnings and administrative expenses are allocated based on each participant’s proportionate share of the total Plan assets as of the beginning of the Plan year. Plan earnings are allocated to the participants’ accounts based on the performance of the participants’ investment selections.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsors have the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall become 100% vested and entitled to the amount of their account at the date of such termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Payment of Benefits – The Plan allows a participant on termination of service due to death, disability, or retirement to withdraw all of their account balance in a lump sum distribution. The Plan also allows a participant, after attaining the normal retirement age, to withdraw all or any part of their participant account balance. The Plan was amended and restated January 1, 2023 to permit in-service distributions upon reaching the age of 59 1/2.

Administrative Expenses – The costs of administering the Plan are borne by both the Plan and Plan Sponsors.

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities, which are subject to be reported at fair value based on accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 is to be used only where neither Level 1 nor Level 2 inputs are available.

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value

Common collective trusts: These funds primarily hold guaranteed and other similar investment contracts that are fully-benefit responsive. The funds are valued based on the NAV of the shares held by the Plan at year-end using NAV contract value. These funds generally have no redemption restrictions or unfunded capital commitments.

Included in common collective trust accounts is the State Street U.S. Inflation Protected Bond Index Securities Lending Series Fund Class II and State Street REIT Index Securities Lending Series Fund Class II. The objective of State Street U.S. Inflation Protected Bond Index Securities Lending Series Fund Class II is to seek an investment return that follows the performance of the Bloomberg Barclays U.S. Treasury Inflation Protected Securities over the long-term. The objective of State Street REIT Index Securities Lending Series Fund Class II is to see an investment return that follows the performance of the Dow Jones U.S. Select REIT IndexSM over the long-term.

Mutual funds: Valued based on the quoted market price available on an active market, which represents the NAV of the shares held by the Plan.

Pooled separate accounts: These accounts are valued at the NAV of units held by the Plan at year-end. The pooled separate accounts have been measured at fair value using the NAV practical expedient as of December 31, 2024, and generally have no redemption restrictions or unfunded capital commitments.

Money market fund: Valued at the daily closing price as reported by the funds. The money market funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish a daily net asset value (“NAV”) and to transact at that price. The money market funds are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties – The Plan’s assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

Subsequent Events – The Plan has evaluated the effects of all subsequent events through September 22, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan’s assets that are measured at fair value as of December 31:

4. PARTY-IN-INTEREST TRANSACTIONS

Empower Life & Annuity Insurance Co. is the recordkeeper of the Plan, and therefore qualifies as a party-in-interest. Fees paid during the year for other services rendered by parties-in-interest were based on customary and reasonable rates for such services.

5. INCOME TAX STATUS

The Plan Sponsor has adopted the Empower Retirement, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the “Pre-Approved Plan”). The Pre-Approved Plan received an Opinion Letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.

6. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the unaudited information regarding the Plan as of and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule. The information was prepared and certified by Empower Trust Company, LLC (“Empower”), as trustee of the Plan, and furnished to the Plan Sponsor.
