Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Indemnity Company Retirement and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National Indemnity Company Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

1. **Description of the Plan**

The following description of the National Indemnity Company Employee Retirement and Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General — The Plan, established January 1, 1968, as amended and restated, is a defined contribution retirement and savings plan maintained for participating entities and their eligible employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions — Each year, contributions up to 5% of compensation, as defined by the Plan, may be made by active participants, and such contributions are 100% matched by the participating employers. Additional contributions, not subject to employer matching contributions may be made by participants up to 65% of compensation, however, the maximum annual contribution by any participant shall not exceed the amount allowable under provisions of the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualifying defined benefit or defined contribution plans.

Participant Accounts — Individual accounts are maintained for each Plan participant. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Each participant’s account is credited with the participant’s contribution, and allocations of (a) the employer’s contribution and (b) the Plan earnings, and charged with withdrawals and an allocation of the Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Plan participants may direct their contributions and employer matching contributions in any proportion within the twenty-one available investment funds.

Vesting — Employer contributions and earnings (losses) thereon to a participant’s account begin vesting after two years of service and are fully vested after six years of service or upon death, permanent disability or retirement at or after the normal retirement age, which is age 65. Non-vested employer contributions that are forfeited by participants are used to reduce subsequent employer contributions to the Plan. Employee contributions and earnings (losses) thereon are fully vested at all times.

Notes receivable from participants — Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is set at 1% above the current prime lending rate of Principal Trust Company. Principal and interest are paid ratably through payroll deduction. Participants may not exceed two loans outstanding at any time.

Participating Entities — Participating employers as of December 31, 2024 and 2023 were: National Indemnity Company, Berkshire Hathaway Direct Insurance Company, Berkshire Hathaway Homestate Insurance Company, Northern States Agency, Inc., Berkshire Hathaway Inc., Resolute Management Inc., Ringwalt & Liesche Co., National Liability & Fire Insurance Company, Oak River Insurance Company, Blue Chip Stamps, Inc., Affordable Housing Partners, Inc and Farnam Management Services, LLC.

Payment of Benefits — On termination of service due to death, disability or retirement, benefit payments shall be made in lump sum or installments over a period of not more than the participant's life expectancy (or participant's and participant's beneficiary's life expectancies). Participants may withdraw their Plan contributions, vested employer contributions, earnings and rollover funds when their employment ends. In-service withdrawals may be made subject to Plan requirements.

Plan Termination — Although the National Indemnity Company Board of Directors has not indicated its intention to terminate the Plan, it may do so at any time. In the event of a full or partial termination of the Plan or upon a complete discontinuance of contributions to the Plan, all employer contributed amounts credited to the accounts of participants shall be fully vested and non-forfeitable and the Plan assets shall be distributed in accordance with provisions of the Plan and ERISA.

Forfeited Accounts — At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$60,547 and \$172,179, respectively. These accounts are used to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$1,046,904 and \$790,863 respectively, from forfeited non-vested accounts.

2. **Summary of Significant Accounting Policies**

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates — The Plan Administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the U.S.A. Estimates and assumptions affect the reported amounts of assets, liabilities, net asset additions and deductions, and related disclosures. The most significant estimate in the accompanying statements is the valuation of investments at fair value by the Plan custodian. Due to the inherent uncertainties in this process, it is likely that actual results, including the realization of fair value of the investments, will vary from the estimates.

Risks and Uncertainties — The Plan invests in investment securities, which are exposed to interest rate, market, and credit risks. It is therefore, at least reasonably possible that changes in fair value could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value, which is determined by quoted market prices. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on the trade-date. Dividend income is recorded on the ex-dividend date.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as benefit payments on the basis of the terms of the Plan agreement.

Payment of Benefits — Benefits are recorded when paid.

Plan Expenses — All expenses of the Plan are paid by the participating entities of the Plan, except some investment fees which are paid by the plan. Revenue sharing fees received are reported as a reduction to administrative expenses on the statement of changes in net assets available for benefits and used to reduce plan expenses.

Subsequent Period — Management evaluated transactions and events occurring subsequent to December 31, 2024, and through September 9, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Codification Section 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1--Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2--Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3--Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and collective funds – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Plan Administration**

The Plan provides for the appointment by the participating entities of an Administrative Committee, which is responsible for the management, operation and administration of the Plan.

6. **Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's counsel believe the Plan is designed, and is currently being operated in compliance with, the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
