NOTE 1. DESCRIPTION OF PLAN

The following description of the Physicians' Medical Center, P.C. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) profit-sharing Plan, originally adopted on January 1, 1975, and most recently amended and restated on January 1, 2022. The Plan is a defined contribution plan covering all employees of Physicians' Medical Center (the "Plan Sponsor") who have completed one hour of service in their first sixty days and attained age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees may enter the Plan as participants on the first day of the month following the date they meet the eligibility requirements. Eligible participants are automatically enrolled in the Plan with six percent withheld from their wages as 401(k) deferrals, unless the participants opt out or elect a different deferral amount.

Contributions – Participants may elect to contribute up to one hundred percent of pretax annual compensation, as defined in the Plan, and/or a minimum of one percent for Roth contributions, combined not to exceed statutory limits. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified Plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. Notwithstanding the catch-up provisions, the statutory limit on each participant's pretax and after-tax contributions for 2024 was \$23,000.

Annually, the Plan Sponsor may make any of the following three discretionary contributions: 1) a four percent safe harbor contribution, 2) a discretionary matching contribution and/or 3) a discretionary profit-sharing contribution. Participants must complete one year of service (1,000 hours) and be employed on the last day of the year to be eligible for the discretionary employer contributions. Participants are eligible for the safe harbor contributions once they have met the eligibility requirements for salary deferrals. Participants are not required to be employed on the last day of the year to be eligible for the safe harbor contribution.

Investment Elections – Participants may choose any combination of investments as presented in Plan documents. The accounts of participants who do not choose among these options are automatically invested in the Target Maturity fund based on their year of expected retirement. Participants can change investment combinations as often as permitted under the particular investment vehicle.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts – Each participant’s account is credited with their contributions and allocations of (a) the Plan Sponsor’s contributions, (b) investment earnings (losses), (c) and charged with an allocation of administrative expenses when applicable. Allocations are based on participant earnings or account balances, as defined by Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and any special contributions, such as rollover contributions, that are made to the Plan, and actual earnings thereon. Participants shall also become 100 percent vested upon attainment of normal retirement age, death, or permanent disablement. Vesting in employer discretionary matching and profit-sharing contributions is based on years of credited service. After two, three, four, five, and six years of credited service, participants will become 20 percent, 40 percent, 60 percent, 80 percent, and 100 percent vested, respectively, in the employer discretionary match and profit share. However, participants will become 100 percent vested after two years of credited service in the Qualified Automatic Contribution Arrangement safe harbor profit sharing contributions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll it over to another qualified Plan. For balances over \$7,000, the participant may elect to leave the money in the Plan. For balances less than \$7,000 where participants do not directly transfer payment to an IRA or another Plan, the account will be transferred to an IRA in the participant’s name.

Hardship Distributions – The Plan contains a provision for hardship distributions in the event of a qualified financial hardship, which constitutes an immediate and heavy need. However, the participant must have exhausted all other means of satisfying the need before a distribution will be approved. Examples of qualified hardships include medical expenses, purchase of a principal residence, preventing an eviction from a participant’s primary residence, and other related expenses.

Forfeited Accounts – The non-vested portion of a participant’s account is forfeited when certain terminations described in the Plan document occur. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$715 and \$38,821, respectively. Forfeitures may be used to pay administrative expenses of the Plan with any remaining amounts used to reduce employer contributions. In 2024, \$41,403 was used to reduce employer contributions and \$0 was used to pay Plan expenses.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or fifty percent of their vested account balance. A participant is allowed only one loan outstanding at any time. Loan transactions are treated as participant-directed investments. The loans are secured by the remaining balance in the participant's account and bear interest at the Prime Rate plus two percent. Principal and interest are paid ratably through payroll deductions for a period that generally does not exceed five years.

SECURE Act 2.0 – On March 5, 2024, the Plan Sponsor signed a Request for Change in Plan Operation to comply with the mandatory sections of the SECURE Act 2.0. The Plan Sponsor will incorporate the changes into a plan amendment during their next restatement cycle which is scheduled for plan year 2026.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion on fair value measurement. The investment contract held in the general account is reported at contract value. Fair value and contract value for the investments of the Plan are certified by the custodian and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of Benefits – Benefits are recorded when paid. As of December 31, 2024, there were no distributions requested by participants in the ordinary course of Plan operations, but not yet processed.

Administrative Expenses – Certain administrative activities are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses consisting of insurance company fees, administration fees, and other related professional services are paid by the Plan Sponsor. If other expenses are specifically incurred by, or attributable to, a specific participant, his or her account balance will be reduced to reflect the participant-specific fee.

Date of Management's Review – Subsequent events were evaluated through September 3, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

The Plan includes one Guaranteed Investment Contract (GIC), a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and investment management fees. The GIC issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. Since the GIC is fully benefit-responsive, contract value is the relevant measurement attributed to the portion of the net assets available for benefits attributable to the GIC. As reported to the Plan by Voya, contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct transfers between fund options, while terminated participants may direct a withdrawal of all or a portion of their investments at contract value.

There are no reserves against contract value for the credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was approximately 2.00% during the years ending December 31, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.25% for 2024 and 2023. Such interest rates are reviewed on a monthly basis. VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risk, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There are no redemption restrictions for this fund. If the Plan initiates a full redemption of the trust, the issuer reserves the right to require 30 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Transfers from the GIC to other investments may be limited to a percentage of the holdings as of January 1, of that Plan year. The percentage will never be less than 10 percent.

NOTE 5. INFORMATION CERTIFIED BY CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024; and related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6. PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. Fees paid during the year to third-party administrators or trustees for services rendered by parties-in-interest were based on customary and reasonable rates for such services and were paid by the Plan Sponsor. Also, certain Plan investments are shares of funds managed by Voya, the trustee. The Plan issues loans to participants, which are secured by balances in the participants' accounts. These transactions qualify as exempt parties-in-interest transactions.

Plan investments in shares of registered investment companies and investment contracts are managed by Voya Retirement Insurance and Annuity Company, the custodian of the Plan. These transactions qualify as exempt parties-in-interest transactions.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be fully vested in the amounts credited to their accounts.

NOTE 8. TAX STATUS

The Plan is an IRS pre-approved defined contribution plan. The Plan Sponsor adopted the Plan from pre-approved plan Provider Premier Retirement Services, Inc., and as designed, it complies with applicable requirements for Cycle 3 Pre-Approved Plans under Rev. Proc. 2017-41. The Plan has been amended since adoption. However, the plan administrator, the pre-approved plan provider, and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
