Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Boundless Enterprises, LLC 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. Plan Description

The following brief description of the Boundless Enterprises, LLC 401(K) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Boundless Enterprises, LLC and its wholly-owned subsidiaries, Boundless Operations, LLC, Harvest Roasting, LLC and Scooter's Coffee, LLC, as well as Don Eckles, LLC and Graeve Enterprises, LLC (collectively, the Company). Effective January 1, 2024, employees of Graeve Enterprises, LLC are no longer included in the Plan.

Employees are eligible to make pre-tax and designated after-tax Roth salary deferral contributions and receive safe harbor matching contributions, discretionary matching contributions, and discretionary profit-sharing contributions after attaining age 21 and completing two months of service (one month of service, prior to January 1, 2024). Part-time, temporary or seasonal employees whose regularly scheduled annual service is less than 1,000 hours are not eligible to participate in the Plan. If a part-time, temporary or seasonal employee completes 1,000 hours of service within a plan year, then such employee will no longer be part of the excluded class and shall become eligible to participate in the Plan after attaining age 21. Effective January 1, 2024, part-time, temporary and seasonal employees are eligible to participate in the Plan after attaining age 21 and completing two months of service. Eligible employees became participants on the first day of the month coinciding with or next following the date requirements were satisfied. Participants are eligible for discretionary profit-sharing contributions if they are employed on the last day of the Plan year.

Contributions

Participants may make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 100% of their eligible annual compensation as defined by the Plan, up to the maximum dollar limits allowable by law. Employees are automatically enrolled in the Plan with an initial pre-tax salary deferral of 5% (4% effective January 1, 2025), which is increased by one percentage point at the beginning of each Plan year, until it reaches a total of 10% of their eligible compensation. Each pay period (at any time, prior to January 1, 2024), a participant may elect not to contribute or may change their deferral rate as allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan is a “Safe Harbor 401(k) Plan” whereby the Company is required to make safe harbor matching contributions equal to 100% of each participant’s elective deferral, up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation (100% of each participant’s elective deferral up to 4% of eligible compensation, effective January 1, 2025). The Company may make discretionary matching contributions and discretionary profit-sharing contributions (none in 2024 and 2023). Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of a) the Company’s safe harbor matching contributions and discretionary matching contributions, b) the Company’s discretionary profit-sharing contributions and c) Plan earnings and losses. The Company’s safe harbor matching contributions and discretionary matching contributions are allocated among participants based upon each participant’s elected salary deferral. The Company’s discretionary profit-sharing contributions are allocated among participants based upon the grouping method, including eligible compensation, as defined in the Plan document and determined by the Company. Prior to January 1, 2024, the Company’s discretionary profit-sharing contributions were allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Investments are maintained in individual member accounts managed by Principal Trust Company and Principal Life Insurance Company (collectively, Principal).

Vesting

The Company’s safe harbor matching contributions credited to participants’ accounts are vested based on a two-year cliff vesting schedule. The Company’s discretionary matching and profit-sharing contributions credited to participant accounts are vested based on years of continuous service and a two-year cliff vesting schedule. Prior to January 1, 2024, participants were immediately vested in their contributions and the Company’s discretionary matching and profit-sharing contributions plus actual earnings thereon.

Notes Receivable from Participants

Effective January 1, 2025, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates. The terms of the notes receivable are limited to five years. Principal and interest are paid through payroll deductions. Prior to January 1, 2025, no loans were allowed in the Plan.

Payment of Benefits

Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive lump sum, partial or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect a payout option. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan also allows for in-service distributions for participants who have reached the age of 59 ½. Participants may also receive hardship distributions, as defined by the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before termination, normal retirement, disability, or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce the Company's contributions or pay Plan expenses. Effective January 1, 2024, the forfeited portion of any participant's account may also be re-allocated to remaining participants. As of December 31, 2024 and 2023, forfeited, non-vested amounts totaled \$24,239 and \$225, respectively. During 2024, forfeitures of \$201,436 and \$24,590 were used to reduce the Company's contributions and to pay Plan expenses, respectively. During 2023, forfeitures of \$98,253 and \$76,248 were used to reduce the Company's contributions and to pay Plan expenses, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 4 for further discussion on fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investments contracts through a guaranteed investment account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Effective January 1, 2025, the Plan was amended to allow participants to obtain loans from their individual account balances. Notes receivable from participants will be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes will be reclassified as distributions based upon the terms of the Plan document.

Other

Certain Plan expenses are paid by the Company and are excluded from these financial statements. Investment management and record-keeping expenses are paid by the Plan are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participant's accounts are included in administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 25, 2025. See Notes 1 and 2 for descriptions of subsequent events.

3. Information Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, the custodians of the Plan, except for comparing such information certified by the custodians to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective Trusts: Valued at the net asset value (NAV) based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan's assessment that these trusts meet those requirements since the participants have the ability to redeem these trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. Funds held by the Plan are deemed to be actively traded and are properly categorized as a Level 1 fair value investment.

Pooled Separate Accounts: Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan’s assessment that these accounts meet those requirements since the participants have the ability to redeem these accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has entered into an investment contract with Principal. Principal maintains the contributions in pooled separate accounts, collective trusts, and a guaranteed investment account. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal.

The pooled separate accounts and collective trusts, as reported to the Plan by Principal, are included in the financial statements at fair value, which represents contributions made under the contracts, plus earnings, less withdrawals and administrative expenses.

As the guaranteed investment account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

8. Related-Party Transactions

Certain assets of the Plan are held and managed by Principal, the custodian of the Plan, therefore, these transactions qualify as party-in interest.
