## **Independent Auditors' Report**

To the IMCO General Construction Davis-Bacon 401(k) Plan and Participants

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

I have performed audits of the accompanying financial statements of IMCO General Construction Davis-Bacon 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## IMCO General Construction Davis-Bacon 401(k) Plan Notes to the Financial Statements

### A. Description of Plan

The following description of the IMCO General Construction (“the Company”) Davis-Bacon 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions:

1. *General.* The Plan has two components to it; (1) a defined contribution plan covering substantially all full-time employees of the Company, who have two months of service and are age 18 or older, and (2) a prevailing wage Company contribution formula not subject to any minimum age or service requirements, pursuant to the Davis-Bacon Act or any state or municipal “prevailing wage” law or ordinance. The Plan is subject to the provisions of ERISA. The Board of Trustees is responsible for oversight of the Plan.
2. *Contributions.* Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Prevailing wage contributions are at an hourly rate prescribed for fringe benefits pursuant to respective publicly funded contracts entered into by the Company. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may also make matching and profit-sharing contributions at the discretion of the Company’s board of directors. Prevailing wage contributions are at an hourly rate prescribed for fringe benefits pursuant to each Federal, State, County, or Publicly funded contract entered into by the Company. Contributions are subject to certain Internal Revenue Service (IRS) limitations.
3. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution and Company prevailing wage contributions, as well as allocations of the Company’s discretionary matching and profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. *Vesting.* Participants are vested immediately in their contributions and Company prevailing wage contributions, plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.
5. *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account and bear interest at rates of 4.25% to 9.5% which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through monthly payments.
6. *Payment of Benefits.* On termination of service due to death, disability, or retirement, a participant receives a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Hardship withdrawals and in-service withdrawals are permitted by the Plan and are available from all participant contributions that are 100% vested.
7. *Forfeited Accounts.* On December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,751 and \$6,856, respectively. These accounts can be used to pay Plan expenses or reduce future Company contributions to the Plan. Also, in 2024 \$3,784 of Plan expenses were paid from forfeited nonvested accounts.

## IMCO General Construction Davis-Bacon 401(k) Plan Notes to the Financial Statements

### **B. Summary of Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Contributions*

Contributions from participants are recorded as they are withheld from the participant's wages.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### *Subsequent Events*

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

### C. Certified Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Standard Insurance Company (Standard) the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of the investment information and the notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Pooled separate accounts:* The Plan's interest in the pooled separate accounts is valued at the NAV practical expedient of the underlying investments. The practical expedient would not be used if it is determined to be probable that the funds would sell their investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

### **E. Guaranteed Investment Contract with Insurance Company**

The Guaranteed Portfolio Fund represents a benefit-responsive guaranteed investment contract with Minnesota Life. Contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and are reviewed quarterly for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract.. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### **F. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of pooled separate accounts managed by Minnesota Life. Minnesota Life is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan made direct payments to the third-party administrator of \$23,724 and \$31,742 to the Plan's investment advisors which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

The Company is a party in interest to the Plan. However, there are no transactions with the Company other than the payment of certain administrative expenses to the Plan. These transactions qualify as exempt party in interest transactions.

### **G. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### **H. Tax Status**

Effective January 1, 2022, the Plan adopted Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. CCH Incorporated, the sponsor of this prototype plan, obtained its latest Internal Revenue Service (IRS) opinion letter on June 30, 2021, in which the IRS stated that the form of the Plan, as then designed, was following the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **I. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
