Note 1. Description of Plan

The following description of the Monroe Tractor & Implement Co., Inc. 401 (k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401 (k) profit sharing plan covering the employees of Monroe Tractor & Implement Co., Inc. Employees are eligible to participate in the employer matching and profit sharing features of the Plan after completion of one year of service and must be employed at the end of the Plan year. There is no minimum service requirement for the employee deferral portion of the Plan. Length of service is based on whole years of service. There is no minimum or maximum age for eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may elect to have a specified portion (not to exceed 99%) of his/her compensation for a plan year allocated to his/her account up to a maximum of \$23,000 per year. Eligible participants may also defer additional catch-up amounts as permitted by law. The plan includes an auto - enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. The initial deferral default rate is 4% and contributions are automatically invested in a designated balanced fund until changed by the participant. The employer will make a matching contribution for amounts deferred by participants. Matching contributions for 2024 and 2023 will equal 50% of the salary reduction up to 6% of compensation, resulting in a maximum contribution of 3% of compensation. The Company may also make annual profit sharing contributions at its own discretion. Participants direct the investment of the contributions and the investment options may be changed daily.

Participant Accounts

Salary deferral contributions and any matching contributions are allocated to the respective employee's accounts. Employer profit sharing contributions are allocated to each participant based on the ratio by which the participants' compensation bears to the compensation of all eligible participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is fully vested once they have completed five years of service, as defined by the Plan. If participants die or become disabled before retirement, the entire value of the participant's account becomes vested and non-forfeitable. Participants have the right to designate a beneficiary to receive their benefits should they die.

Note 1. Description of Plan (continued)

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the participant's vested account balances and bear interest at prevailing market rates (7.75%). Loan terms range up to 5 years or up to 10 years if the loan is used for the purchase of a principal residence. Effective March 15, 2022 per a plan amendment, no new participant loans are allowed.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account or annual, monthly or quarterly installments, or by a qualified joint and survivor annuity option. The Plan also allows for in-service distributions if certain eligibility requirements are met.

Forfeitures

Forfeitures for terminated non-vested participant's accounts attributable to employer profit sharing contributions, employer-matching contributions and earnings there from will be used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Participant Loans Receivable

Participant loans are stated at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan recordkeeping and trustee fees are paid by the Plan and charged to participant's accounts. Investment expenses are allocated and deducted from participant accounts and shown separately from investment earnings. All other administrative expenses are paid by the Plan sponsor which is a party-in-interest. These expenses are not reflected in the accompanying financial statements and are considered exempt party-in-interest transactions.

Note 4. Fair Value Measurements

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority, Level 1, to measurements using unadjusted quoted prices in active markets for identical assets or liabilities measurements. Level 2 measurements are quoted prices in markets that are not active, or inputs that are observable directly or indirectly, for substantially the full term of the asset or liability. Level 3 measurements, the lowest priority, utilizes inputs which are unobservable and significant to the fair value measurement.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Tax Status

The Plan has adopted a prototype document for a non-standardized 401(k) Profit Sharing Plan written by Fidelity Management Trust Company. An Opinion letter dated June 30, 2020 was obtained for the nonstandardized prototype in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the advisory opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan is subject to routine audits by taxing authorities, however there are no audits for any tax periods in progress.

Note 7. Terminated Vested Accounts

At December 31, 2024 and 2023 there is \$0 allocated to participant accounts who have elected to withdraw from the Plan, but have not been paid.

Note 8. Forfeited Accounts

As of December 31, 2024 and 2023 forfeited nonvested accounts amounted to \$32,247 and \$6,141, respectively. During the plan years ended December 31, 2024 and 2023 employer contributions were reduced by \$5,929 and \$4,726, respectively from forfeited nonvested accounts.

Note 10. Risks and Uncertainties

The Plan invests in registered investment companies and money market funds. These investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11. Related Party Transactions

The Plan investments include shares of funds managed by affiliates of Fidelity Management Trust Company (FMTC). Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions and administrative expenses paid to FMTC qualify as exempt party-in-interest transactions. Expenses paid to Fidelity Management Trust Company were \$112,868 and \$92,839 for the years ended December 31, 2024 and 2023, respectively. Loans receivable from plan participants and the related interest income are also considered exempt party-in-interest transactions.
