SCHEDULE SB, PART V – SUMMARY OF PLAN PROVISIONS

1. **Eligibility:** All employees are eligible on the January 1 or July 1 following the completion of one Year of Service and attainment of age 21.
2. **Normal Retirement Date:** The first day of the month following the attainment of age 65 or the fifth anniversary of Plan Participation, if later.
3. **Compensation:** Gross compensation for the year ending December 31.
4. **Normal Retirement Benefit:** The benefit that can be provided by the actuarial accumulation of contributions each year, which shall be determined as follows:
 - i. For Clark Huang, the Theoretical Contribution shall be equal to \$95,000.
 - ii. For all other Participants, the Theoretical Contribution shall be equal to 3.00% of Compensation.
5. **Accrued Benefit:** Same as Normal Retirement Benefit.
6. **Interest Crediting Rate:** 4.00%
7. **Standard Form of Retirement Benefit:** A single life annuity which is the actuarial equivalent of the value of the participant's accumulated contributions. If the Participant is married, the benefit must be converted to an actuarially equivalent Joint & Survivor Annuity, unless elected otherwise with spousal consent.
8. **Early Retirement Benefit:** None
9. **Disability Benefit:** Upon retirement due to Total and Permanent Disability, the Actuarial Equivalent of Accrued Benefit is payable.
10. **Death Benefits:** Upon death prior to retirement, actuarial present value of Accrued Benefit is payable (in the form of a Pre Retirement Survivor Annuity unless elected otherwise with Spousal Consent).
11. **Termination of Employment:** Upon termination of employment prior to retirement, death, or disability, the vested Accrued Benefit is payable.
12. **Vesting:** Vested in the accrued benefit based on years of service. 0% for less than 3 years increasing to 100% on or after 3 years. A year of vesting service is credited for each Plan Year in which an employee completes at least 1,000 hours of service. Years prior to the participant attaining age 18 are excluded.
