In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hospice of East Texas Safe Harbor 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Hospice of East Texas Safe Harbor 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF PLAN**

**GENERAL**

The following description of the Hospice of East Texas Safe Harbor 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of Hospice of East Texas, a controlled group, referred to herein as, Hospice of East Texas Foundation and Texas Palliative Care, who have a minimum of twelve months of service and are age twenty-one or older. The Plan is subject to the provisions of ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Hospice of East Texas (“The Company”) is the Plan Sponsor.

**CONTRIBUTIONS**

Contributions to the Plan are made by the participants and the Company. Employees of the Company may enter the Plan on the first day of the plan year or the first day of the seventh month of the Plan year coinciding with or next following the date after eligibility requirements are met. A participant may elect to defer a percentage of his or her pretax compensation, as defined by the plan, subject to certain maximum limitations imposed by the Internal Revenue Code (“IRC”), section 401(k). Participants that reach age fifty before the close of the Plan year may make catch-up contributions. Participant contributions are made through regular payroll deductions. In order to maintain safe harbor status, the Company makes basic matching contributions equal to 100% of each participant’s salary deferrals that do not exceed 3% of the participant’s compensation, plus 50% of salary deferrals between 3% and 5% of participant compensation. Participants are fully vested in this contribution referred to as the basic matching contribution.

In addition to the basic matching contribution, the Company may contribute a discretionary matching contribution which is contributed at a uniform percentage of each participant’s salary determined annually. The Company may also contribute to the Plan discretionary profit-sharing contributions. Discretionary employer profit sharing contributions, if any, will be allocated to all eligible participants based upon the percentage of each participant’s eligible compensation to total eligible compensation or as a uniform dollar amount. The Company did not elect to make a discretionary matching or profit-sharing contribution for the year ended December 31, 2024.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, basic matching contribution, additional employer matching contribution and employer profit-sharing contribution, as well as allocated earnings. The employer's profit-sharing contribution, if any, is allocated to all participants who are employed during any part of the Plan year based upon eligible participant compensation. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options provided by Mid Atlantic Trust Company (“Mid Atlantic”), the Custodian of the Plan. Participants may modify investment elections or transfer existing account balances on a daily basis.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by local commercial banks for similar loans. Principal and interest are paid ratably through bi-weekly payroll deductions.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**VESTING**

Participants are immediately vested in their voluntary contributions, rollover contributions and basic matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. The vesting percentages currently in effect are as follows:

Full vesting also occurs at retirement, disability, death, or plan termination.

**PAYMENT OF BENEFITS**

The vested portion of the participant's benefits may be distributed to the participant or his beneficiary in the form of a single lump-sum payment, or as a direct rollover to an Individual Retirement Account. Vested balances less than \$1,000 at termination of employment are paid as a lump sum.

**FORFEITED ACCOUNTS**

Forfeitures may be used to pay any administrative expenses of the Plan, reduce employer contributions, and may also be reallocated to participants based upon compensation. For the plan year ended December 31, 2024, the plan received \$87 in new forfeitures and earnings. At December 31, 2024 and 2023, the Plan had unallocated forfeited accounts totaling \$1,395 and \$1,308, respectively. These forfeitures are held in investments on the statement of net assets available for benefits.

**PLAN ADMINISTRATOR**

The Board of Trustees and Management appoints the Plan Administrator. The Plan Administrator is an employee of the Plan Sponsor. Certain administrative duties, such as compliance testing, were performed by the custodian of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted in the United States of America ("GAAP").

**ESTIMATES**

The preparation of financial statements in accordance with accounting principles GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of the contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a settlement-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the modified cash basis. Dividends are recorded on the pay date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participant loans are classified as notes receivable and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses is considered necessary to record. If a participant fails to comply with the terms of a loan and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment, a deemed distribution, or a combination of the two.

**PAYMENT OF BENEFITS**

Benefit payments are recorded when paid.

**EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at the per unit price as quoted by the financial institution.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023, respectively:

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain investments of the Plan are managed by Mid Atlantic. Professional fees related to custodial services for the Plan’s assets paid by the Plan to Mid Atlantic totaled \$35,547 for the year ended December 31, 2024. Mid Atlantic is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan with respect to either a portion or all of the participants by executing a written instrument. In the event of Plan termination, participants will become 100% vested in their employer contribution accounts.

**NOTE 6 - TAX STATUS**

The Company has adopted a prototype plan which received a favorable tax determination letter from the Internal Revenue Service (“IRS”) that it qualifies under Section 401(a) of the IRC and is, therefore, not subject to tax under present law. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
