Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 – Description of the Plan

The following description of the Foundant Technologies 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan, which went into effect January 1, 2019, that is generally available to all employees of Foundant Technologies (the "Company", "Employer", "Plan Sponsor," or "Plan Administrator"). The Plan excludes union employees; nonresident aliens; and leased employees. Employees working a full time equivalent become eligible as of their date of hire, otherwise an employee must be credited with at least six consecutive months of employment in which they are credited with at least 83 1/3 hours of service per month to become eligible. Employees may enter the Plan on the same date they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- Salary Deferral Contributions – Participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after-tax compensation and designate it as a Roth deferral contribution. A participant's total salary deferral contributions cannot exceed \$23,000 (\$30,500 if age 50 or over) in calendar year 2024.
- Safe Harbor Employer Matching Contributions – The Company makes a safe harbor Employer matching contribution equal to 100% of each eligible participant's salary deferral contributions that do not exceed 4% of each eligible participant's compensation.
- Discretionary Employer Nonelective Contributions – The Company may make a discretionary nonelective contribution to eligible participants employed on the last day of the Plan year. Such contribution is allocated in the proportion that each participant's compensations bears to the compensation of all participants. During 2024, the Employer did not make a discretionary Employer nonelective contribution.
- Rollover Contributions – Certain amounts distributed to eligible participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation in calendar year 2024.

Investment Options. Participants may currently direct their investments into various mutual funds, a common collective trust, and an investment contract with insurance company.

Participant Accounts. Each participant's account is credited with the participant's contributions (salary deferrals and rollovers, if any) and an allocation of (a) the Employer's contributions (safe harbor matching and discretionary nonelective, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their salary deferral contributions, rollover contributions, and safe harbor Employer matching contributions and related earnings thereon. With certain exceptions, discretionary Employer nonelective contributions are subject to a one year vesting schedule, whereas participants become 100% vested in these contributions after completing one year of service. Additionally, employed participants become 100% vested in their accounts upon attainment of normal retirement age, death, disability, and termination or partial termination of the Plan.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum or installments equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request in-service withdrawals upon attainment of age 59½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined in the Plan

Forfeitures and Unallocated Asset Accounts. When certain terminations of Plan participation occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan, to restore previously forfeited accounts, or used to reduce Employer contributions. The Plan also maintains an unallocated account. During 2024, the unallocated asset accounts received \$32,766 of revenue credits, \$32,789 of which was used to pay Plan administrative expenses. As of December 31, 2024 and 2023, the balance in the forfeitures and unallocated asset account were \$618 and \$594, respectively.

Note 2 – Summary of Significant Accounting Policies

Use of Estimates and Basis of Accounting. The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value, except for the Plan's investment in an investment contract with insurance company which is stated at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

Benefits Payments. Benefits are recorded when paid.

Expenses and Revenue Credits. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are recordkeeping, investment management, contract administrator, withdrawal charges, and other fees. Additionally, certain investment related expenses are included in investment income.

As further discussed in Note 1, the Plan provides for revenue credits which are used to offset the Plan's administrative expenses. For the year ended December 31, 2024, the Plan's administrative expenses and revenue credits netted to \$83,515 which consisted of \$116,281 of administrative expenses and \$32,766 in revenue credits.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

- The common collective trust is valued at the NAV of units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment Contract with Insurance Company

During 2019, the Plan entered into a traditional benefit-responsive investment contract, the Guaranteed Interest Fund ("GIF"), with Empower Annuity Insurance Company of America ("EAIC"). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$340,314 and \$409,260, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- **Excessive Trading:** Based on EAIC's excessive trading policy, EAIC shall restrict a participant, alternate payee, or beneficiary from making a transfer into the GIF for up to thirty calendar days from the date of the most recent transfer from the GIF. Contributions and deposits, other than transfers, will be allowed into the GIF during the 30 day period.
- **Plan Sponsor Initiated Events:** The Plan Sponsor shall notify EAIC at least 30 calendar days prior to a Plan Sponsor initiated event. Plan Sponsor initiated events are events that materially impact the assets in the GIF as it relates to the Plan including, but not limited to, a spin-off, sale, merger, full or partial plan termination. In certain circumstances, a market value adjustment, as defined in the investment contract, may apply to Plan Sponsor initiated events.

- Contract Termination: Either EAIC or the Plan Sponsor may terminate the investment contract upon a 75 day written request to the other party. At least 60 days before the contract termination date, the Plan Sponsor must notify EAIC, in writing, of its selection of contract termination options. Such contract termination options include (a) lump sum payment with market value adjustment, (b) payment at book value, (c) payment in 20 quarterly installments, and (d) any other termination option allowable under applicable law as mutually agreed in writing by EAIC and Plan Sponsor. Upon termination of the contract by Plan Sponsor, transfer restrictions and a contract termination charge may apply.

The Plan administrator does not believe that the occurrence of any contract provisions which would limit the Plan's ability to transact at contract value with participants is probable.

Note 5 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment amounts, as shown in Notes 3 and 4;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- The investment information in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedules.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Company has adopted a Big Sky Retirement, Inc. Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7 – Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Nonexempt Prohibited Transaction

During 2024, 2023, 2022, and 2021, the Company had a nonexempt prohibited transaction related to participant contributions not remitted to the trust in a timely manner as listed in Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company corrected the 2023, 2022, and 2021 nonexempt prohibited transactions by remitting applicable principal amounts and lost earnings into the Plan's trust in September 2024. The Company intends to correct the 2024 nonexempt prohibited transactions by remitting lost earnings into the Plan's trust as soon as administratively feasible.

Note 9 – Party-In-Interest Transactions

Certain Plan investments are shares of an investment contract with insurance company offered by Empower Annuity Insurance Company of America. As Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan, these transactions qualify as party-in-interest transactions. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 10 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in mutual funds, a common collective trust, and an investment contract with insurance company. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was one investment which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
