### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of PREMIER 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Description of Plan:**

The following description of the PREMIER 401K Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of United National Corporation, First PREMIER Bank (the Bank), PREMIER Bankcard, LLC (Bankcard), and First PREMIER Corporation, collectively PREMIER. Employees must have at least one hour of service in each of four consecutive calendar months following employee's start date to be eligible to participate in the Plan. The entry date into the Plan is the first day of the month following the date that eligibility requirements are satisfied. Allocation of benefits is made bi-weekly to all eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions: Eligible participants may contribute to the Plan a percentage of their annual wages, not to exceed a specific dollar amount determined by the Internal Revenue Service. PREMIER will match 100% of the eligible participant's elective deferral up to a maximum contribution of 5% of the participant's salary. The Plan includes an automatic annual deferral increase for all participants of 1% up to 10%. An employee must opt out each year to prevent the automatic increase.

PREMIER, at its discretion, may make an additional contribution based on a percentage of its earnings for the year. This contribution would be credited to the participant's account based upon an integrated formula involving wages paid during the Plan year.

The Plan, by law, cannot recognize annual compensation in excess of a certain dollar limit, set annually by the IRS, which caps the annual contribution amount provided by PREMIER.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocations of PREMIER's contribution, and investment income net of expenses. Investment income or (losses) of the Plan are allocated based upon the participant's individual account balance and investment selection. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a stable value fund as investment options for participants.

Vesting: All participants in the Plan are 100% vested in their participant account balance.

Payment of Benefits: On termination of employment or having attained the age of 59 ½ years, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, part lump sum and part installments, or in installments over a specified period of time not exceeding the life expectancy of the participant or a designated beneficiary. If the value of the participant's vested interest is \$5,000 or less at the time of the participant's termination of employment, the employee may elect a lump sum distribution, or the balance will be automatically roll over into an Individual Retirement Account.

**2. Summary of Significant Accounting Policies:**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / depreciation includes the Plan's gains and losses on investments bought and sold as well as those held at the end of the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: All administrative expenses are paid by the Plan except when paid by PREMIER. Expenses that are paid by PREMIER are excluded from these financial statements. Investment related expenses are included in the net appreciation / depreciation of fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

**3. Plan Termination:**

Although it has not expressed any intent to do so, PREMIER has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act.

**4. Tax Status:**

The Plan obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax council believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* The fair value of participation units held in the Reliance Trust Stable Value Fund (MetLife Series 25053, Class M), a common/collective trust (CCT) is based on net asset value, as reported by the manager of the collective trust fund, Reliance Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The CCT invests in the MetLife Group Annuity Contract 25053, which consist of separately managed investment portfolios in fixed income securities, and also enters into wrapper contracts, which are issued by third-parties and are designed to allow the Fund to maintain a constant net asset value.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**7. Related Party Transactions and Party in Interest Transactions:**

Certain plan investments are managed by Empower Annuity Insurance Company of America, a division of Empower Trust Company, LLC. Empower Annuity Insurance Company of America is the trustee and recordkeeper for the plan and, therefore, these transactions qualify as a party-in-interest transactions. Intellicents provides investment and financial advisory services through Empower. All of the transactions between the Plan and the above listed vendors qualify as party in interest transactions.

The majority of the fees incurred by the Plan for administrative services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. The Plan or Plan Sponsor may make payments for administrative expenses not covered by revenue sharing.

**8. Information Prepared and Certified by Trustee:**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Retirement LLC, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the years then ended.
