## ADDENDUM TO FORM 5500

The foregoing Form 5500 for the 2024 plan year is for Catmint, Inc as a participating employer in the Pension Transfer Trust Plan, (plan sponsor's: EIN 45-3113208; plan number: 001), which was designed and intended to be, and has been operated as, a "multiple employer plan."
