Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **Southern Crown Partners, LLC Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the Southern Crown Partners, LLC Retirement Plan (the Plan) is provided for general information purposes only. It is the Plan for Southern Crown Partners, LLC (the Company). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company except for leased employees and non-resident aliens. Employees are eligible to participate on the first plan entry date following the completion of 60 days of service. Plan entry dates are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974. The Plan's Board of Directors oversee the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance.

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provision under the SECURE 2.0 Act:

- **Mandatory distributions:** The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000, as permitted by the Act.

Contributions

Participants may contribute up to 100% of their pretax annual compensation as defined in the Plan. However, the total elective deferrals by an individual participant cannot exceed the annual permissible dollar limit prescribed by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. In 2024, the Company contributed a discretionary matching contribution of 50% of the first 8% of compensation that a participant contributes to the Plan. In 2023, the Company contributed a discretionary matching contribution of 50% of the first 6% of compensation that a participant contributes to the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, an allocation of plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service according to the following schedule:

Investment options

Upon enrollment in the Plan, participants may direct their contributions and the Company's discretionary matching contributions in a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes receivable from participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and accrue interest at a rate of 4.25% to 9.50% which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Withdrawal and payment of benefits

On termination of service, if a participant's vested account balance does not exceed \$1,000, the Plan will automatically distribute the participant's vested account balance in a lump sum. If his or her vested account balance exceeds \$1,000 but is less than \$7,000, a participant may elect to receive a single lump sum or roll over the vested balance into an Individual Retirement Account (IRA) or other qualified plan. However, if no election is made by the participant, the Plan will automatically roll over the vested balance into an individual retirement plan designated by the plan administrator. If his or her account exceeds \$7,000, a participant may elect to receive the value of the participant's interest in his or her account in the form of a lump-sum distribution or roll over the vested balance into an IRA or other qualified plan or may leave their funds in the Plan.

In-service withdrawals are permitted once a participant has attained age 59½. Hardship withdrawals are permitted for participants who meet certain criteria as more fully described in the Plan's literature.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited discretionary matching may be used to reduce the Company's discretionary contribution. For the years ended December 31, 2024 and 2023, forfeited balances of terminated participant's non-vested accounts, and earnings thereon, totaled approximately \$182,962 and \$124,749, respectively.

Forfeited Accounts (continued)

During the years ended December 31, 2024 and 2023, forfeitures of \$76,394 and \$65,582, respectively, were used to pay plan fees. During the years ended December 31, 2024 and 2023, forfeitures of \$0 and \$168,020, respectively, were used to reduce employer matching contributions and correct employee contributions. Forfeited employer discretionary contributions available for future use totaled \$195,690 and \$89,122 as of December 31, 2024 and 2023, respectively.

Note 2. Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis by the custodian. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued or unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

Employer discretionary contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. Other administrative costs are charged to the individual participant's accounts. Contract administrative expenses and trustee fees are paid by the Company.

Note 3. Information Prepared and Certified by Trustee

Certain information related to investments and notes receivable from the participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years then ended, is obtained or derived from information supplied to the plan trustee and certified as complete and accurate by Ascensus LLC.

Note 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods described below may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

- *Shares of registered investment companies (mutual funds):* Valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Stable value common collective trust fund:* A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Party-In-Interest Transactions

Ascensus provided certain administrative and custodian services to the Plan. Ascensus is a fiduciary as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Ascensus during 2024 and 2023 were \$101,928 and \$78,839, respectively. The Plan made direct payments to the investment advisors totaling \$77,760 and \$66,033 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Tax Status

The Plan has obtained a determination letter for the prototype Non-Standardized Profit Sharing Plan with CODA adopted by the Company in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receipt of the determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9. Subsequent Events

In May 2025, the Plan documents were amended to add KW Beverage Company, LLC as a participating employer.

The Plan has evaluated subsequent events through September 16, 2025, the date which the financial statements were available to be issued. There were no additional material subsequent events to be disclosed as of this date.
