### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Regent Holding Company, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Opinion

### Note 1 - Description of Plan

The following description of Regent Holding Company, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of Regent Holding Company, LLC and its affiliates (the "Company") who are twenty-one (21) years of age or older and have completed three (3) consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to defer any amount of their eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants may make rollover contributions representing distributions from other qualified retirement plans. Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions equal to one hundred percent (100%) of the participant's elective deferral up to four percent (4%) of the participant's total eligible compensation for the year. The Company may also make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made for 2024 or 2023.

#### Participant investment account options

The Plan allows participants to direct their contributions and account balances among a diversified selection of mutual funds and a fixed income account offered by Voya Retirement Insurance and Annuity Company (Voya).

#### Participant accounts

Each participant's account is credited with the participant's deferral contribution, the Company safe harbor matching contribution, and an allocation of the Company discretionary profit sharing contribution, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Description of Plan (continued)

#### Vesting

Participants are immediately vested in their deferral contributions, safe harbor matching contributions, and qualified non-elective contributions, plus earnings thereon. Participants vest in the Company discretionary profit sharing contributions plus earnings thereon based upon years of service, with 100% vesting occurring after five years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. The minimum amount that can be borrowed is \$1,000. Loan repayment periods range from one to five years with the exception of loans borrowed for the purchase of a principal residence which range from one to 10 years. Participants are allowed a maximum of two loans outstanding at a time. The loans are secured by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is repaid ratably through payroll deductions.

#### Payment of benefits

Upon termination of service for any reason, participants may request account distributions in the form of a lump-sum payment or installments over a period of time, as defined in the plan document. Withdrawals by a participant while still employed are limited to those requested upon attainment of normal retirement age or age 59½. Hardship withdrawals are not permitted by the Plan.

#### Forfeited accounts

If an employee terminates before his or her discretionary profit sharing contribution account has become fully vested, such portion of the account is forfeited. Participant forfeitures can be used to pay plan administrative expenses, reallocated to participant accounts, to restore forfeited accounts, or to reduce Company contributions.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Profit sharing contributions are recorded in the year in which participant compensation is earned.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as benefits paid to participants based upon the terms of the plan document.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's accounts. Certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan, has certified that the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and the supplemental schedule is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and the supplemental schedule.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair value measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed interest account:* Valued at fair value by Voya discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to maturity. Therefore, the guaranteed interest accounts are not considered benefit-responsive and are valued at estimated fair value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

### Note 6 - Related party transactions and party-in-interest transactions

Certain Plan investments include a mutual fund and a fixed income account managed by Voya. Voya is the custodian as defined by the Plan and therefore, these investments and related investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. The Plan made direct payments to Voya for plan expenses totaling \$4,689 in 2024 and \$4,562 in 2023. The plan sponsor pays directly any other fees related to the Plan's operations.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become one hundred percent (100%) vested in their employer contributions.

### Note 8 - Tax status

The IRS has determined that the Non-Standardized Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the custodian of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, approximately 16% and 15% of the Plan's total investments were invested in the Vanguard 500 Index Fund, respectively.

### Note 10 - Subsequent events

Plan management has evaluated subsequent events through September 23, 2025, which is the date that the financial statements were available to be issued.
