Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

General

The following brief description of the Vitaquest International LLC 401(k) Savings Plan (Plan), is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan was established on March 1, 1982, and was most recently restated on January 1, 2021. The Plan is a defined contribution plan that covers substantially all employees of Vitaquest International LLC (Company or Plan Sponsor). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

Employees are eligible to participate in the Plan on the 1st day of the next month following the completion of three months of service and upon attainment of eighteen years of age.

Contributions

Participants may elect to contribute pre-tax or after tax deferral contributions up to 80% of eligible compensation as defined in the plan document, up to the maximum amount permitted by the Internal Revenue Code (IRC). Participants are automatically enrolled into the Plan at a deferral rate of 3% once they have completed the eligibility requirements. The safe harbor match is a non-elective contribution of 3% to each eligible participant. The Company may also make a discretionary contribution to the Plan in accordance with the provisions contained in the plan document. There were no discretionary contributions made by the Company for the year ended December 31, 2024.

Forfeitures

Unvested balances of participants terminating their employment are forfeited at the earlier of time the participant requests a distribution or after a break in service of 5 consecutive years. Forfeitures of the Plan are used to either reduce future Company contributions or to offset Plan administrative expenses. Forfeitures of approximately \$152,000 were applied to employer contributions for the year ended December 31, 2024. Forfeitures from employees including earnings approximated \$193,000 for the year ended December 31, 2024. The available forfeiture balance approximated \$200,000 and \$159,000 at December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their deferral contributions and safe harbor matching contributions, and non-elective contributions plus earnings thereon. Vesting in the Company's discretionary contributions is based on years of service, as follows:

Participant Accounts

Each participant's account is credited with their deferral contributions, employer contributions and the earnings thereon. Contributions to the Plan are invested by the trustees as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Payment of Benefits

Participants' vested interest in the Plan's assets are distributable generally upon termination, disability, retirement or death. In addition, participants may request withdrawals pursuant to specific guidelines as set forth in the Plan document.

Notes Receivable from Participants

Each participant is permitted to borrow 50% of his or her vested account balance up to a maximum of \$50,000. The term of a loan may not exceed five years, unless it is used to purchase a primary residence. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. Principal and interest are paid ratably through payroll deductions and monitored by the plan administrator. The loans are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%. Interest rates at December 31, 2024 ranged from 4.25% to 9.50%.

Administrative Expenses

A portion of administrative expenses for the Plan is paid directly by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value as determined by plan management (see Note 4 and 5). Purchases and sales of investment securities are recorded on a trade-date basis. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Information Certified by the Plan's Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America ("EAIC"), and Empower Trust Company, LLC ("ETC"), the trustees of the Plan, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract with Insurance Company

The Plan is party to an investment contract with Massachusetts Mutual Life Insurance Company (Mass Mutual) hereby allocated contributions are maintained in a Guaranteed Interest Account. The contract is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is fully-benefit responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Mass Mutual. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under the *Employee Retirement Income Security Act of 1974*. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The investment contract does not permit Mass Mutual or EAIC to terminate the agreement prior to the scheduled maturity date.

Note 5. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any

input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts are stated at the fair value based on the year end market value of each unit held, which is based upon the market value of the underlying assets of the funds less management fees. The pooled separate accounts do not have any unfunded commitments relating to their investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Risks and Uncertainties

The Plan's investments are concentrated in pooled separate accounts and a guaranteed interest account that invest in marketable securities, debt and fixed income securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 7. Related-Party Transactions

EAIC and ETC, the trustees of the Plan, manage certain plan investments, therefore, these transactions qualify as party-in-interest transactions. Fees paid to EAIC by the Plan for administrative services amounted to \$4,795 for the year ended December 31, 2024.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend, alter or terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, all participants' account balances shall be 100% vested and the account balances will be distributed to the participants by the Plan's trustees.

Note 9. Tax Status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's management and its tax counsel have analyzed the tax positions taken by the Plan, and have concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 10. Subsequent Events

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
