#### 1. Plan Description

The following description of Smith Freed & Eberhard, P.C. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan was established to provide a retirement savings program for eligible employees of Smith Freed & Eberhard, P.C. (the "Company" or "employer"). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan's operations including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

##### **Eligibility**

Employees who have attained 21 years of age and who have completed at least six months of service, with a minimum of 850 hours of credited service within the first six months of employment or one year of service if the 850 hours threshold is not satisfied, are eligible to participate in the elective salary deferral portion of the Plan and receive employer contributions, if any. Upon satisfaction of the respective eligibility requirements, participants may enter the Plan on the first day of the next calendar month.

##### **Contributions**

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan permits after-tax elective deferrals ("Roth Elective Deferrals"). Participants may also contribute amounts representing distributions from certain other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 7 percent of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Under the terms of the plan document, the employer is permitted to make discretionary matching and nonelective profit sharing contributions to the Plan. For the year ended December 31, 2024, the employer elected to remit qualified automatic contribution arrangement ("QACA") safe harbor nonelective contributions in the amount of 3 percent of each eligible employee's compensation, as defined by the plan document. Participants direct the investment of all contributions credited to their accounts into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer matching contributions, and allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions and employer safe harbor nonelective contributions plus actual earnings thereon. Vesting in the employer profit sharing and matching contributions portion of participant accounts is based on years of credited service. For these

employer contributions, participants vest according to a six year graded vesting schedule at the rate of 20 percent per year after two years of credited service. A participant is 100 percent vested after six years of credited service. QACA safe harbor contributions are fully vested after two years of credited service.

#### **Notes Receivable from Participants**

Under certain conditions, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are collateralized by the balance in the respective participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan's administrator. Principal and interest are paid ratably through monthly payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, resignation, discharge, retirement or proven hardship, a participant is eligible to receive a payment or payments in aggregate amounts up to the total value of the participant's vested interest in his or her account. Hardship withdrawals are permitted from the employee deferrals and rollover contributions portions of participant accounts.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,327 and \$8,057, respectively. These accounts may be used to pay expenses of the Plan or to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$15,395 from forfeited nonvested accounts.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan

repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

In preparing these financial statements, management has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the custodian for all of the Plan's assets as follows:

- **Pooled separate accounts:** Pooled separate accounts are valued at the unit value as reported by the issuer of the accounts each day the principal market is open. The fair value of investments in this category has been estimated by the investment manager using the net asset value of the underlying investments, which consist primarily of mutual funds, per unit of participation. The unit value of the Plan's investments in pooled separate accounts is not a publicly-quoted price in an active market. There are currently no significant redemption restrictions on these investments.
- **Insurance company general accounts:** Insurance company general account assets consist of investments in noninterest-bearing accounts offered and maintained by John Hancock Life Insurance Company. John Hancock Life Insurance Company maintains these assets in an insurance company general account; accordingly, the Plan's ability to receive the amounts due under these unallocated contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Noninterest-bearing accounts are valued at the amount payable on demand.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Stable Value Fund Investments**

The Plan holds an indirect investment in John Hancock Stable Value Fund ("Fund") which invests in collective trusts, group annuity contracts and synthetic investment contracts ("SICs") or wrap contracts issued by insurance companies or banks. The SICs or wrap contracts held by the Fund are participating, wherein the contract holder participates in gains and losses incurred due to the performance of the underlying portfolio relative to book value at times of withdrawals. Gains and losses are amortized through future crediting rate resets. Crediting rates on wrap contracts typically reset on a monthly or quarterly basis as negotiated with the wrap issuer and wrap contracts do not have a final stated maturity date. The wrap contract issuer guarantees a minimum crediting rate of not less than zero; however, a wrap does not absorb any loss for credit defaults in an underlying portfolio.

Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for the credit risk of the contract issuer or otherwise. Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events include but are not limited to termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these or certain other events, a market value adjustment may apply. The issuer reserves the right to delay withdrawal up to 12 months for a full or partial withdrawal of the Plan assets. Accordingly, the Plan's investments in the fund are deemed to not be fully benefit-responsive and are recorded at fair value in the accompanying financial statements.

**6. Related Party and Party-In-Interest Transactions**

Certain of the Plan's investments are managed by John Hancock Life Insurance Company ("John Hancock") or affiliated entities. John Hancock is the Plan's investment custodian as defined; therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid at the investment fund level rather than by direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments to certain vendors totaling \$70,659 for contract administration and other fees. The plan sponsor pays directly certain other fees related to the Plan's operations.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

#### 8. Plan Tax Status

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
