## INDEPENDENT AUDITORS' REPORT

To the Trustees  
TT Multiple Employer 401(k) Plan  
Federal Way, Washington

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TT Multiple Employer 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the TT Multiple Employer 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TT Multiple Employer 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TT Multiple Employer 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A.--DESCRIPTION OF PLAN**

The following description of TT Multiple Employer 401(k) Plan formerly known as Neltac Inc 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution 401(k) plan originally effective February 1, 2015, and was amended and restated January 31, 2022 as part of the Cycle 3 restatement requirements. Effective January 1, 2020 the Plan adopted the hardship provisions of the Bi Partisan Budget Act of 2018 and the Plan name changed to TT Multiple Employer 401(k) Plan, and Neltac Inc.; Michelle B. Nelson, Inc. PS; J&T Restaurant, Inc.; Hanna-Clore, Inc.; Jon D. Hanna – Taco Time; Hanna & Hanna, Inc.; Edward Keith, Inc.; JKL TT, Inc., and Nellies Restaurant Group, Inc became sponsors as participating employers in the TT Multiple Employer 401(k) Plan. Prior to January 1, 2020, Neltac Inc. was the only Plan sponsor. Then coinciding with this change, the Edward Keith Inc 401(k) Profit Sharing Plan & Trust, Hanna Clore Inc 401(k) Profit Sharing Plan & Trust, Hanna & Hanna Inc 401(k) Profit Sharing Plan & Trust, Jon D Hanna 401(k) Profit Sharing Plan & Trust, JKL TT Inc 401(k) Profit Sharing Plan & Trust, J & T Restaurant Inc 401(k) Profit Sharing Plan & Trust, Michelle B Nelson Inc PS 401(k) Profit Sharing Plan & Trust, and Nellies Restaurant Group Inc 401(k) Profit Sharing Plan & Trust merged into the TT Multiple Employer 401(k) Plan. Effective December 2021, Nellies Restaurant Group closed and is no longer a participating employer of the Plan. Effective November 2022, Jon D. Hanna Taco Time also closed. Effective December 31, 2023, the Plan was amended to remove Jon D. Hanna as a participating employer of the Plan. The term “Companies” will be used in the financial statements to mean Neltac Inc. prior to January 1, 2020, and the participating employer’s group as of January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). See also Note K.

*Eligibility:* An eligible employee is any person employed by the Companies excluding employees covered by a collective bargaining agreement, non-resident aliens with no U.S. income, and leased employees. Employees of the Companies are eligible to participate in the Plan on the first day of the first and seventh month of the Plan year upon reaching age 21 and after completing one year of service in which at least 1,000 hours are worked. In addition, participants must be employed as of the last day of the Plan year, to be eligible to receive any employer matching contributions except in the case of death, disability, or normal retirement.

*Contributions:* The Plan is funded by eligible participant elective deferrals and discretionary employer matching contributions. Participants may contribute on a pre-tax basis up to the maximum amount allowed by law. The Companies may elect to make discretionary matching contributions to the Plan. The Companies elected to match the lesser of 1.2% of eligible compensation or 20% of the employee’s contributions for the year ended December 31, 2024.

*Contributions (Continued):* All participants that are eligible to make deferral contributions may designate all or any portion as Roth elective deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirements plans. Contributions are subject to certain limitations.

*Participant Accounts:* Each participant's account is credited with the participant's contribution, allocation of the Companies' contributions and plan earnings (losses) and charged with certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

*Vesting:* Participants are immediately vested in their rollover contributions and elective deferral contributions plus actual earnings thereon. Participants vest in the Companies' contributions at the rate of 20% per year and are fully vested at the end of six years of credited service. All contributions are 100% vested upon the attainment of normal retirement age or termination of employment due to death or disability.

*Retirement:* The normal retirement date is the date on which the participant attains age 65. Early retirement is not permitted.

*Payment of Benefits:* On termination due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. If the balance of the vested accounts are \$5,000 or less, payment may be made in a lump-sum or rolled to an IRA at the participants' direction, or if no direction, it will automatically be rolled into an IRA without the participant's consent. The Plan permits in-service distributions at age 59½ and for qualified reservist distributions. Hardship distributions are allowed in accordance with safe harbor rules.

*Notes Receivable from Participants:* Participant loans from the Plan are not permitted.

*Investment Options:* Participants are allowed to direct their contributions and account balances in a variety of investment options. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

*Forfeitures:* Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures will be used to offset the Companies' contributions for the Plan year. At December 31, 2024 and 2023, forfeited non-vested balances totaled \$2,440 and \$5,487, respectively. For the year ended December 31, 2024, \$1,670 was forfeited from participant accounts, and \$4,800 of forfeitures were utilized to offset Plan expenses.

**NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines valuation utilizing information provided by investment advisors and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits:* Benefits are recorded when paid.

*Administrative Expenses:* Fund expenses, including 12(b) (1) revenue sharing fees, are deducted from each fund's earnings to arrive at net appreciation or depreciation as reported in the accompanying statement of changes in net assets available for benefits. Custodial and administrative expenses are paid with 12(b) (1) revenue sharing fees, and distribution expenses from participants are deducted from accounts of the respective Plan participants. Certain other expenses are paid by the Companies.

**NOTE C.--CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value and contract value of investments, dividend and interest income for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian of the Plan, Massachusetts Mutual Life Insurance Company ("Mass Mutual") by Empower Annuity Insurance Company of America ("EAIC"), an affiliate of Empower.

**NOTE D.--FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at NAV less operating expenses accrued but not deducted, if any, which is based on the fair value of the underlying investments held in such separate accounts. NAV per unit is used as a practical expedient for measuring fair value. Participant transactions may occur daily. Participants eligible to receive benefits may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty or notice. There are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate or consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. (b) These investments seek to maximize total returns from price appreciation and income. The funds pursue income opportunities from government, corporate, emerging market and high-yield sources. The investments may include United States (“U.S”) and non-U.S. corporate debt securities and sovereign debt securities.

(c) These funds seek to provide capital growth and appreciation by investing in equity securities of growth oriented companies.

(d) These funds seek to provide capital growth and appreciation by investing in equity securities which are considered to be a good value relative to underlying company fundamentals.

(e) These funds seek to provide capital growth and income by investing in equity securities and fixed income securities in appropriate weightings base on the number of years until the participant reaches retirement age.

(f) These funds seek to provide capital growth and appreciation. The funds seek to achieve the objective by investing a portion of its net assets in (1) healthcare related equity securities that explore or develop natural resources and other basic commodities or supply goods and services to such companies, or (2) common stocks and other equity securities of real estate companies.

**NOTE E.--INVESTMENT CONTRACT WITH INSURANCE COMPANY**

Effective January 1, 2020, the Plan entered into a group variable annuity contract with Mass Mutual. On December 31, 2020, EAIC acquired the retirement business of Mass Mutual. Following an initial transition period, Empower became the sole administrator of this business in 2021.

Investment options with Mass Mutual/EAIC include investments in Pooled Separate Investment Accounts (SIA-CAI) and a fixed account. The fixed account is fully benefit-responsive and therefore reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate transactions under the terms of the plan.

Contract value, as reported to the Plan by Mass Mutual/EAIC, represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024, and 2023, was \$70,631 and \$78,360, respectively.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**NOTE E.--INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

The crediting interest rate is based on a formula agreed upon with the issuer and may not be less than the minimum guaranteed rate of 1.35%. The declared rate was 2.80% and 1.35% at December 31, 2024 and 2023, respectively. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Mass Mutual/EAIC. Such events may include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, and partial or total plan termination. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator does not believe the occurrence of any such event which would limit the Plan's ability to transact at contract value are notable of occurring.

Mass Mutual/EAIC may terminate the contract by 90 days written notice. It may also cancel for certain reasons which include the following: (1) the Plan or Plan trust fails to maintain its special tax qualified or exempt status under 401(a) of the Code, (2) the Plan fails to provide the information necessary to perform the contract and the Plan fails to remedy the failure within 31 days from the notification date, (3) the Plan trust is amended in a way that adversely affects obligations under this contract, (4) all contracts in this class of business are amended, changed or altered due to changes in any applicable laws and it is determined that obligations under this contract or ability to maintain this class of business are thereby materially affected, (5) the assets held or the participants covered under the contract are less than the amount required for the contract to be a group annuity under any applicable insurance law, (6) the Plan changes such that the Plan is no longer considered to be an entity which is authorized or eligible to sponsor this contract, (7) no contributions are made to this investment during any consecutive 12-month period, (8) at any time the contributions or balances are less than the amount required for this class of business under the underwriting standards in effect as of the contract effective date.

The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The Plan may terminate the contract at any time by written notice. For the fixed account, a liquidation factor may apply to balances as of the transfer date upon termination of the contract by either party.

**NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are in funds managed by the custodian, Mass Mutual under power of attorney granted to EAIC (an affiliate of Empower); therefore, these transactions would qualify as party-in-interest transactions. Additionally, the Plan may incur 12(b)(1) revenue sharing fees used to offset costs of administering the Plan. Certain administrative functions of the Plan are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan.

**NOTE G.--TAX STATUS**

The Plan was amended and restated effective January 1, 2022 and adopted a non-standardized pre-approved profit sharing plan with CODA which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan including employer contributions shall become fully vested and non-forfeitable.

**NOTE I.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE J.--OPERATIONAL ERROR**

During the year ended December 31, 2024, it was discovered that one employee's deferrals were not turned off and subsequently re-elected following their termination and eventual rehire, as required. The error was discovered in 2025 and Plan management calculated the contributions and earnings of \$189 for a corrective distribution to the participant, while employer matching contributions and earnings will be forfeited.

**NOTE K.--SUBSEQUENT EVENTS**

Effective January 1, 2025, as part of the SECURE 2.0 Act, the Plan adopted the optional provision to allow long-term part time employees to receive matching contributions.

Effective January 1, 2025, the Plan was amended to remove Hanna & Hanna, Inc. and Hanna - Clore, Inc., as participating employers in the Plan.

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
