## **Independent Auditors' Report**

To the Trustees and Management of  
Churchill Opco Holding LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Churchill Opco Holding LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Churchill Opco Holding LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ending December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Churchill Opco Holding LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. DESCRIPTION OF PLAN**

The Churchill Opco Holding LLC 401(k) Plan (the Plan) was originally established and effective as of June 1, 2021. Since that date the Plan has been amended and restated to change key provisions of the Plan, as well as to maintain compliance with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following briefly describes the Churchill Opco Holding LLC 401(k) Plan. The description is provided for general information purposes only. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution 401(k) profit sharing plan that covers substantially all of the employees of Churchill Opco Holding LLC (the Employer). Employees become eligible to participate in the Plan upon attaining age 21 and completing 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participant

Participants may elect to defer compensation as defined in the plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer

The Employer will make safe harbor matching contributions for all eligible participants in the Plan. The Employer's match was 100% of eligible compensation for the first 3% deferred by employees and 50% of the next 2% for the years ended December 31, 2024 and 2023.

The Employer may, at its sole discretion, make non-elective contribution to the plan on Participants behalf. To be eligible for the non-elective contribution you must have at least one hour of service during the plan year. There were no non-elective contributions for the years ended December 31, 2024 and 2023.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions and (b) Plan earnings, and charged with any investment or administrative fees. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-four mutual funds, six pooled accounts, thirteen common/collective trusts and an investment contract as investment options for participants.

**1. DESCRIPTION OF PLAN**

*Vesting*

Participants are immediately vested in their contributions, matching employer contributions, and rollover contributions plus actual earnings thereon. Vesting in the Employer's non-elective contribution portion of their accounts is based on years of continuous service. A six-year graded vesting schedule is used to determine the accumulated plan benefits attributed to the Employer's contributions. An employee begins to vest at 20% a year starting with the second year of service until the sixth year, at which time the employee is 100% vested.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate + 2% (5.25% to 10.50% as of December 31, 2024). Principal and interest are made ratably through payroll deductions over a period not to exceed five years, unless extended because the participant is on qualified military service leave.

*Payment of Benefits*

Upon termination of service due to death, disability or retirement, participants or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment or in annual installments through one of several annuity options. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in a lump sum distribution, choose or be required to make a rollover of the funds as governed by the Plan, or choose to leave the money in the Plan if the value exceeds \$5,000.

*Administrative Expenses*

The Employer pays the expenses associated with the administration of the Plan, except for certain investment management fees and loan fees which are deducted directly from the participant's account.

*Forfeited Accounts*

If a participant's employment is terminated, the non-vested portion of his or her account balance becomes subject to forfeiture. At December 31, 2024 and 2023, forfeited nonvested accounts were \$1 and \$3,964, respectively. Such forfeitures will be allocated and used in accordance with the plan document. Forfeitures allocated and used by the Plan for the years ended December 31, 2024 and 2023 were \$3,964, and \$-0-, respectively.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Date of Management's Review***

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds and common/collective trusts are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The pooled separate accounts are proprietary to and invested in underlying mutual funds; these pooled separate accounts are valued at fair value based on the underlying mutual funds unit value of account. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balances plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Parties-in-Interest***

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Level 2 Fair Value Measurements*

The underlying mutual funds of the common/collective trusts and pooled separate accounts are traded in public markets and are valued at their adjusted unit values on the last business day of the fiscal year based on unadjusted quoted market prices within active markets.

**4. FAIR VALUE MEASUREMENTS**

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1, 2 and 3.

**5. INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan has two investment contracts with Principal Life Insurance Company. Principal Trust Company administers the contracts. Principal Trust Company maintains the contributions in the Principal Fixed Income Guaranteed Option (terminated and liquidated December 2024) and Principal Guaranteed Option (commenced March 2024). The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. This investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The contracts are included in the financial statements at contract value as reported to the Plan by Principal Trust Company. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contracts.

Certain events limit the Plan's ability to transact at contract value with Principal Trust Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**5. INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, Churchill Opco Holding LLC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**7. TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator had analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. PROHIBITED TRANSACTIONS**

Delinquent deposits of participant contributions were identified on the 2023 Form 5500, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions. All delinquent deposits were corrected and made to the Plan, including lost earnings, subsequent to the December 31, 2023 year end.

Going forward, corrective action has been developed to ensure the timely deposit of participant deferrals.
