To the Plan Administrator

Opinion

We have audited the financial statements of Mirra Company, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of Mirra Company, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General –

The Plan is a defined contribution plan covering all employees of Mirra Company, LLC (the Company) who are at least 18 years of age and have completed three months of service, except for union employees, non-resident aliens, and leased employees, as defined. Employees may enter the Plan on the first day of the quarter coinciding with or immediately following the date on which these eligibility requirements are met. Sentinel Benefits & Financial Group (Sentinel) provides recordkeeping and administrative services to the Plan and National Financial Services (NFS) holds the Plan's assets. Two officers of the Company serve as the Plan's Trustees. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions –

Participants may defer up to a maximum of 100% of their eligible compensation, as defined by the Plan, on a pre-tax or Roth basis not to exceed the annual dollar limit established under the Code. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company, at its discretion, may elect to make matching contributions to the Plan. A participant is entitled to matching contributions once enrolled in the Plan and making deferral contributions. For the years ended December 31, 2024 and 2023, the Company elected to match 75% of participant deferrals up to the first 6% of eligible compensation. For the years ended December 31, 2024 and 2023, the Company made matching contributions totaling \$464,607 and \$456,812, respectively.

The Company, at its discretion, may make profit sharing contributions to the Plan. To be eligible for a profit sharing contribution, a participant must be employed by the Company on the last day of the Plan year unless termination of service is due to death, disability, or retirement. Company profit sharing contributions are allocated based on employee classifications. The allocation method will be pro rata based on compensation in that classification. For the years ended December 31, 2024 and 2023, the Company elected not to make profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts –

Each participant's account is credited with the participant's deferral contributions, the Company's matching contribution, the Company's profit sharing contribution, an allocation of the Plan's investment earnings or losses, and is charged with an allocation of certain administrative expenses, if applicable. Allocations are based on account balances or participants' compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting –

Participants are immediately vested in their contributions and rollover contributions, plus earnings thereon. Also, upon reaching normal retirement age of 55, participants become 100% vested in all of their accounts. Vesting in Company matching and profit sharing contributions is based on years of continuous service, as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Notes Receivable from Participants –

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within 5 years unless the loan is to be used for the purchase of a primary residence in which case the loan may be repaid within a period of no more than 30 years. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits –

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount, partial withdrawals or installment payments equal to the value of the participant's vested interest in their account. A participant may withdraw from their rollover account at any time. In-service withdrawals from the participant's account are available upon reaching age 59 ½. If a participant's account balance is less than \$7,000 (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act), the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA).

Hardship withdrawals are available from the participant's account in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

1. DESCRIPTION OF PLAN (Continued)

Forfeitures –

Forfeitures are used to pay plan expenses or offset future Company contributions to the Plan. At December 31, 2024 and 2023, unallocated forfeitures amounted to \$9,277 and \$20,594, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$21,077 and \$19,674, respectively, were used to pay administrative expenses. No forfeitures were used to offset Company matching contributions during the year ended December 31, 2024. During the year ended December 31, 2023, forfeitures of \$22,000 were used to offset Company matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition –

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits –

Benefits are recorded when paid.

Administrative Expenses –

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The total amount of investment related expenses, including certain investment advisory fees that were paid out of Plan assets for the years ended December 31, 2024 and 2023 were \$63,768 and \$52,804, respectively.

The Plan has a revenue sharing agreement with NFS that provides for expense reimbursements to the Plan. These reimbursements are held in an ERISA expense account and are utilized to pay for Plan administrative expenses. During the years ended December 31, 2024 and 2023, the Plan received \$5,157 and \$3,967, respectively, of expense reimbursements which were utilized to pay Plan administrative expenses. At December 31, 2024 and 2023, there was \$1,363 and \$1,065, respectively, of unallocated amounts in the ERISA expense account.

Date of Management's Review –

The Plan has evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts:

Valued at the NAV of units in the collective trust fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the collective trust fund in order to ensure that securities liquidation will be carried out in an orderly business manner.

4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. TAX STATUS

The Plan has adopted a volume submitter profit sharing plan with CODA (cash or deferred arrangement) and relies on the volume submitter's opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all Company contributions.

7. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include mutual funds that are managed by an affiliate of NFS. Additionally, the Plan paid administrative expenses of \$63,768 and \$52,804 to Sentinel during the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.
