## Notes to Financial Statements

### 1. Description of Plan

The following description of Standard Profit Sharing Plan Plus 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan operates as a multiple employer plan. Employers participating in the Plan (collectively, the "Companies") include the following:

Standard Nutrition Company

Standard Dairy Consultants, LLC

Standard Nutrition Services, LLC

Hawkeye Sow Centers, Inc. (ceased participation effective August 27, 2024)

Kerber Milling Company (ceased participation effective August 27, 2024)

Ag Property Solutions

Bluebonnet Feeds, LLC

Dairy Specialists, LLC

TDSG, LLC

On August 28, 2024, the Plan transferred out all assets of Hawkeye Sow Centers, Inc. and Kerber Milling Company and participant accounts in the amount of \$4,699,821, pursuant to participant cessation resolution agreements executed by Hawkeye Sow Centers, Inc., Kerber Milling Company, and Standard Nutrition Company.

*General.* The Plan is a pooled employer defined contribution plan established effective June 1, 1944, as restated January 1, 2021. The Plan covers all employees, excluding union and non-resident alien employees, of the Companies who have completed 2 months and are age 18 or older. Employees who are 18 or older, have completed one year of service, as defined, and are employed on the last day of the year are eligible for the discretionary employer profit sharing contribution. Employees do not need to contribute to the Plan in order to receive a profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

## Standard Profit Sharing Plan Plus 401(k) Plan

### Notes to Financial Statements

*Contributions.* Each year, participants may contribute a percentage of compensation or a dollar amount up to the amount permitted by law. Contributions can be made tax-deferred or after-tax, but the combination of contributions may not exceed amounts permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan permits participants to elect to automatically escalate elective deferrals by 1, 2, or 3% of compensation each year, up to a maximum of 25% of compensation. Participants may also contribute amounts representing distributions from other qualified plans. The Companies have adopted 401(k) safe harbor provisions. The Companies' safe harbor matching contributions equal the sum of 100% of participant's elective deferrals up to 3% of participant's compensation plus 50% of participant's elective deferrals that exceed 3% of participant's compensation but do not exceed 5% of participant's compensation. Contributions are deposited into participants' accounts, which they can then direct to the investments they choose. The Companies' profit sharing amounts are contributed at the discretion of the Companies' boards of directors. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant accounts.* Each participant's account is credited with the participant's contributions, Companies' safe harbor matching contributions, allocations of the Companies' discretionary profit sharing contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their contributions and the Companies' safe harbor matching contributions plus actual earnings thereon. Vesting in the Companies' profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 20 percent vested after 2 years of credited service and continues to vest in increments of 20 percent until 100 percent vested after 6 years of credited service, death, disability or a normal retirement age.

*Notes receivable from participants.* New loans are not permitted by the Plan. In connection with the plan mergers in 2020 and 2022, the Plan permitted existing loans in the Hawkeye Sow Centers, Inc. 401(k) Profit Sharing Plan and the Dairy Specialists, LLC 401(k) Profit Sharing Plan in the amounts of \$66,828 and \$28,174, respectively, to be grandfathered into the Plan under the terms previously established. The loans are secured by the balance in the participant's vested account and bear interest at 5.25%. Principal and interest are paid ratably over a period not to exceed 5 years.

*Payment of benefits.* On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of an individual retirement account (IRA) rollover. In addition, the Plan allows for hardship distributions if certain criteria are met.

*Forfeited accounts.* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$60,576 and \$31,414, respectively. These accounts will be used to reduce future employer contributions. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

### **2. Summary of Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reported as distributions based on the terms of the Plan document. Related fees are paid by plan participants and are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### *Subsequent Events*

Subsequent events were evaluated through September 29, 2025, the date the financial statements were available to be issued.

### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Investment Trust Funds:* The NAV of the common collective investment trust funds is valued at fair value based on the NAV of the observable market prices of the underlying assets within that account less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair values.

*Self-Directed Brokerage Account:* Consists of money market accounts valued based on quoted market prices.

#### **4. Information Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

#### **5. Related-Party and Party In Interest Transactions**

Certain Plan investments with balances of \$2,234,015 and \$2,870,625 at December 31, 2024 and 2023, respectively, are managed by affiliates of John Hancock Trust Company, LLC, the trustee for the Plan, and therefore, these transactions qualify as party in interest transactions. Fees paid to John Hancock Trust Company, LLC and affiliates amounted to \$35,959 for the year ended December 31, 2024.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. John Hancock Trust Company, LLC receives revenue from investment fund service providers for services John Hancock Trust Company, LLC provides to the funds. This revenue is used to offset certain amounts owed to John Hancock Trust Company, LLC for its administrative services to the Plan. If the revenue received by John Hancock Trust Company, LLC from such investment fund service providers exceeds the amount owed for its services, John Hancock Trust Company, LLC remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to John Hancock Trust Company, LLC for administrative expenses not covered by revenue sharing.

Notes receivable from participants are assets of the Plan due from plan participants and, therefore, qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan.

These transactions are exempt party in interest transactions under ERISA.

#### **6. Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer profit sharing contributions.

#### **7. Tax Status**

The Plan adopted a pre-approved plan offered by John Hancock Retirement Services LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
