Notes to Financial Statements

1. Description of the Plan

General

The following description of Hord Coplan Macht, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all eligible employees of Hord Coplan Macht, Inc. (the Employer) except those considered part-time or temporary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration

Voya Retirement Insurance and Annuity Company (Voya) has been engaged to serve as the custodian of the Plan, and the recordkeeper that processes and maintains the records of participant data. The Employer has appointed individual trustees to the Plan. The Employer serves as the Plan Administrator. The Plan Administrator and trustees are responsible for the day-to-day operations and oversight of the Plan.

Participant Contributions

Participants may elect to contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Roth deferrals are also permitted. A Roth deferral is an elective deferral the participant irrevocably designates as a Roth deferral and is subject to income tax when contributed to the Plan. Participants who elect to contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Internal Revenue Code (IRC). Participants are permitted to make rollover contributions of amounts received from other tax-qualified retirement plans. Contributions are invested in accordance with the participant's election in any or all of the investment options available under the Plan and may be redirected online at any time subject to certain limitations by the funds.

Effective January 1, 2022, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Employer Contributions

The Employer may make a discretionary matching contribution for each pay period to all eligible employees. Additionally, the Employer may make a discretionary profit-sharing contribution to the Plan. During 2024, the Company matched 7% of participants' eligible compensation (maximum match of \$2,500). There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, as well as allocations of the Employer discretionary profit-sharing contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their salary deferrals, rollover contributions and related earnings thereon. Vesting in the Employer's discretionary matching and non-elective profit-sharing contributions is based on years of continuous service as follows:

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's vested account balance and no more than one outstanding note is permitted at any time. Such notes bear interest at one percent over the prime rate and must be repaid to the Plan within a five-year period, unless the note is used to purchase a principal residence. The specific terms and conditions of such notes are established by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Forfeitures

Forfeited non-vested account balances are used to offset Employer contributions or reduce Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,223 and \$11,509, respectively. During 2024, \$56,591 in forfeitures were used to reduce Employer discretionary matching contributions.

Payment of Benefits

Benefit payments are available to participants upon retirement, termination of employment, death, disability, or attainment of age 59 ½. The participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested account, unless the participant or beneficiary elects another option provided by the Plan. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for hardship purposes. Distributions are subject to the applicable provisions of the Plan agreement. In addition, upon termination, the Plan allows for automatic lump sum distributions of participant vested account balances that do not exceed \$5,000. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Voya. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 5) is valued at contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the note receivable balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative and recordkeeping fees are paid by the Plan and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The Plan's investments are using net asset value (NAV) as the practical expedient to measure fair value; therefore, the fair value hierarchy is not presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts

Valued at NAV of the units held by the Plan at the end of the year. The NAV is determined by Voya and is not publicly quoted. The NAV is primarily based on the underlying assets owned by the pooled separate accounts, minus any liabilities, and then divided by the number of shares outstanding. The NAV per unit is used as the practical expedient to estimate fair value.

Investments measured at NAV totaled \$50,272,495 and \$42,204,565 as of December 31, 2024 and 2023, respectively. In accordance with the Financial Accounting Standards Board (FASB) ASC 820-10, investments that are measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts disclosed are intended to permit reconciliation to the amounts presented in the statements of net assets available for benefits.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured Using the NAV per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice is applicable only to the Plan. There are no unfunded commitments related to these investments. These investments are direct filing entities.

5. Fully Benefit-Responsive Investment Contract

The Plan has a group annuity contract with Voya, which invests in the Fixed Account, a general account product in which participant principal and interest is fully guaranteed by the general account assets of Voya. For the years ended December 31, 2024 and 2023, contract value was \$442,412 and \$508,153, respectively.

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investments contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Voya, represents contributions plus earnings less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting. Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents, (b) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (c) bankruptcy of the Company or other Company events, and (d) the failure of the Plan to qualify for exemption of Federal Income taxes. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

6. Related Party and Party-in-Interest Transactions

Plan investments are in funds and accounts that are managed by Voya. Fees for certain participant-initiated transactions and services are paid to Voya by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants would become fully vested in their accounts.

8. Tax Status

The Plan uses a pre-approved profit sharing/money purchase/CODA plan document sponsored by Voya. Voya received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan's investment options provide participants with a variety of investment alternatives with differing levels of risk and income potential. Investment securities are exposed to various risks such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the financial statements.

10. Subsequent Events

The Plan Administrator has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
