Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements is:

The trustee's estimate of the investment valuation is based on fair market value. We evaluated the methods, assumptions, and data used to develop the investment valuation in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements relate to:

- Fair Value Measurements
- Fully Benefit Responsive Investment Contracts
- And Risk and Uncertainties.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No misstatements were identified.

#### *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified no reportable findings.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

*Other Audit Findings or Issues*

No other significant audit findings or issues, including any circumstances that could affect the form or content of the report were found.

*Other Matters*

With respect to the ERISA-required supplemental schedules accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of the plan administrator and management of Industrial, General, Polytemp, IGP, and Independent 401K PSP and is not intended to be, and should not be, used by anyone other than these specified parties.

### DESCRIPTION OF PLAN

The following description of the Industrial, General, Polytemp, IGP and Independent (“the Company”) 401(k) PSP (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all non-union employees of the Company who have worked two months and are age 18 or older. Eligible employees may enter the Plan immediately upon meeting all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer matching contributions are discretionary and based on a discretionary percentage of the participant's compensation. For the year ended December 31, 2024 and 2023 employer discretionary contributions were equal to 100% of the employees first \$2,500 of contributions. Discretionary contributions for the year ended December 31, 2024 and 2023 totaled \$312,422 and \$293,413, respectively.

Contributions are subject to certain IRS limitations.

#### Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies as investment options for participants. Participants may direct contributions in investment options in percent increments or fixed dollar amounts. All employer contributions are invested in the same funds in which the participants invest their own contributions.

#### Participant accounts

Each participant's account is credited with the participant's contribution and the Company's discretionary matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**DESCRIPTION OF PLAN (Continued)**

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's discretionary contribution and nonelective contribution portions of their account is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Recently Passed Legislation

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans that became effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the plan.

Notes receivable from participants

Participants may borrow from their fund up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the aggregate dollar amount of loans outstanding. Loan terms range from 1 to 5 years or longer if the loan is for the purchase of a primary residence provided documentation as to the purpose of the loan is made available. The loans are secured by the balance in the participant's account. The loan must bear a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions or by direct payments to the plan's custodian.

Payment of benefits

On termination of service a participant may elect to receive a partial distribution or a lump sum amount equal to the value of the participant's vested interest in his or her account if their account balance exceeds \$1,000. If a participant's account balance does not exceed \$1,000 a participant will receive a lump sum distribution. In addition, a participant may receive a distribution from the Plan prior to termination of employment if the participant has obtained the age of 59 ½ or to satisfy certain immediate and heavy financial needs of the participant if there is a financial hardship.

Forfeited accounts

Forfeitures will be allotted to participants in an equitable manner. During the year ended December 31, 2024 reallocated forfeitures to participants totaled \$49,853. The forfeiture balance as of December 31, 2024 and 2023 was \$38,545 and \$29,674, respectively.

### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Administration of plan assets

The Plan's assets are currently held by Empower Annuity Insurance Company of America. As prototype sponsor of the Plan, they provide recordkeeping and investment services for the Plan. They are also the third-party administrator and provide administrative services including preparation of all required annual filings. Investment advisory services are provided by Onedigital Investment Advisors, LLC. Administrative expenses are paid first by Plan's earnings, prior to being allocated to the participant accounts. During the years ended December 31, 2024 and 2023, \$36,243 and \$28,301 were paid out in administrative expenses, respectively.

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policy utilizing information provided by the investment advisors and custodians. See the **FAIR VALUE MEASUREMENTS** note for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and expensed when they are incurred.

No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent events

The plan has evaluated subsequent events through September 25, 2025, the date these financial statements were available to issue.

### FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

---

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2 Inputs other than quoted prices included within Level 1, to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

Certain Plan investments are shares of registered investment companies managed by Empower Annuity Insurance Company of America (“Empower”). Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Investment advisory services are provided by Onedigital Investment Advisors, LLC. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

As described in the **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**, the Plan made direct payments to the trustee of \$17,688 and \$18,554 to the investment advisor for the year ended December 31, 2024. These payments were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

### **PLAN TERMINATION**

Although it has not expressed the intent to do so, the Company has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### **TAX STATUS**

The volume submitter document, upon which the Plan was designed received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Plan is qualified under Internal Revenue Code ("IRC") section 401. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan was amended subsequent to receiving the opinion letter, however, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
