## Independent Auditor's Report

We are required to be independent of the Midwest Motor Supply Corporate 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Midwest Motor Supply Corporate 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of the plan**

The following description of the Midwest Motor Supply Corporate 401(k) Plan (the “Plan”), is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

**General**

The Plan is a defined contribution plan covering employees, except sales representatives and field sales managers, of Midwest Motor Supply Company and affiliates (the “Employer”) who have completed 60 days of service and have attained age 21.

**Amendment**

Effective January 1, 2024, the Plan was amended to allow for participant Roth deferrals.

**Trustee**

Reliance Trust Company is the trustee (“Trustee”) and holds the Plan’s investments. T. Rowe Price Retirement Plan Services, Inc. (“TRPRPS”), an affiliate of T. Rowe Price (“TRP”), is the third party recordkeeper.

**Administration**

The Plan is administered by the Employer.

**Contributions**

**Employer**

***Matching:***

Effective January 1, 2023, the Employer provides a safe harbor matching contribution of 100% on the first three percent and 50% on the next two percent of the participant’s voluntary tax-deferred and catch-up contributions, based on a payroll period basis.

***Profit sharing:***

Prior to January 1, 2023 the Employer provided a discretionary profit sharing contribution.

**Participant**

***Participant’s voluntary contributions:***

Participants may elect to make voluntary tax-deferred, after-tax Roth, or any combination thereof his or her annual compensation up to the maximum permitted under Section 402(g) of the Internal Revenue Code (the “Code”). For 2024, the combined total of tax-deferred and after-tax Roth contributions were limited to \$23,000.

***Catch-up contribution:***

Participants who reached age 50 during the Plan year are eligible to make catch-up contributions in accordance with the Code. In 2024, total catch-up contributions were limited to \$7,500.

**Investment options**

Participant contributions can be directed into various investment options offered by the Plan solely at the participant's discretion. If a participant makes no investment fund election, any contributions made into such participant's account are invested into the Plan's default investment funds. The default investment funds are the age-appropriate T. Rowe Price Target Date mutual funds, which are selected based on the participant's date of birth.

**Participant accounts**

Each participant's account is credited with the participant's and Employer's contributions as well as allocated investment earnings and administrative expense. The benefit to which a participant is entitled is equal to the vested balance in the participant's account.

**Vesting**

A participant is fully and immediately vested in their voluntary contributions, rollover contributions, and employer matching contributions.

A participant is credited with one year of vesting service in the Employer's prior profit sharing contributions and related investment income (loss) for each Plan year that the participant is credited with at least 1,000 hours of service.

A summary of vesting percentages relating to Employer's profit sharing contribution and related investment income is as follows:

**Forfeitures**

Forfeitures are used to reduce the Employer's contributions to the Plan or pay Plan expenses. Forfeitures of \$2,447 were used to pay Plan expenses for the Plan year ended December 31, 2024. There were no unused forfeitures as of December 31, 2024 and \$843 as of December 31, 2023.

**Benefits paid to participants or beneficiaries**

The full value of participants' accounts becomes payable upon retirement (age 65), early retirement (age 55) with ten years of service, disability, or death. Upon termination of employment for any other reason, participants' accounts, to the extent vested, become payable. Participants with vested account balances exceeding the cash-out threshold, as defined in the Plan document, may choose to leave their accounts invested in the Plan. Participants with vested account balances at or below this threshold, who have not

elected to receive a distribution or roll it over to an eligible retirement plan, will have their balance rolled over to an individual retirement account (IRA) with a properly accredited and regulated financial institution. All benefits will be paid as a lump-sum distribution. Participants have the option of having the benefit paid directly to an eligible retirement plan specified by the participant.

Terminated participants, based on age, are required to take minimum annual distributions in accordance with Section 401(a)(9) of the Code. Minimum annual distributions are also required for participants who are 5% owners (as defined in Section 416 of the Code).

Upon reaching age 55 with fifteen years of service or by reaching 59 ½, an active participant may withdraw up to 100% of their vested account balance.

A participant may also request a hardship distribution due to an immediate and heavy financial need based on the terms of the Plan.

### **Amounts allocated to participants withdrawn from the plan**

There are no amounts allocated, but not yet paid, to participants withdrawn from the Plan as of December 31, 2024 and 2023.

### **Administrative expenses**

Certain expenses of the Plan are paid directly by the Employer and are excluded from these financial statements. Additionally, Plan participants pay administrative expenses of the Plan through fees deducted directly from participant accounts on a quarterly and per-participant basis.

## **2. Summary of accounting policies**

### **Basis of presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Estimates**

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from these estimates.

### **Risks**

The Plan invests in various investments as described in Note 1. Any investment is exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. These risks could result in a material effect on participants’ account balances and the amounts reported in the statements of net assets

available for benefits and the statement of changes in net assets available for benefits.

**Net appreciation (depreciation) in fair value of investments**

Net realized and unrealized appreciation (depreciation) are recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

**Investment valuation and income recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis.

**Contributions**

Contributions from Plan participants, and the related matching contributions from the Employer, are recorded in the year in which the participant contributions are withheld from compensation.

**Excess contributions**

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability with a corresponding reduction to contributions. The Plan distributed \$29,437 consisting of \$26,342 in excess contributions and \$3,095 in investment gains to the applicable participants during 2024.

**Benefits paid to participants or beneficiaries**

Benefits paid to participants or beneficiaries are recorded in the statement of changes in net assets available for benefits when paid.

**Subsequent events**

Subsequent events have been evaluated through September 9, 2025, the date the financial statements were available to be issued.

**3. Fair value measurement**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted market price in the active market which the individual securities are traded and are classified within level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information certified by the trustee**

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments and earnings from investments for the year ended December 31, 2024 was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**5. Tax status**

The Plan sponsor adopted a non-standardized pre-approved plan document. The Internal Revenue Service (“IRS”) has determined and informed the pre-approved plan sponsor, by an opinion letter dated on June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Plan termination**

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time. The Employer has the right at any time to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

**7. Parties-in-interest**

The Employer provides certain administrative services to the Plan at no charge. The investments held by the Plan are managed by TRP for which they receive management fees. These fees result in a reduction of earnings from investments. These transactions are party-in-interest transactions, which are exempt under ERISA.
