Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Segal Group Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in *the Auditor's Responsibilities for the Audit of the Financial Statements* section:

Basis for Opinion

Notes to Financial Statements December 31, 2024 and 2023

Note 1 - Description of Plan

The following brief description of The Segal Group Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Company is defined as The Segal Group, Inc.

General

The Plan is a defined contribution plan that covers all full-time and part-time employees of the Company as soon as practicable following the employees' employment commencement date, a group of whom are covered under a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's Board of Trustees is responsible for oversight of the Plan, which includes the appropriateness of the Plan's investment offerings and monitors investment performance.

Auto-enrollment

New hires are automatically enrolled in the Plan and accounts are established so that pre-tax contributions equal to 6% of pay are automatically deducted from employee salaries unless they opt out or elect a different contribution level.

Contributions

Each year, participants may make voluntary, pre-tax and/or after-tax contributions to the Plan from 1% up to 85% of their annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum voluntary pre-tax contribution permitted by Section 402(g) of the Internal Revenue Code (the "IRC") for 2024 was \$23,000 and the maximum allowable catch-up contribution was \$7,500, for a total maximum contribution of \$30,500 for eligible participants. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

The Company's contributions to the Plan are as follows:

- a. Contributions to the Plan are made by the subsidiaries of the Company in amounts determined by the Board of Directors. Company contributions are allocated based on eligible compensation. Contributions to the Plan are made in the form of cash. Beginning in 2007, contributions can also be made as a discretionary match. There were no profit sharing or discretionary matching contributions made in 2024.
- b. The Company matches \$0.50 for each \$1.00 an employee defers on a pre-tax and/or Roth 401(k) post-tax basis up to the first 6% of eligible compensation. The matching contributions contributed to the Plan for 2024 were \$4,325,233.

The Plan allows elective 401(k), Roth 401(k), voluntary, and catch-up contributions. Participants are permitted to elect to defer a portion of current compensation to the allowable limit permitted by law.

Participant accounts

Records are maintained to account for the proportionate interest of each participant under the Plan. These records reflect both realized and unrealized investment gains and losses, as well as the investment income of, and contributions to, the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. A participant vests in the Company's contributions at the rate of 20% for each of the first four years of service and becomes 100% vested after completing the fifth year of service.

Notes receivable from participants

Participants can borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in the prior 12-month period. Loan terms range from one to five years, with longer terms available for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as of the last day of the prior quarter before the loan application is received plus 1%. Principal and interest are paid ratably through semi-monthly and/or weekly payroll deductions. A one-time fee of \$35 is charged to cover administrative costs and \$3.75 per quarter is charged from the participant's account while the loan is outstanding.

Payment of benefits

Distributions of amounts attributable to the participants' voluntary and elective contributions are made in cash.

Distributions of vested benefits attributable to Company contributions held in participant-directed accounts are also made in cash.

Upon termination of service, including death and/or disability, participants may elect to receive any amount of payment, as well as stop or change how their lump-sum payments are set up and receive any amount in a single sum or make any change to payment amount, structure or timing to the extent permitted by the IRC and the Plan.

Forfeited accounts

At December 31, 2024 and 2023, forfeitures were \$388,288 and \$223,526, respectively. Amounts not vested upon termination of employment are forfeited. The forfeited amounts are used to fund the Plan's administrative expenses and any remaining forfeitures shall be used to reduce any employer contributions. Forfeitures used for administrative expenses in 2024 amounted to \$24,412.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan is administered by a Board of Trustees who are appointed by the Board of Directors of the Company. Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees charged to the Plan are presented net of shared revenue credits received from the trustee. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Issued Accounting Standards Codification 820, *Fair Value Measurements*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money market fund and mutual funds

Valued at daily closing price as reported by the fund. Funds held by the Plan are an open-end money market fund and mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts and pooled separate accounts

The fair values of accumulation units held by the Plan in common collective trusts and pooled separate accounts are based on each account's daily NAV, which is considered by Plan management to be the best approximation of fair value. The NAV is based on the value of the underlying investments owned by each trust, minus its liabilities divided by the number of shares outstanding. Data for NAVs are distributed to Plan administrators and client investors and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 6 - Related party transactions and party-in-interest transactions

Certain members of the Board of Trustees of the Plan are also employees of the Company and may be participants in the Plan. They do not receive any fees associated with being members of the Board of Trustees of the Plan. Also, certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan.

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity Investments. Fidelity Management Trust Company, a subsidiary of Fidelity Investments, is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. During 2024, the Plan paid fees of \$2,407 to Fidelity Investments. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions.

Note 7 - Tax status

The Internal Revenue Service (the "IRS") has determined and informed the Company by a letter dated July 14, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties

The Plan's assets are invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
