Note 1 – Description of Plan

The following description of the Echo Maintenance 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan was effective January 1, 1998 and is a defined contribution plan covering all employees of Echo Maintenance, L.L.C., (the Company) and participating affiliates who have 1 year of service and have also attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, subject to a dollar limit which is set by law. Participants may also elect to make Roth 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company, at its discretion, may contribute an amount equal to 50% of participant contributions up to 6%, but no more than \$2,000. A discretionary profit sharing contribution may also be made, as determined by the employer. Participants direct the investment of all contributions into various investment options offered by the Plan.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments:** Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options for participants.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on number of years of active service. A participant is 100% vested after 5 years of credited service. Participants shall become fully vested upon death or total and permanent disability.

Note 1 – Description of Plan (Continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant may only have 1 loan outstanding at a time. The loans are secured by the balance in the participant's account and bears interest at rates determined by the administrator of the Plan. Principal and interest is paid monthly through payroll deductions. Interest income is recorded on the accrual basis. All loans are deemed collectable by management; therefore, no allowance for doubtful accounts has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable: At December 31, 2024, payables of \$228,275 are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Use of Estimates in the Preparation of Financial Statements: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Contributions: Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the plan administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Note 2 – Summary of Significant Accounting Policies (Continued)

**Investment Valuation and Income Recognition:** The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note 3 for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits:** Benefits are recorded when paid.

**Plan Expenses:** Employees of the Company perform certain administrative functions with no compensation from the Plan. Some administrative expenses are paid by the Company and are not reflected in the accompanying financial statements.

**Forfeited Accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,107 and \$9,459, respectively. Forfeited accounts may be used to pay administrative expenses and to reduce employer contributions.

**Date of Management's Review:** Subsequent events were evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

Level 1 – observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.

Level 2 – observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.

Level 3 – inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

Note 4 – Information Prepared and Certified by the Trustee

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by John Hancock Life Insurance Company (U.S.A.), the Trustee of the Plan, which included total investments as of December 31, 2024 and 2023, the total investment income for the years ended December 31, 2024 and 2023, and all information included in the supplemental schedule H, line 4i – schedule of assets (held at end of year).

Note 5 – Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8 – Tax Status

The Plan has adopted a non-standardized prototype plan and trust document sponsored by Nova 401(k) Associates, Inc. Nova 401(k) Associates, Inc., received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Department of the Treasury information returns are subject to examination, generally for three years after the filing date.

Note 9 – Reconciliation of Balances with Form 5500

The following excess contributions payable were refunded to certain participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan, which related to the Plan year ended December 31, 2024. This activity is not included in the Plan's Form 5500.
