NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the ATC Individual Account Pension Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan covering certain eligible classes of employees of ATC Management Inc. (the “Company”). Upon completion of 30 days of service with the Company, an employee is eligible to participate on the first day of the subsequent month. The Company sponsors and administers the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company’s Employee Benefits Committee is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

401(h) Account—The Plan includes a medical-benefit component in addition to the normal retirement benefits to fund a portion of the post-retirement obligations for retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code (IRC). A separate account has been established and maintained in the Plan for the net assets related to the medical-benefit component (“401(h) account”). The 401(h) account is held and managed by U.S. Bank N.A., who directs the account balance into the investment options it chooses. In accordance with IRC Section 401(h), the Plan’s investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. Plan participants do not contribute to the 401(h) account. Employer contributions or qualified transfers to the 401(h) account are at the discretion of the plan sponsor.

Contributions—The Company makes annual contributions to participants’ accounts that are currently based on an amount equal to 5% of an active participant’s eligible compensation. Company contributions are made to participant accounts on a bi-weekly basis.

Participants’ Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the Company contribution and an allocation of Plan earnings and charged with withdrawals, an allocation of Plan losses and administrative expenses. Allocations of Plan earnings/losses are based on participant earnings/losses on account balances, as defined. The maximum benefit to which a participant is entitled from the Plan is the benefit that can be provided from that participant’s account.

Vesting—Participants are immediately vested in the Company contributions plus actual earnings thereon. Therefore, there are no forfeitures under the Plan.

Payment of Benefits—On termination of service due to retirement, death, disability or termination of employment, a Plan participant may elect to receive a lump-sum distribution or installments equal to the vested interest in their account. Benefits may also be payable in the form of a qualified joint and at least 50% survivor annuity, if the participant is married, or a life annuity if the participant is unmarried. Effective December 1, 2022, partial withdrawals may also be elected.

Investment Elections—The participants may direct their account balance into a variety of different investment options. The Company currently offers a money market fund, a collective investment trust, various mutual funds, and participant-directed brokerage accounts as investment options for participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates—The preparation of financial statements in conformity with U.S. GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates.

Risks and Uncertainties—The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value at quoted market prices. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are accounted for on the trade date. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in the fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the period or the cost of the investment if purchased during the year.

401(h) Account—The Plan records the aggregate amount of net assets held in a 401(h) account related to health and welfare plan obligations for retirees as both assets and liabilities on the face of the statements of net assets available for benefits. Investment income, changes in the market value of investments and employer contributions to the 401(h) account are reported as changes to both assets and liabilities, with no activity reported in the statement of changes in net assets available for benefits. The ATC Management Inc. Health Care Plan is required to reflect the benefit obligations related to the 401(h) account.

Administrative Expenses— Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Benefit Payments—Distributions to participants are recorded when paid. There were no benefit payments requested and unprocessed as of December 31, 2024 and 2023.

Subsequent Events—Management has evaluated the impact of all subsequent events through September 23, 2025, the date the Plan’s financial statements were available to be issued and

determined that all subsequent events have been appropriately recognized and disclosed in the accompanying financial statements.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S TRUSTEES (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, and U.S. Bank N.A., trustee of the 401(h) account, have certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule H, part IV, line 4i – schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP for measuring, reporting, and disclosing fair value. These standards apply to all assets and liabilities that are measured, reported, and/or disclosed on a fair value basis.

As defined in the accounting standards, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Assets and liabilities measured, reported and/or disclosed at fair value will be classified and disclosed in one of the following three categories:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2 Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liabilities
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
- Level 3 Inputs to the valuation methodology that are unobservable and not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following are descriptions of the valuation methodologies used for investments measured at fair value:

Money market fund: Valued at the net asset value of the shares held by the Plan at year end.

Collective investment trust: Valued at the net asset value of the shares held by the Plan at year end.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end.

Participant-Directed Brokerage Accounts: The Plan's investments held in participant-directed brokerage accounts may include mutual funds, common stock, bonds, cash, money market funds, unit investment trusts and options. The fair values of mutual funds and money market funds are based on the quoted net asset values of the shares held by the Plan at year end. The fair values of common stock and unit investment trusts are based on quoted market prices. Cash is reported at carrying value which approximates fair value. The fair value of bonds for which quoted market prices are not available are valued based on yields currently available on comparable securities of issues with similar credit ratings. The fair value of options is based on cost; no value is given until options are exercised.

The plan sponsor is responsible for the determination of fair value. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are

appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial reporting instruments could result in a different fair value measurement at the reporting date.

5. ADMINISTRATION OF PLAN ASSETS

The Plan's assets are administered under a contract with Fidelity Management Trust Company and U.S. Bank, N.A., the trustees of the Plan. The trustees invest funds received from contributions, investment sales, interest, and dividend income and make distribution payments to participants.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in certain mutual funds, participant-directed brokerage accounts, a collective investment trust, and a money market portfolio managed by Fidelity Management Trust Company and U.S. Bank, N.A., trustees of the Plan. These are not considered prohibited transactions under ERISA. Fees paid by the Plan for investment management, recordkeeping and other operating expenses are with the trustee and are party-in-interest transactions. These fees are netted against investment income.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

8. FEDERAL TAX STATUS

The Plan is designed as a volume submitter money purchase pension plan and is maintained by Fidelity Management & Research Company, the volume submitter sponsor. The Plan has obtained a favorable determination letter from the Internal Revenue Service (IRS) dated September 26, 2022 stating that the Plan based on the information provided was deemed qualified under the Internal Revenue Code (IRC) Section 401 to be tax-exempt. The Plan has not been amended since receiving the determination letter, therefore plan management and the Company believe that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC, and that the Plan qualifies under Section 401 to be tax-exempt as of December 31, 2024.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The net assets of the 401(h) account included in Form 5500 are not available to pay Plan retirement benefits but can be used only to pay certain retiree health benefits and are thus excluded from the net

assets in the Plan’s financial statements. Such amounts are included in the Plan’s net assets as reported on the Form 5500.
