Opinion

Note 1 – Plan Description

The following description of Acme Mechanical Contractors of Virginia, Inc. Employee Stock Ownership Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Acme Mechanical Contractors of Virginia, Inc. (the “Company”), an S Corporation, established the Plan effective January 1, 2009, covering substantially all employees who have attained age 18 and have one year of credited service. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the *Internal Revenue Code* of 1986 (*IRC*), as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*), as amended.

The Plan has purchased Company stock utilizing Company contributions and proceeds from a note payable to the Company (Note 5). The stock is held in a trust established under the Plan. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities pertaining to:

- The accounts of employees with vested rights in allocated stock (Allocated), and
- Stock not yet allocated to employees (Unallocated).

Employees of the Company, with the exception of leased employees, union employees, and non-resident aliens, are generally eligible to become participants in the Plan upon the completion of 1,000 hours of service within a 12-month period. Eligible employees become participants of the Plan on the January 1 or July 1 entry date following the date on which the eligibility requirements are met.

Employer Contributions

Each year, the Company may make a discretionary contribution to the Plan as determined by the Board of Directors. Company contributions may be made in cash or in shares of Company stock. The Company is obligated to make sufficient annual contributions to enable the Plan to repay principal and interest as due on the Plan’s loan.

Participant Accounts

Upon the annual adjustment date, the account of a participant who is employed on the last day of the Plan year and credited with 1,000 hours of service during the Plan year, or who retired, died, or became disabled during the Plan year, will be credited with an allocation of Plan earnings, forfeitures, and employer contributions. Employer contributions are discretionary and will be determined each year by the Board of Directors and are allocated based on the proportion of each participant’s compensation to the total compensation of all eligible participants, as defined in the Plan document. Forfeited balances of terminated participants’ non-vested accounts are allocated based on the proportion of each participant’s compensation to the total compensation of all eligible participants, as defined in the Plan document. Plan earnings are allocated based on the proportion of each participant’s account balance to the total of all participant account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in a participant's account is based on years of service, as defined in the Plan document. A participant is 100% vested upon the completion of six years of service, the attainment of normal retirement age, or the occurrence of death or disability while employed by the Company.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary), or otherwise terminates employment with the Company. The normal form of distribution of a participant's vested account balance shall be equal annual installments over a period not to exceed five years. If the participant's vested account balance is equal to or less than \$1,000, their balance will automatically be distributed as a lump-sum payment. A participant may elect to receive any portion of their account attributable to Company stock, if any, distributed in such stock rather than cash or may elect to receive any combination thereof. Once these shares leave the Plan they are retired by the Company. Effective January 1, 2024, the Plan may distribute participant's vested account balances between \$1,000 and \$7,000 as automatic direct rollovers, in accordance with SECURE Act 2.0.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments, which are more diversified. Participants who have attained age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Such diversification distributions shall be either transferred to the participant directly or made as a rollover to an IRA or another eligible retirement plan.

Forfeitures

Forfeitures of terminated non-vested account balances, including cash and shares of stock, are generally reallocated to remaining participants' accounts in the Plan year in which the forfeiture occurred, as defined. At December 31, 2024 and

2023, there were no unallocated forfeited accounts. There were no forfeited amounts reallocated to participants' accounts for the year ended December 31, 2024.

Voting

Unallocated shares of Company stock owned by the Plan shall be voted by the Trustee in such manner as it shall determine. With respect to any corporate matter, which involves the voting of such shares at a stockholder meeting and which constitutes a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets of a trade or business or a similar transaction specified in the regulations under Section 409(e)(3) of the *IRC*, each participant will be entitled to give confidential instructions to the Trustee as to the voting rights attributable to the shares allocated to his or her account. In that event, any allocated Company stock with respect to which voting directions are not given by the participant shall be voted by the Trustee as the Trustee, in its sole discretion shall deem appropriate.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Interest-Bearing Cash

The Plan's cash consists of funds held in an interest-bearing money market account with a commercial bank. The account is insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, cash may exceed federally-insured limits.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 3 Fair Value Measurements

The fair value of the Acme Mechanical Contractors of Virginia, Inc. common stock is determined by independent appraisal. This appraisal was based upon income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, and return on equity, as well as applying a discount for the lack of marketability for non-publicly traded stock. Significant changes to these inputs could have resulted in a significantly higher or lower fair value measurement for the Company common stock. The following table provides further details of this Level 3 fair value measurement.

Note 5 – Loan Payable

In July of 2013, the ESOP acquired 140,000 shares of the Company's common stock for \$3,945,200. The acquisition of the shares was financed through a loan bearing an interest rate of 2.44% per annum, payable in sixty consecutive quarterly installments of \$78,717, maturing on July 26, 2028. The ESOP shares were pledged as collateral for the loan. As the debt is repaid, shares are released from collateral and allocated to active participants, based on the formula in the Plan agreement.

Note 6 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Tax Status

The *Internal Revenue Service* has determined and informed the Company by letter dated September 25, 2015, that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9 – Subsequent Events

Subsequent events have been evaluated through September 16, 2025, the date the financial statements were available to be issued.
