## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Tricon Residential 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). # **Tricon Residential 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023**

## **1. Description of Plan**

The following description of the Tricon Residential Plan 401(k) (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established effective January 1, 2017, as restated August 1, 2022. The Plan covers employees of TAH Operations, LLC and Tricon Holdings USA LLC (the "Company"), who have completed 30 days of service. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Effective January 1, 2018, the Company makes Safe Harbor matching contributions equal to 100% of the first 3% of compensation that participants contribute to the Plan, plus 50% of the amount a participant contributes between 3% and 5% of compensation. Safe Harbor matching contributions of \$3,008,436 were made to the Plan for the year ended December 31, 2024. Additional discretionary non-elective contributions may be contributed at the option of the Company. In order to receive a discretionary non-elective contribution, a participant must complete one thousand (1,000) hours of service and be employed on the last day of the Plan year. No discretionary non-elective contributions were made to the Plan during the year ended December 31, 2024.

### **Automatic Enrollment**

Plan provisions allow for automatic deferrals of 3% of the participant's compensation on a pre-tax basis. Effective August 1, 2022, the Plan was amended to increase automatic deferrals from 3% to 5% of the participant's compensation on a pre-tax basis. In addition, on an annual basis, each participant with a deemed elective deferral rate of less than 6% will have his or her elective deferral rate increased by 1% up to a maximum deemed elective deferral rate of 6%. Participants may elect to opt out of the automatic enrollment feature.

### **Notes Receivable from Participants**

The Plan does not permit participants to borrow from their fund accounts.

### **Vesting**

Participants are vested immediately in their contributions and the Company's Safe Harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary non-elective contributions are based on years of continuous service. A participant is 25% vested after one year of credited service and continues to vest in increments of 25% until 100% vested after four years of credited service.

### **Investments**

Each participant directs the allocation of his or her contribution and employer contributions to one or more of the available investment options. If no investment selection is made, the contributions are, by default, allocated to one of the target date funds available.

### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. A terminated participant that has a balance above a threshold as provided in the plan document has the option to maintain their balance in the Plan. In addition, the Plan allows for hardship distributions if certain criteria are met.

# **Tricon Residential 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023**

## **Forfeitures**

Amounts forfeited from terminating participants' nonvested portion of their Company discretionary contributions and earnings on Company discretionary contributions can be used to reduce future employer contributions or pay administrative expenses. During the year ended December 31, 2024, there were no forfeiture amounts used to reduce employer contributions or pay administrative expenses. There were forfeited nonvested accounts of \$540 and \$95 at December 31, 2024 and 2023, respectively.

## **2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in the following plan year.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan's management evaluated events that occurred after December 31, 2024 through September 22, 2025, the date when the financial statements were available to be issued. Based on this evaluation, the Plan has determined that no material subsequent events have occurred which require recognition or disclosure in these financial statements.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Fully Benefit-Responsive Investment Contracts**

The Plan holds an investment contract with Empower Annuity Insurance Company of America. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The investment contract held by the Plan is summarized as follows:

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

- Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
- Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

- An uncured violation of the Plan's investment guidelines;
- A breach of material obligation under the contract;
- A material misrepresentation; or,
- A material amendment to the agreement without the consent of the issuer.

**5. Information Certified by the Plan's Trustees**

ERISA Section 103(a)(3)(C) with respect to information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Plan's trustees (the "trustees"), except for comparing such information with the information reported in the financial statements. Based on information provided and certified by the trustees, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024 and 2023. Accordingly, the trustees of the Plan assets have certified to the completeness and accuracy of:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 as well as the supplemental schedule of assets (held at end of year) as of December 31, 2024.
- Net appreciation in fair value of investments and interest and dividend income reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, so that each participant received 100% of his or her account balance as of the date of termination.

**7. Tax Status**

The Plan document is a prototype non-standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 14, 2022, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designated and being operated in compliance with the applicable requirement of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. With few exceptions, the Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Related-Party and Party-in-Interest Transactions**

Certain plan investments are shares of guaranteed investment contracts managed by Empower Annuity Insurance Company of America or its wholly owned subsidiaries. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan pays administrative expenses to parties-in-interest who provide services to the Plan and for whom a statutory exemption exists.

**9. Reconciliation of Financial Statements to Form 5500**

The Form 5500 was prepared on the cash basis of accounting for the years ended December 31, 2024 and 2023. The following is a reconciliation of net assets available for benefits per the financial statements to the Form 5500.
