The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statement or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statement or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Infusion Upstate NY, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan, established as of January 1, 2014, is a defined contribution plan covering substantially all employees of InFusion Upstate NY, Inc. and its wholly owned subsidiaries and affiliates (the “Company” or the “Plan Sponsor”) who have attained the age of 21 and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was restated effective November 14, 2023 to align the plan document from the transition of the Plan’s trustee from Principal Trust Company to Empower Retirement Services. The transition took place on February 1, 2024.

Employees of the Plan Sponsor may participate in the Plan on the semi-annual date on or after meeting the eligibility requirements. The following classes of employees are excluded from eligibility:

- Union employees covered by a collective bargaining agreement which includes retirement benefits;
- Nonresident aliens with no income from a U.S. source;
- Leased employees, and;
- Residents of Puerto Rico.

Plan Amendments – The Plan was amended effective December 1, 2024, to allow two additional employers to adopt the Plan provisions effective January 1, 2025.

Contributions – Participants may elect to defer up to 100% of their annual compensation (as defined in the Plan), as pre-tax or Roth after-tax contributions, subject to Internal Revenue Code (the “Code”) limitations. Additionally, participants age 50 or older may also elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified plans (i.e., rollover contributions).

During the year ended December 31, 2024 and 2023, the Plan Sponsor made safe-harbor contributions to eligible participants equal to 3% of their compensation. Additionally, the Plan Sponsor may elect to make a discretionary profit sharing contribution to eligible participants. Discretionary profit sharing contributions totaled \$19,119 and \$33,545 for the years ended December 31, 2024 and 2023, respectively.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts – Individual trust fund accounts are established and maintained for each participant, illustrating the participant’s interest in the Plan. Each participant’s account is credited with the participant’s contributions, Plan Sponsor contributions and earnings on the participant-directed investments. Each participant’s account is charged with the participant’s distributions, losses and expenses on the participant-directed investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their salary deferral contributions, rollover contributions, Plan Sponsor safe-harbor contributions and actual earnings thereon. Vesting in Plan Sponsor discretionary profit sharing contributions and actual earnings thereon is based on years of service. Participants are 20% vested after two years of service and vest ratably at 20% per year thereon. Accordingly, participants are fully vested in discretionary profit sharing contributions after six years of service. Forfeitures resulting from non-vested contributions may be used to pay Plan expenses or in some cases, reduce Plan Sponsor contributions.

Payments of Benefits and Withdrawals – Participants may elect to withdraw their funds from the Plan upon death, disability, termination, retirement, or attaining age 59½. Benefit payments are typically made in the form of a lump-sum distribution. Hardship distributions are not permitted within the Plan.

Loans to Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their vested account balance, reduced by any outstanding loan balance, or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. A participant may have one loan outstanding in any 12-month period, and loans are repayable over a period of up to 5 years or a maximum of 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a rate of interest based on the prevailing interest rates for loans which would be made under similar conditions. Principal and interest is paid ratably through monthly payroll deductions. Delinquent loans from participants are recorded as a distribution based upon the terms of the Plan document.

Forfeitures – Forfeitures from non-vested Plan Sponsor contributions are used first to reduce the Plan’s administrative expenses and then allocated as additional matching contributions. There were no forfeitures for the year ended December 31, 2024. Forfeitures in the amount of \$8,371 were allocated to eligible Plan participants for the year ended December 31, 2023. Forfeitures were not used to pay administrative expenses during the year ended December 31, 2023.

1. Description of the Plan (continued)

Income Taxes – The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended subsequent to receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believe that the Plan is qualified.

2. Summary of Significant Accounting Policies

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA.

Basis of Accounting – The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Valuation of Investments – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan presents in the accompanying statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) in the fair value of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In the event of a default or death, the entire outstanding principal and accrued interest shall be immediately due and payable. Any unpaid balance will be deemed a taxable distribution from the Plan.

Benefit Payments – Benefits are recorded when paid.

Other Expenses – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to certain investment activity are paid by participants from their respective individual accounts.

2. Summary of Significant Accounting Policies (continued)

Party-in-Interest Transactions – Certain Plan investments are units of participation in pooled separate accounts and collective investment trusts that were managed by Principal Life Insurance Company and Principal Global Investors Trust Company (collectively “Principal”) and by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively “Empower”). Empower is the Plan trustee (the “Trustee”) as defined by the Plan document. Therefore, these transactions qualify as party-in-interest transactions.

Risks and Uncertainties – Investments are exposed to various risks, such as interest rate, credit and market risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Subsequent Events – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through September 24, 2025, the date the accompanying financial statements were available to be issued.

3. Information Certified by the Trustees’ (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees have certified that the investments and participant loans included in the accompanying financial statements and supplemental information are complete and accurate at December 31, 2024 and 2023.

Empower and Principal also certified interest and dividend income totaling \$106,675 and \$76,275, as well as net appreciation in fair value of investments totaling \$1,140,818 and \$1,374,919 for the years ended December 31, 2024 and 2023, respectively.

4. Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value of the Plan's assets. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There are no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Funds: Shares of money market funds are valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

Mutual Funds: Shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year end.

Collective Investment Trusts ("CITs"): CITs are valued daily based on the market value of the underlying assets. Fair value is determined by dividing the fair value of the CITs' net assets by the total number of units owned.

4. Fair Value Measurements (continued)

Collective Trust Funds (“CTFs”): CTFs are valued based on the NAV of shares held by the investment provider. Fair value is determined based on inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Fixed Annuities: Fixed annuities are valued daily based on the valuation method disclosed in the annuity contract.

Pooled Separate Accounts: The Plan has participant-directed investments held in pooled separate accounts. The fair value of these investments is based on inputs that are derived principally from or corroborated by observable market data by correlation or other means.
