We have performed audits of the financial statements of Northern Metal Products 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Northern Metal Products 401(k) Profit Sharing Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Northern Metal Products 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering employees of Northern Metal Products, Inc. and its wholly owned subsidiary Aubright, LLC (collectively the "Company") who have completed two months of service (three months of service prior to March 3, 2023). Plan entrance dates are the first of the month following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Board of Trustees (or equivalent) is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

#### **Contributions**

Participants may, after meeting eligibility requirements, contribute a portion of their compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. If the participant does not make an investment election, the contributions are invested in the Plan's default investment option. The Company will contribute for each participant that has completed a year of service with 1,000 or more hours, a safe harbor matching contribution equal to 100% up to the first 3% compensation contributed and 50% of the next 2% of compensation the employee contributes to the Plan through salary deferral, for a maximum of 4%. The Company also may make additional discretionary matching contributions, although for 2024 and 2023, no additional discretionary matching contributions were made. The Company's contributions are invested in the same manner as participant contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are fully vested in their voluntary, rollover, and safe harbor matching contributions at all times. Vesting in the Company's additional discretionary contribution portion of their account is based on years of continuous service. Participants begin to vest ratably in additional discretionary matching contributions after they complete a year of service and are fully vested at the end of five years of service.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Notes Receivable from Participants**

Eligible participants may borrow against the value of their accounts. The maximum amount of any loan is the lesser of 50% of the participant's vested account, or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The minimum amount of any loan is \$1,000 and the number of outstanding loans is limited to one. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate set by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, retirement (age 65 or age 55 with five years of vesting service), death, or disability, a participant may elect to receive a lump sum amount or partial payments equal to the value of his or her account. Upon termination of service, if the vested account balance is \$1,000 or less, the account balance will be distributed to the participant, who may elect to treat the distribution as a taxable withdrawal or directly roll over the balance into another qualified plan or individual retirement account. If the vested balance is greater than \$1,000, but less than \$7,000, the benefit payment will be rolled over into a qualified individual retirement account. Balances greater than \$7,000 may remain in the Plan. In service distributions are allowed for participants after obtaining age 59.5 or for amounts attributable to rollover contributions at any time, without restriction. Hardship distributions of elective deferrals are also permitted.

**Forfeitures**

Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's contributions to the Plan are used to offset plan expenses. As of December 31, 2024 and 2023, nonvested accounts totaled \$72 and \$2,224 respectively.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income (Loss) Recognition**

Investments are reflected at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued at the measurement date. The plan's administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income (Loss) Recognition (Continued)**

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded using the accrual basis of accounting. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded as of both December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Funding Policy**

Company discretionary matching contributions are generally remitted to the Plan at the same time as employee deferrals.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to benefit payments and administration of participant loans are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The plan administrator has evaluated subsequent events through September 16, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - CERTIFICATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: valued at net asset value (NAV) of units of the collective investment trust as of year-end. The NAV is used as a practical expedient to estimate fair value. The NAV, as determined by the issuer of the trust, is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 - TAX STATUS**

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since adoption of the prototype plan, however the plan administrators believe the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by affiliates of Fidelity Investments. Fidelity Management Trust Company is the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
