Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). Note 1—Description of Plan

The following description of the New Lexington Clinic, P.S.C. Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible employees of New Lexington Clinic, P.S.C. (the "Company" or "Plan Sponsor"), who have completed 3 months of services. Residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees and nonresident aliens, are not eligible to participate in the Plan. To participate in the employer non-elective safe harbor and discretionary profit sharing contributions, an employee must complete one year of service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Benefits Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Administration – The Company has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – The Plan is funded with employee pre-tax and after-tax Roth contributions and the Plan Sponsor's non-elective safe harbor and discretionary profit sharing contributions. Each year, participants may elect to contribute up to the maximum compensation permissible under the Internal Revenue Code ("IRC"). The Plan provides for an automatic pre-tax salary deferral percentage of 5% for all new participants unless they elect otherwise. If no investment elections are made by the participant, these contributions will be invested in accordance with guidelines established by the Plan's Benefits Committee. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan provides for an employer non-elective safe harbor contribution of not less than 3% of eligible participant compensation. The Plan also allows for additional profit sharing contributions at the discretion of the Plan Sponsor. For the years ended December 31, 2024 and 2023, the Plan Sponsor made a discretionary 2% profit sharing contribution to each eligible participant in the Plan. The Plan Sponsor also made a supplemental profit sharing contribution approximating \$2,698,000 and \$2,273,000 for the 2024 and 2023 Plan years, respectively, allocated based on the provisions of the Plan agreement. Contributions are subject to certain limitations.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, as well as allocations of Company non-elective safe harbor and discretionary profit sharing contributions, Company supplemental profit sharing contribution, and Plan earnings (losses). Participant accounts are charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – The Plan's Benefits Committee is the named fiduciary for purposes of ERISA and has the general authority to direct the investment, reinvestment and disposition of Plan assets. Subject to the authority of the Benefits Committee, individual participants in the Plan may elect to self-direct his or her Plan accounts among the investment funds offered by the Plan including a self-directed portfolio option (brokerage account) available through Fidelity Management Trust Company ("Fidelity"), the Plan trustee.

Note 1—Description of Plan (continued)

Vesting – Participants are immediately vested in their contributions and Company non-elective safe harbor contributions, plus actual earnings thereon. Vesting in Company discretionary profit sharing and supplemental profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of credited service and vest 20% for each additional year of credited service until the employee reaches 100% vesting after six years of credited service. The Plan provides for 100% vesting for any participant whose termination is attributable to death, normal retirement, or permanent disability.

Notes Receivable from Participants – Participants may borrow from their individual fund balances. Participant loans can be for any purpose, classified as either a general purpose or residential purpose loan (as defined in the Plan agreement), and are limited to the lesser of \$50,000 or 50% of the vested portion of the participant's account balance. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a participant's principal residence, the Plan agreement permits a longer term with a limit of 10 years. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is repaid ratably through payroll deductions.

Payment of Benefits – Upon termination of service or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, annual installments over a predetermined period of time, and direct rollover into a qualified plan or individual retirement account. In-service and hardship withdrawals are also allowed as defined in the Plan agreement.

Forfeited Accounts – The nonvested portion of former participants' accounts attributable to Company discretionary profit sharing contributions and Company supplemental profit sharing contributions may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contributions. Forfeited accounts totaled \$2,976 and \$40,799 at December 31, 2024 and 2023, respectively. Forfeitures approximating \$151,000 and \$38,000 were used to reduce the amount of employer contributions allocated to Plan participants for the Plan years ended December 31, 2024 and 2023, respectively.

ERISA Account – The Company has entered into an agreement with Fidelity to create a Plan expense account ("ERISA Account") to hold revenue sharing funds the Plan receives from Fidelity pursuant to an agreement. These funds are available to pay qualified Plan administrative expenses or may be reallocated to Plan participants. The amount credited to the ERISA Account is determined on an annual basis by Fidelity and is reported as a reduction of "administrative fees" in the statements of changes in net assets available for benefits. At December 31, 2024 and 2023, the ERISA Account balance was \$386 and \$19,444, respectively. For the Plan years ended December 31, 2024 and 2023, the amount used to pay Plan expenses in accordance with this agreement approximated \$86,000 and \$72,000, respectively.

Note 2—Summary of significant accounting policies

Basis of Presentation – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Investment Management Fees and Operating Expenses – Investment management fees and operating expenses charged to the Plan for certain investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

Administrative Expenses – The Company is not obligated to pay administrative expenses of the Plan but has elected to pay for a portion of these expenses. The Plan also has an ERISA Account (see Note 1) to offset certain administrative expenses.

Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of Department of Labor's Rules and Regulations for Reporting and Disclosure under. Accordingly, Fidelity, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4—Fair value measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are therefore classified within Level 1 of the valuation hierarchy.

Self-directed Brokerage Accounts – Accounts consist primarily of cash equivalents, mutual funds, common and preferred stocks, and government and corporate debt securities. Cash equivalents are valued at cost which approximates fair value and are classified within Level 1 of the fair value hierarchy. Mutual funds and common and preferred stocks are valued at quoted market prices and are classified within Level 1 of the fair value hierarchy. Government and corporate debt securities are valued at either the closing price reported in the active market in which the security is traded or valued based on yields currently available on comparable securities of issuers with similar credit ratings. Government and corporate debt securities are classified within Level 2 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Related party and party-in-interest transactions

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest. It invests in mutual funds and self-directed brokerage accounts managed by an affiliate of Fidelity, the trustee of the Plan. The Plan paid fees to Fidelity affiliates totaling \$65,553 and \$62,740 during the Plan years ended December 31, 2024 and 2023, respectively. Notes receivable from participants and related activity also qualify as party-in-interest transactions.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7—Income tax status

The Internal Revenue Service ("IRS") ruled on June 30, 2020, that the non-standardized pre-approved plan of FMR LLC, upon which the Plan is based, is designed, in accordance with applicable requirements of the IRC. The Plan has been amended since receipt of the opinion letter. However, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the financial statements.

Note 9—Subsequent events

The Plan has evaluated all subsequent events through September 15, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
