Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

The following description of the Walsh Gallegos 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, which covers eligible employees of Walsh Gallegos Trevino Russo & Kyle P.C. (the Sponsor) who are at least 21 years old. Employees who have attained one year and 1,000 hours of service are eligible to receive matching and profit-sharing contributions. There are no minimum service requirements in order to make salary deferrals and receive safe harbor employer contributions. Eligible employees are permitted to enroll in the Plan on the following dates: January 1, April 1, July 1 and October 1. The Plan was established effective September 1, 1985, and amended and restated effective January 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may elect to contribute up to 90% of annual compensation, as defined in the Plan, through payroll deductions, subject to the annual dollar limitation under Internal Revenue Code (IRC) Section 402(g). Participants who are age 50 or older may also make catch-up contributions in accordance with IRC Section 414(v). In addition, participants may make rollover contributions to the Plan, including pre-tax or Roth rollovers from other eligible retirement plans or traditional IRAs, even if not yet otherwise eligible to participate in the Plan.

The Plan includes an automatic deferral provision. Upon meeting eligibility requirements, employees are automatically enrolled at a deferral rate of 5% of compensation, unless they affirmatively opt out or elect a different rate. These deferrals are treated as pre-tax elective contributions unless otherwise elected by the participant. Participants may modify or revoke their deferral elections at any time during the Plan year. The Plan permits both pre-tax elective deferrals and Roth elective deferrals. Participants may designate all or a portion of their elective deferrals as Roth contributions, which are made on an after-tax basis.

The Plan is intended to satisfy the requirements of a safe harbor 401(k) plan under IRC Section 401(k)(12). As such, the Sponsor makes nonelective safe harbor contributions equal to 3% of compensation to all eligible employees, regardless of whether the employee makes elective deferrals. For the year ended December 31, 2024, the Sponsor made safe harbor contributions of \$358,255.

The Sponsor may also make discretionary employer contributions, including matching and/or profit-sharing contributions, subject to the terms of the Plan. For 2024, the Sponsor made profit-sharing contributions of \$416,880 to eligible participants. Matching contributions, if made, are determined at the discretion of the Sponsor, and may be allocated as a fixed dollar amount or a percentage of participant contributions. All employer contributions, including safe harbor, matching, and profit-sharing, are made in accordance with the eligibility and allocation provisions set forth in the Plan document.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and net earnings of the participant's individual account. Participant accounts are charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants direct the investment of their entire interest in the Plan. Participants may modify elections, transfer existing balances, and obtain information regarding investments on a daily basis.

Vesting: Participants are vested immediately in their employee contributions, including catch-up and Roth contributions, rollovers and safe harbor contributions, plus actual earnings thereon. Vesting in the discretionary employer match and profit-sharing contributions are based on each employee's length of service. A participant is 100% vested after six years of credited service.

Forfeitures: When participants separate from service, any amounts that are not vested will be forfeited. Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan.

Notes Receivable from Participants: Participants may borrow from their account under the loan provisions of the Plan. Loans are available to all eligible participants and must be a minimum of \$500. The maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the highest outstanding loan balance during the prior 12 months.

A participant may have no more than two loans outstanding at any time. Loans are secured by the participant's vested account balance and bear interest at a rate of prime plus 2%, determined at the time of loan origination. Repayments are generally made through payroll deduction, and participants may prepay their loan balance by check without penalty. The loan repayment period may not exceed five years, unless the loan is used to purchase a primary residence, in which case the repayment period may extend up to 20 years. Interest income on participant loans is recorded on an accrual basis.

Payment of Benefits: Participants who terminate employment at normal retirement age (age 65 or 5th anniversary joining the Plan, if later), disability, or death, are entitled to receive 100% of the amounts in their Plan accounts as of the day benefits are paid. If a participant terminates employment for any other reason before normal retirement age, the participant is entitled to 100% of their account's vested balance. Upon separation from service, death, or disability, Plan benefits will be paid in the form of a lump sum. If the amount of the payout is more than \$5,000 and the participant has not reached normal retirement age, died, or consented to distribution, the payment will be deferred to the earliest date administratively feasible following attainment of normal retirement age, death, or consent to distribution.

Participants may receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. Hardship distributions are also available to participants who demonstrate certain immediate and heavy financial needs. Such hardship withdrawals are limited to fully vested account balances and are only available to participants who are actively employed at the time of the request.

Administrative Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Sponsor. Expenses relating to specific participant transactions (i.e. loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net depreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement date and recent transaction prices. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in a single, open-ended mutual fund. The underlying investment composition of the pooled separate accounts as of December 31, 2024 and 2023, was approximately 16% and 14% target date mutual funds, 79% US equity index funds and 5% and 7% fixed income securities funds, respectively. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

NOTE 5 – INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by NOVA 401K Associates Inc. The pre-approved profit-sharing plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved profit-sharing plan, as then designed, was acceptable under section 401 of the IRC for use by the employer for the benefits of its employees. Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor. John Hancock Life Insurance Company is a service provider to the Plan, and, therefore, the Plan's payment of fees to the service provider qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.
