Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Delta Dental of Rhode Island 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Delta Dental of Rhode Island 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and profit sharing plan covering substantially all employees of Delta Dental of Rhode Island and subsidiaries (Altus Systems, Inc., Altus Dental Insurance Company, Inc. and First Circle, Inc.) (collectively, the "Company" or "Plan Sponsor"), who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Company and the assets of the Plan are held and invested by Voya Retirement Insurance and Annuity Company (the "Custodian").

Eligibility

Employees who are 21 years of age and have completed three months of service, as defined by the Plan, are eligible to participate and are automatically entered into the Plan, through automatic enrollment, on the first day of the Plan year, or the first day of the month of the Plan year after the employee has met the eligibility requirements. Employees meeting eligibility requirements will be automatically enrolled at a 6% deferral rate unless the participant makes an affirmative election otherwise. The employee has ninety days to opt out of the Plan by signing a waiver form.

Contributions

Each year, participants may elect to have a percentage deducted on a pre-tax or Roth basis from their compensation, as defined by the Plan. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Service ("IRS") and adjusted annually.

Under the terms of the Plan, the Company has the option of making both matching contributions and profit sharing contributions. The Plan Sponsor can offer discretionary employer matching contributions in addition to the matching contributions provided for by the Plan. Profit sharing contributions are discretionary. During the year ended December 31, 2024 the Plan Sponsor made a discretionary profit sharing contribution of \$1,019,810.

1. Description of Plan (*continued*)

Safe Harbor Election

The Plan provides for a qualified automatic contribution arrangement safe harbor election for employer contributions. Under the safe harbor, the employer makes matching contributions in an amount equal to 100% of an employee's contributions that do not exceed 1% of eligible compensation, plus 50% of the portion of the employee contribution between 1% and 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and allocations of Plan earnings / losses thereon. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

ERISA Expense Account

The Plan utilizes an ERISA expense account. Such account accumulates revenue share income from plan investment holdings. The Plan has opted to receive this revenue share and pay plan expenses from monies accumulated in the ERISA expense account. Any accumulation of funds retained by the Plan in this account at year-end is to be allocated evenly among the Plan participants in the following plan year. The balance in the ERISA expense account at December 31, 2024 and 2023 is \$11,488 and \$42,057. The amount allocated from the account to participants in the Plan for the year ended December 31, 2024 was \$42,057.

Vesting

Participants are immediately vested in their pretax savings contributions and any amounts rolled over or transferred into the Plan. Vesting for employer contributions, if any, and associated earnings is based on years of continuous service. A participant's account attributable to the employer matching amounts becomes 100% vested after two years of credited service as required by the safe harbor utilized by the Plan. A participant's account attributable to profit sharing contributions becomes vested in 20% increments starting after two years of credited service and becomes 100% vested after six years as defined in the Plan document.

Investment Options

Participants must direct their salary deferral contributions to various investment options offered by the Plan. Participants may change their investment options at any time throughout the year.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

If a participant reaches age 60 while still employed by the Company and has completed five years of vesting service, that participant may elect to receive all or a portion of his or her account. In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. At any time, a participant may also elect to receive all or a portion of his or her rollover contributions. Terminated participants with vested account balances greater than \$5,000 can maintain their account in the Plan or receive a lump sum distribution. The Plan has an involuntary cash-out amount with respect to terminated participants up to \$5,000, with automatic rollover to an IRA if the vested account is more than \$1,000 (but not more than \$5,000) and the participant fails to make a timely election regarding the distribution.

Notes Receivable from Participants

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Only one loan may be outstanding at any given time. Principal and interest payments on an outstanding loan are paid in level payments through bi-weekly payroll deductions. A default in a participant's loan is treated as a distribution at the time of default against the participant's account.

The Plan's loan policy allows for a participant (borrower) enrolled in the Plan to borrow a minimum amount of \$1,000 up to a maximum of 50% of his or her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from the Custodian. Each loan shall bear interest at the prime rate in effect at the time of its issuance. The loan must be repaid directly to the Custodian within a five year period, unless such loan is used to acquire a principal residence of the borrower.

Forfeitures

Upon a participant's termination, any nonvested portion of the Company's matching and profit sharing contribution is forfeited. Forfeited amounts can be used for payment of reasonable expenses in addition to being used to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$89,152 and \$105,611. The Plan used \$173,929 of nonvested forfeitures to reduce employer contributions for the year ended December 31, 2024. Subsequent to December 31, 2024, the plan used \$81,102 of nonvested forfeitures to reduce the profit sharing contribution remitted to the plan related to the employer contribution receivable at December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan’s investments, that were valued at fair value, were valued using level 2 inputs.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the Voya Fixed Account, which is stated at contract value. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts using level 2 inputs. The Voya Fixed Account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management of the Plan Sponsor has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 12, 2025.

3. Certified Investments

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution.

4. Voya Fixed Account

The Voya Fixed Account (the "Account") is a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company ("Voya"). The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant's account daily yields the then current credited rate. Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds out of this investment option. Withdrawals from the Account for other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

4. Voya Fixed Account (*continued*)

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A2 as of September 2024), Standard and Poor's (A+ as of September 2024), and Fitch (A+ as of September 2024).

5. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The Company has adopted a prototype profit sharing plan. The IRS has issued a letter, dated June 30, 2020, which stipulates that an employer who adopts this prototype plan will be considered to have a plan qualified under Section 401(a) of the Internal Revenue Code provided all terms of the Plan are followed. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the date of the auditors' report.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

All of the Plan's investments are managed by the Custodian. These transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, affected participants will become 100% vested in their accounts.



