Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Yeled v'Yalda E.C.C., Inc. Employees 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of the Yeled v'Yalda E.C.C., Inc. Employees 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document, which is available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Plan was effective January 1, 2008 and is a contributory-defined contribution plan sponsored by Yeled v'Yalda E.C.C. (the Sponsor) for the benefit of all eligible employees of Yeled v'Yalda E.C.C., Inc. Employees of the Sponsor are considered eligible for the Plan as long as any percentage of his or her compensation is paid through, or is allocated to, the Federal Head Start Program, Early Head Start Program, or a Federal Head Start/Early Head Start Partnership Grant, excluding leased employees, employees covered by the terms of a collective bargaining agreement, employees classified as substitutes or consultants, and highly compensated employees. Effective January 1, 2019, employees classified as hourly paid are not eligible, unless they were already participating in the Plan as of this date. Effective January 1, 2023, the Plan was amended to remove the employees "who are customarily employed less than 20 hours per week" qualification from the list items that render an employee ineligible for the Plan. Employees are eligible to participate in the Plan on the first day of the month following one year of employment with the Sponsor. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Nationwide Trust Company, FSB is the custodian of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Sponsor make annual contributions as defined in the Plan Document. The Sponsor makes matching contributions of 25% of employee elective deferrals, not to exceed 3% of an employee's total compensation. Sponsor profit-sharing contributions are discretionary as determined by the Sponsor's Board of Directors. Contributions are subject to certain limitations.

The Sponsor may make a discretionary contribution to eligible participants. In 2024 and 2023, the Sponsor made a 2% discretionary contribution. Discretionary contributions totaled \$412,797 and \$368,736 for the years ended December 31, 2024 and 2023, respectively.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service.

Notes Receivable from Participants

Participants may not borrow from their fund accounts under the Plan.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or participant's beneficiary may elect to receive a lump-sum amount equal to the value of the vested interest in their account or annual installments over a period to be determined by the participant or the participant's beneficiary.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$16, respectively. These accounts will be used to reduce future employer contributions. Also, employer contributions were reduced by \$11,883 and \$15,630 in 2024 and 2023, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor of the Plan or the Plan, at the Sponsor's discretion.

Note 3. Certifications of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB (Nationwide), a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Nationwide is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment. Fees of \$63,864 and \$70,606 were paid to Nationwide for the years ended December 31, 2024 and 2023, respectively. The Sponsor provides certain administrative services at no cost to the Plan and pays certain administrative costs on behalf of the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities held by the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a volume submitter profit sharing plan with CODA document sponsored by FIS Business Systems LLC. This prototype Plan Document has been filed with the appropriate agency and has obtained a favorable opinion letter dated June 30, 2020 from the IRS that the prototype plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan has been amended since issuance of the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

In July 2025, the Plan was amended to update the definition of eligible compensation, effective January 1, 2025.
