Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Corcoran Companies Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Corcoran Companies Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Note 1 – Description of the Plan

The following brief description of the Corcoran Companies Profit Sharing Plan (the “Plan”) is provided for general information purposes only. More complete information is provided within the Plan documents.

General

The Plan is a contributory, defined contribution plan sponsored by Corcoran Management Company, Inc. (the “Sponsor”), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established effective January 1, 1981 and has been amended and restated to comply with regulatory requirements. The Sponsor is the Plan Administrator (“Administrator”). The Administrator has sole authority to control and manage the operation and administration of the Plan, subject to the terms and provisions of the Plan.

Participants may elect to invest contributions in any combination of registered investment companies, a common collective trust, and self-directed brokerage accounts offered by the Plan through Fidelity Management Trust Company (“Fidelity” or the “Trustee”).

Eligibility

The Plan covers all employees who have completed three months of service, as defined under the Plan, at the Sponsor or its affiliates, Corcoran Administration Company and John M. Corcoran and Co. Services, Inc. (“Affiliates”).

Contributions

Each participant may elect to contribute a percentage of his or her eligible compensation, as defined in the Plan, subject to certain limits and provisions of the Internal Revenue Service (“IRS”) regulations. Participants’ contributions are not subject to Federal or State income tax. Participants who are projected to be age 50 or older by the end of the calendar year may also make catch-up contributions. Rollover contributions from other qualified plans are permitted.

Employer contributions

The Plan provides for a safe harbor matching employer contribution equal to 100% of the first 3% of the employee’s contribution and 50% of the next 2% contributed by the employee to the Plan.

Discretionary contributions

The Sponsor may make discretionary contributions in an amount to be determined annually by the Board of Directors. There were no discretionary contributions in 2024. In addition, the Sponsor may make qualified nonelective contributions to satisfy certain IRS tests.

Participant accounts

Each participant’s account is credited with the employee’s contribution and an allocation of Sponsor contributions and Plan earnings. Allocations are based on employee earnings or account balances, as defined. The benefit to which an employee is entitled is the benefit that can be provided from the employee’s vested account.

Distributions

Upon termination of employment for any reason, including retirement, a participant's vested account is generally distributed either in a single lump-sum payment or in installments over a period of time. Participants who are still employed may withdraw their vested accounts upon attaining age 59-1/2. If the termination is before the normal or early retirement dates and is for a reason other than death or disability and the vested balance is \$1,000 or less, the entire balance will be distributed. For retired participants, the latest commencement date for distributions is April 1 of the calendar year following the year in which the participant attains age 73. A participant may request withdrawal from their account in the case of hardship as defined in the Plan document.

Notes receivable from participants

A participant may borrow from the Plan a minimum amount of \$1,000 and a maximum amount equal to the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Participants who borrow are responsible for the administrative expense of processing the loan.

A participant may have only one loan outstanding at any time. The term of the loan may not exceed five years unless the loan is for the purchase of a principal residence in which case a 10-year term may be used. Repayment is made through regular payroll deductions of principal plus interest at the rate charged at the time of the loan by regional banks for similar loans. At December 31, 2024, the interest rate ranged from 4.25% to 9.50% and maturities through November 2031. Outstanding loan balances are due and payable immediately upon termination of employment.

Vesting

All participants are 100% vested in their deferral contributions, amounts rolled over or transferred into the Plan, safe harbor matching employer contributions, and qualified nonelective employer contributions. The vesting percentage rates with respect to the employer nonelective contributions are as follows:

In addition, participants become fully vested upon normal retirement age, total or permanent disability or death while in the employ of the Sponsor or Affiliates.

Forfeitures of nonvested balances of terminated employees are used first to pay administrative expenses, any remaining amounts are used to reduce employer contributions payable under the Plan. At December 31, 2024, forfeited non-vested accounts totaled \$14,636. The Plan used \$13,212 of forfeited non-vested accounts to pay administrative expenses for the year ended December 31, 2024.

Plan expenses

Certain costs of plan administration are absorbed by the Sponsor.

Note 2 – Summary of significant accounting policies

Method of accounting

The Plan maintains its accounting records and prepares its financial statements and supplemental schedule on the accrual basis.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See discussion under *Fair Value Measurements* for a description of valuation methodologies used.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Fair value measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The classification of a fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These levels include:

Level 1 – observable inputs such as quoted prices in active markets for identical assets and liabilities;

Level 2 – observable inputs such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, other inputs that are observable or can be corroborated by observable market data; and

Level 3 – unobservable inputs for which there are little or no market data, which require the reporting entity to develop its own assumptions.

The following is a description of the valuation methodologies used for the Plan's investments; there have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies

These investments are public investment vehicles valued using the Net Asset Value (NAV). The NAV is a quoted price in an active market.

Common/collective trust

The investment is a public investment vehicle valued using the NAV provided by the administrator of the fund as a practical expedient. The NAV is based on the fair value of the underlying investments held by the fund. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The investment seeks to preserve principal while earning a level of interest income consistent with principal preservation by investing in a portfolio comprising of primarily investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds.

Self-directed brokerage accounts

These investments are comprised of money market and mutual funds. Money market and mutual funds are valued at the NAV of shares held by the Plan at year-end.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan documents.

Allocations to participants' accounts

Individual accounts are maintained for each participant, which are separated into the various investment fund components and a participant loan component, if the participant has an outstanding loan. Separate accounts are also maintained for rollover, matching and discretionary profit-sharing contributions.

Income for each fund is allocated to each participant's account monthly in proportion to each participant's account balance. The income allocation is based on the actual monthly yield for the Plan.

Payment of benefits

Benefits are recorded when paid.

Accounting estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Accordingly, actual results may differ from these estimates.

Note 3 – Plan termination

Although the Sponsor and Affiliates have not expressed any intent to do so, they may terminate the Plan at any time, subject to the provisions of ERISA. If the Plan is terminated, all participants would become 100% vested in the employer matching and discretionary contributions.

Note 5 – Tax status

The Plan received a determination letter from the Internal Revenue Service ("IRS") dated March 31, 2008, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRS. The Plan operates under a prototype plan sponsored by Fidelity (FMR, LLC). The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the IRS. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Accordingly, no provision has been made for federal income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s tax returns for tax years beginning 2021 through 2024 may be subject to examinations by the Department of Labor and the Internal Revenue Service.

Note 6 – Parties in interest

Affiliates of the trustee manage investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with the recordkeeping services qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. However, these transactions are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for the investment management services are netted against net appreciation (depreciation) in fair value of investments.

Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Note 9 – Subsequent events

The Plan has evaluated subsequent events and transactions through July 28, 2025, the date the financial statements were available to be issued. There were no events or transactions that occurred that would require recognition or disclosure in the financial statements.
