Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Years ended December 31, 2024 and 2023

Note A - Description of the Plan

The following description of the Beacon Mutual Insurance Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering substantially all employees of the Beacon Mutual Insurance Company (the Company, Employer, or Plan Sponsor) who have met certain requirements as to age and length of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is John Hancock Trust Company LLC. The Company restated the Plan effective as of January 1, 2022.

Eligibility

All employees of the Company, including full-time, part-time, and temporary employees on the Company's payroll are eligible to participate in the Plan. The only employees that are excluded from participating include leased employees, employees covered by a collective bargaining agreement, individuals classified by the Company as independent contractors, and employees younger than age 18. Eligible employees may begin participating on the first day of the month coincident with or next following their hire date.

Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. In addition, the Plan also includes an automatic escalation provision whereby participants deferral percentage will automatically increase by 1% each year until it reaches 12%.

Participants may contribute up to 100% of pre-tax annual eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches 50% of the participant pre-tax and after-tax contributions, up to 6% of base eligible compensation, as defined in the Plan, on a biweekly basis. Additionally, the Company made a core contribution equal to 7% of the eligible participant's compensation for 2024 and 2023, which is allocated to the participant's account for the Plan year. A participant must be employed on the last day of the Plan year to be eligible, unless employment ended during the plan year due to attaining the age of 65 or older, death or total and permanent disability.

Notes to Financial Statements (Continued)

Note A - Description of the Plan (Continued)

Contributions (Continued)

In addition, the Company may also make additional discretionary contributions to the Plan, on an annual basis. These employer contributions, if any, will be allocated, as of the last day of each Plan year, to each participant's account, if they are employed on the last day of the Plan year, unless employment ended during the plan year due to attaining the age of 65 or older, death, or total and permanent disability, on a pro-rata ratio based on the participant's total eligible compensation in relation to the total eligible compensation of all participants. The Company made discretionary contributions equal to 3% of the eligible participant's compensation for 2024 and 2023, which is allocated to the participant's account for the Plan year.

The Plan also permits participants receiving distributions from other qualified plans to rollover such distributions into the Plan.

Employee and the related employer matching contributions are recorded in the period the employee contribution is withheld by the Plan Sponsor.

Employer contributions receivable include core and discretionary contributions, as well as matching contribution adjustments owed to the Plan by the Company at plan year end, reduced by applicable forfeitures, as outlined in the plan document. These receivables are paid to the Plan during the first quarter following the plan year end.

Participant accounts

Each eligible participant's account is credited with the participant's contributions and (a) the Company's matching contribution, (b) the core contribution, (c) an allocation of additional discretionary employer contributions, and (d) net investment earnings. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Plan participants are 100% vested at all times in the account value of their voluntary contributions plus actual earnings/losses thereon. In addition, participants vest in employer matching, core, and discretionary contributions plus actual earnings/losses thereon as follows:

Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is fixed and will be equal to the Prime Rate (as published in The Wall Street Journal on the day the loan is initiated), plus 1%. Participants may only have one loan outstanding at any given time. Participants may exceed the limit of one loan if and only if they had an outstanding loan before January 1, 2019. Principal and interest is paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Forfeitures

Forfeited non-vested accounts are used to reduce future Company contributions and pay Plan expenses. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$13,249 and \$22,880, respectively, were used to reduce employer contributions and pay Plan expenses. Forfeited non-vested accounts available at December 31, 2024 and 2023 were approximately \$38,142 and \$13,249, respectively.

Benefits

On retirement or other termination of service, participants with a vested account balance of \$1,000 or less will be paid out in a single sum payment as soon as administratively possible, unless elected otherwise. Participants with a vested account balance greater than \$1,000, but less than \$5,000 will be rolled over to an individual retirement account (IRA) selected by the Plan Sponsor. For participants with vested account balances that exceed \$5,000, participants can select to leave the funds in the Plan until minimum distribution rules apply, take a single-sum cash payment, or receive annual or more frequent installments over a period as limited under the Plan. In addition, a participant may withdraw vested funds, subject to Plan restrictions, in the event of a financial hardship. Distributions are subject to the applicable provisions of the Plan agreement. A hardship withdrawal may not exceed the amount of the immediate and heavy financial need of the participant, and the Plan Sponsor may rely on the participant's representation of a financial hardship unless the Plan Sponsor has knowledge to the contrary.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0) became law. SECURE 2.0 makes various changes applicable to tax qualified retirement plans. Plan management is evaluating the impact of SECURE 2.0 and awaiting additional regulatory guidance from the IRS and the Department of Labor. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

Note B - Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

Investment management, plan administration, record keeping and investment advisory fees are paid by the Plan. Revenue credits are used to offset these fees. All other expenses are paid by the Company.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements and notes.

Note C - Investment Certification

The Plan Sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, John Hancock Trust Company LLC, the trustee of the Plan, has certified the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, the notes to the financial statements, and the accompanying Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability, or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note D - Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Collective Trust Funds:** The funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily, and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan invests in a stable value common collective trust (CCT), whose trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals. The Plan may be required to provide 12 months advance written notice for the stable value fund CCT to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

Note E - Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated August 9, 2022, that the Plan is qualified under the Internal Revenue Code (IRC) and therefore the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor has concluded there are no uncertain tax positions as of December 31, 2024 and 2023 in accordance with GAAP.

Note F - Related Party Transactions and Party-in-interest Transactions

Related party transactions consist of loans to participants of the Plan. Fees are paid to the trustee and to the Plan's investment advisors, WELLth Advisory Services, LLC and John Hancock Personal Financial Services, LLC. Administrative fees paid by the Plan were \$40,118 and \$34,544 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor directly pays certain other fees related to the Plan's operations. Additionally, personnel and facilities of the Plan Sponsor have been used to perform administrative functions for the Plan at no charge to the Plan.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
