Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Orbis 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Orbis 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by the trustees of the plan, that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the trustees in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Life Insurance Company, (a qualified institution) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in "Note 5 – Certified Investments" to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Orbis 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS
Orbis 401(k) Retirement Plan

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Orbis 401(k) Retirement Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

- A. "General". The plan is a defined contribution plan covering all employees of Orbis, Inc. ("Company") regardless of years of service and age. The Plan is subject to the provisions of ERISA.
- B. "Contributions". Each year, participants may contribute up to the maximum amount allowed by law of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans.
- C. "Participant Accounts". Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. "Vesting". Participants are vested immediately in their contributions plus actual earnings thereon. Participants are 100 percent vested in the Company's contribution portion of their accounts upon entering the plan.
- E. "Payment of Benefits". On termination of service, a participant's benefits are distributed in a lump sum payment as soon as administratively possible or within specific periods defined in the plan agreement. Distribution of a participant's account with a balance exceeding \$1,000 requires the participant's consent.
- F. "Participant Directed Investments". The Plan permits a participant to direct the investment of the participant's account in any of the Plan's investment options. All Plan investments were participant directed in 2024 and 2023.
- G. "Participant Loans". Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at commercially reasonable rates, as determined by the plan administrator, which ranged from 3.25% to 8.50% in 2024. Principal and interest are paid ratably through semi-monthly payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants – Loans to participants are reported at their unpaid principal balances. The loans are collateralized by the respective participant accounts and the note payments are withheld by the Company from the respective participant wages. In the event of default, foreclosure on the note and attachment of the security occurs when a distributable event occurs in the Plan, subject to the suspension of payments permitted by Internal Revenue code 414(u)(4). The plan administrator evaluates the collectability of the loans based on the status of the note payments, the employment status of the participants, and the fair value of investment collateral. The plan administrator has determined that no allowance for credit losses was necessary as of December 31, 2024 and 2023.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Fair Value Measurements – Accounting principles generally accepted in the United States of America establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs generally are indirect information such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active. Level 3 inputs are the most subjective and are generally based on an entity's own assumptions on how knowledgeable parties would price assets using the best available information.

Level 1 Fair Value Measurements – The fair value of money market and mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

The Plan did not have assets valued at Level 2 or Level 3 fair value measurements for the years ending December 31, 2024 and 2023.

Net Asset Value

The investment in the pooled separate account is valued as a practical expedient utilizing the net asset valuation as reported in the Principal Financial Group, Proprietary Pooled Separate Account Financial Statements (Unaudited) as of December 31, 2024.

The investments in the Principal LifeTime Hybrid Collective Investment Funds, collective investment trusts, are valued as a practical expedient utilizing the net asset valuation as reported in its Financial Statements (Unaudited) as of December 31, 2024.

Investments – The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded when received, which does not materially differ from the accrual method. Net appreciation/depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expense Recognition – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 4 - PRINCIPAL GUARANTEED OPTION CONTRACT

The plan has a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (“Principal”) totaling \$392,221 for 2024 and \$318,559 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 4 - PRINCIPAL GUARANTEED OPTION CONTRACT – Continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 - CERTIFIED INVESTMENTS

NOTE 6 – INVESTMENTS

During 2024, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$3,399,519.

NOTE 7 - RISKS AND UNCERTAINTIES

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9 - TAX STATUS

The Company has adopted the Volume Submitter Profit Sharing Plan and Trust, which is a prototype standardized profit-sharing plan with CODA. This prototype plan was approved by the Internal Revenue Service (IRS). The IRS has advised that an adopter of a preapproved prototype plan does not have to file for a separate IRS determination letter provided the plan is adopted without changes to the basic plan document. Although the prototype plan has been amended, the Plan administrator and the Plan's trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 10 – PLAN MERGER

In July 2022, the Company acquired Burke Consortium, Inc. The Burke Consortium Inc. 401(k) Profit Sharing Plan merged with the Plan. Its net assets totaling \$2,378,259 were transferred to the Orbis 401(k) Retirement Plan on January 11, 2023.

NOTE 11 - PARTIES IN INTEREST TRANSACTIONS

The Plan has certain service providers that are parties-in-interest under ERISA. Expenses totaling \$113,461 were paid to these service providers by the Plan during 2024. The Plan sponsor paid \$12,795 in audit fees on behalf of the Plan.

Approximately 69 percent, \$21,598,967 of \$31,812,198 of the investments held by the Plan are affiliated products of the Plan's administrative services provider, Principal Life Insurance Company, and are deemed to be party-in-interest transactions under ERISA.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 12 - SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
