Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vigor Industrial LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Vigor Industrial LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General—The Plan is a 401(k) defined contribution plan covering all eligible employees of Cascade General, Inc., Vigor Marine LLC, Washington Marine Repair LLC, Vigor Fab LLC, Everett Shipyard, Inc. and Vigor Shipyards, Inc. (the “Companies”).

Certain union employees of the Companies, excluding Vigor Fab LLC and Everett Shipyard, Inc. (non-carpenters), are eligible to participate following the completion of 90 hours within a calendar month of service, depending on employment status, position and employer. Vigor Fab LLC employees covered under union contracts following the completion of 90 consecutive days of employment within at least 80 hours a month within three consecutive months are eligible to participate in the Plan. Everett Shipyard, Inc. non-carpenter employees covered under union contracts following the completion of 90 cumulative hours of employment within three consecutive months are eligible to participate in the Plan. Additionally, certain employees are excluded based on their collective bargaining agreements.

Non-union employees of the Companies are covered under the Vigor Industrial LLC Savings Plan. As employees either join or leave a union, their account balances are transferred to the appropriate plan and are reported as transfers on the statements of changes in net assets available for benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Specific details of employer match contributions and vesting can be found in the following footnotes.

Contributions—Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participant salary deferral contributions are made voluntarily, subject to certain limits set by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan. Participants direct the investment of their contributions, and any employer contributions, into various investment options offered by the Plan.

The Companies, excluding Cascade General, Inc., makes Safe Harbor matching contributions equal to 100% of each participant’s elective deferral up to 4% of the participant’s annual eligible compensation.

Cascade General, Inc. makes Safe Harbor matching contributions equal to 100% of each participant’s elective deferral up to 8% of the participant’s annual eligible compensation for employees participating in the Plan on or before July 24, 2003. Cascade General, Inc. makes Safe Harbor matching contributions equal to 100% of each participant’s elective deferral up to 4% of the participant’s annual eligible compensation for employees participating in the Plan after July 24, 2003.

In addition, the Companies may, at their sole discretion, make discretionary contributions to the Plan. Employees are eligible to receive discretionary contributions if they are employed on the last day of the Plan year and have completed 900 hours of service during the Plan year. Cascade General, Inc. employees receiving an 8% employer match are not eligible to receive discretionary contributions. No discretionary contributions were made by the Companies for the year ended December 31, 2024.

Participant Accounts—Each participant’s account is credited with the participant’s contribution and related allocations of the Companies’ contributions, Plan earnings, and charged with withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon, and employer contributions; therefore, there are no forfeitures.

Notes Receivable from Participants—Plan participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balances. Participants must be an active employee and are only allowed one outstanding loan at a time. The loan repayment term may not exceed five years, except for those loans qualifying for the purchase of a principal residence. The loans are secured by the vested balances in the participant’s accounts and bear interest at rates that range from 5.25% to 10.50% and maturing through 2031. Interest rates are set at the prime rate plus 2.0%, at the date of the loan. Principal and interest are paid ratably through regular payroll deductions or as a lump sum for the outstanding loan balance.

Payment of Benefits—Participants’ accounts are payable upon retirement, termination, permanent disability, or death. Partial or full withdrawal of participants’ account balances are also available under certain circumstances described in the Plan document. Dependent on the circumstances, participants may be able to elect lump sum or installment payments taken over a period of time that shall not exceed the life expectancy of the employee or designated beneficiary.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans in default have been distributed based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions—Employee contributions and employer matching contributions are recorded when withheld.

Payment of Benefits—Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan but had not been paid as of December 31, 2024.

Administrative Expenses—All administrative expenses of the Plan are paid by the Plan unless otherwise paid by the Companies, at the Companies’ discretion.

Subsequent Events—The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to allow for Roth contributions. No other events occurred that require additional disclosure or adjustments to the Plan’s financial statements.

3. CERTIFIED INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule of assets (held at end of year) that were prepared by or derived from information prepared by T. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Fair value measurements include a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1—Quoted prices in active markets for identical securities;

Level 2—Other significant observable inputs (including quoted prices for similar securities, interest rates, repayment speeds, credit risk, etc.); and

Level 3—Significant unobservable units (including the Plan’s own assumptions in determining the fair value of investments).

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered Investment Company Funds—Valued based on the quoted market value of the fund, which represents the NAV of shares held by the Plan at year end.

Stable Value Fund—A collective trust fund that is composed primarily of fully benefit- responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Common Collective Trust Funds—Valued at the NAV of units of a bank collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment company funds and common collective trust funds managed by T. Rowe Price Trust Company. T. Rowe Price is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

7. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Companies, by a letter dated August 2, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and related trust is tax-exempt.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

9. PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.
