INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the Monte Sano Research Corporation 401(k) Profit-Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Monte Sano Research Corporation 401(k) Profit-Sharing Plan, (the “Plan”) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(c) audit”). Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Monte Sano Research Corporation 401(k) Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2012, covering substantially all employees of Monte Sano Research Corporation (the “Sponsor” or the “Company”). Participation is voluntary for all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Substantially all employees of the Company are eligible to participate in the Plan once they have reached age 21 or older. After an employee of the Company has satisfied the eligibility requirements, they are eligible to enter the Plan as a Participant on the first day of the month coinciding with or following the date on which the eligibility requirements are satisfied. Excluded participants are union employees, leased employees and those otherwise deemed ineligible in accordance with the Plan document.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a matching contribution of 100% of participant deferrals that do not exceed 5% of eligible compensation on behalf of each participant who is employed by the Company on the last day of the Plan year. The Company contributes a safe harbor nonelective contribution equal to 5% of compensation. The Company may also contribute a discretionary profit-sharing contribution to the Plan on behalf of each participant who is employed by the Company on the last day of the Plan year, equal to a percentage of compensation. During the year ended December 31, 2024, the Company elected to make discretionary profit-sharing contributions equal to 5% of employee compensation. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions, Company safe-harbor contributions, and allocations of the Plan Sponsor’s contribution and the Plan earnings and is charged with administrative expenses not paid by the Plan Sponsor. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 — DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon and the Company's safe-harbor contribution portion of their accounts. Vesting in the Company's matching and profit-sharing contribution portions of their accounts is based on years of service. Participants vest ratably after one year of service starting at 33.33% per year and are 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate is the prime rate as published in the Wall Street Journal, plus 1%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of services due to death, disability or retirement, a participant, or their beneficiary in case of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, or the value of the vested account by transfer to another qualified plan or individual retirement account. Terminated participants with a vested balance less than \$5,000 will receive a single lump-sum payment. In-service withdrawals may be made from all or a portion of the participant's vested account balance once he or she reaches age 59½. Participants may withdraw the vested portion of their account and income earned thereon in the event of a participant's immediate financial hardship, as defined in the Plan document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant.

Forfeited Accounts

Forfeitures are used to reduce the Company's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$10, respectively. During 2024, the Company's contributions were reduced by \$37,483 from forfeited nonvested accounts.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

NOTE 3 — FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the money market fund is reported at the carrying amount which approximates fair value because the instrument is liquid in nature.

NOTE 4 — CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Company (“Schwab”), the trustee of the Plan.

NOTE 5 — RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The expenses of administering the Plan are paid by the Plan to the extent not paid by the Company. The Company provides various recordkeeping and administrative services to the Plan for which it receives no compensation. Schwab is the Trustee and CMC interactive is the recordkeeper for the Plan. As defined, these transactions qualify as parties-in-interest and at times holds assets in a cash account. In addition, loans to participants qualify as party-in-interest transactions.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 — TAX STATUS

The Plan is a volume submitter plan, which received an opinion letter from the IRS on June 30, 2020, which stated that the volume submitter document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
