## Independent Auditors' Report

**1. Description of Plan**

The Crohn's & Colitis Foundation, Inc. (the "Foundation") adopted the Crohn's & Colitis Foundation 403(b) Defined Contribution Plan (the "Plan") on October 1, 1982. Effective April 7, 2017, the Plan changed its name from Crohn's and Colitis Foundation of America Defined Contribution Retirement Plan to Crohn's & Colitis Foundation 403(b) Defined Contribution Plan. The following description of the Plan provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General and Eligibility***

The Plan is a defined contribution plan covering all eligible employees of the Foundation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees are eligible to make salary reduction contributions to the Plan on the first day of employment. Through June 30, 2023, employees were eligible to receive employer contributions upon completing one year of service and have worked 1,000 hours. Effective July 1, 2023, employees are eligible to receive employer contributions upon completing six months of service.

***Contributions***

Each year, participants may elect to have a percentage or fixed amount deducted on a pre-tax or Roth basis from their compensation as defined by the Plan. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Foundation. Participants who are age 50 or older by the end of the Plan year can make catch-up contributions to the Plan. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Service ("IRS"). Participants may roll over amounts representing distributions from other qualified plans.

The Plan provides for an employer nonelective contribution which is allocated to each participant based on a graded formula not to exceed the Internal Revenue Code ("IRC") annual limit.

Effective July 1, 2022, the Foundation amended the Plan whereby employees receive employer contributions made by the Foundation as specified in the schedule below:

Greater than six months, but less than or equal to two years	3%
Greater than two years, but less than or equal to three years	4%
Greater than three years, but less than or equal to five years	5%
Greater than five years, but less than or equal to ten years	6%

Effective August 1, 2020, the Foundation amended the Plan to make all employer contributions discretionary. In connection with the amendment, employer contributions are to be made each year on a quarterly basis at the discretion of management. Effective July 1, 2023, employees eligible for the nonelective contribution must be employed on the last day of the quarter end.

***Contributions (continued)***

Effective May 1, 2024, employer contributions are to be made each year on an annual basis at the discretion of management and employees eligible for the nonelective contribution must be employed on the last day of the plan year.

***Vesting***

Participants are one hundred percent (100%) vested in their contributions plus earnings thereon. An employee hired prior to January 1, 2014 is one hundred percent (100%) vested in employer contributions including allocated earnings. A participant hired on or after January 1, 2014 is one hundred percent (100%) vested in employer contributions including allocated earnings after 3 years of eligible service.

***Participant Accounts***

Each participant's account is credited with employer and participant contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

***Loans to Participants/Collateralized Assets***

Up until September 25, 2020, a participant could have elected to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract with Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA and CREF"). Loans were limited to voluntary and rollover contributions. Defaults on loans were treated as deemed distributions at the time of default.

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 45% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant were made directly from TIAA and CREF at the Moody's Corporate Bond Index rate. The participant's account was not reduced by the loan amount, but served as security for the loan. The loan amount was moved into a fixed income collateral account within the borrower's account.

The loan was to be repaid directly to TIAA and CREF within a five year period in substantially equal payments (not less frequently than quarterly). The five year repayment period did not apply to a loan that was used to acquire a principal residence of the borrower. The law treats the amount of any loan not repaid five years after the date of the loan as a taxable distribution on the last day of the five-year period or, if sooner, at the time the loan is in default.

At December 31, 2024 and 2023 there were 5 and 16 collateralized loans outstanding with total principal balances due of \$33,355 and \$54,592, which also represents a collateralization of participant accounts. Of these loans, there were zero loans deemed distributed at December 31, 2024 and 2023. Interest rates on these loans ranged from 5.14% to 5.28% with maturities through 2030.

***Notes Receivable From Participants***

Effective September 25, 2020, collateralized loans are no longer offered to Plan participants. Any loan a participant has taken after this date are made directly from their retirement account. A participant of the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans may only be made from accounts attributable to pre-tax elective deferrals, employer contributions and rollovers from other plans. Participants may only have three outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. Former employees of the Foundation are not eligible to request a loan. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. In the event of a hardship distribution, only the participant's elective deferrals and earnings thereon are eligible to be distributed. In-service withdrawals are permitted in the case of demonstrated financial hardship, disability, attaining age 59 ½, and for pre-1989 elective deferrals in an annuity contract.

***Forfeitures***

In the event that an employee (hired on or after January 1, 2014) terminates before becoming fully vested in his or her account balance, the non-vested portion of the participant's account balance will be forfeited if a participant takes a full withdrawal from the Plan accounts or is separated for five consecutive years. Any forfeiture may be used by the Plan to reduce future employer contributions.

At December 31, 2024 and 2023, forfeited account balances held in nonparticipant directed accounts were \$251,824 and \$586. During 2024, no forfeitures were used to reduce employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account consists of unallocated contracts. The fully benefit responsive contracts are carried at contract value and the non-benefit responsive contracts are carried at fair value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The TIAA Real Estate is a pooled separate account that is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Expenses relating to investment management are paid directly by the respective investment vehicles and are included in net appreciation in fair value of investments. Other administrative expenses of the Plan are generally paid directly by the Plan.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 24, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

TIAA and CREF has been authorized by TIAA, FSB to certify the investments and investment information for which TIAA, FSB is the directed trustee. TIAA and CREF has been authorized by TIAA, FSB through July 14, 2023 to certify the investments and investment income information for which TIAA, FSB is the directed trustee and custodian. TIAA Trust, N.A. served as directed trustee and custodian from July 15, 2023 through December 31, 2024.

The TIAA Traditional Annuity Account is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity ("GSRA"), the Supplemental Retirement Annuity ("SRA"), and the Retirement Choice Plus ("RCP") contracts. The non benefit responsive contracts are: the Group Retirement Annuity ("GRA"), Retirement Annuity ("RA") and Retirement Choice ("RC") contracts. The Plan utilizes the GSRA, SRA and RCP contracts, which are reported at contract value, and the GRA, RA and RC contracts, which are reported at fair value.

Under GSRA, SRA and RCP contracts, lump-sum withdrawals and transfers can be done at any time. Due to the increased liquidity of GSRA, SRA and RCP contracts, these contracts are credited with lower interest rates. Under GRA, RA and RC contracts, lump-sum cash withdrawals are not allowed and withdrawals and transfers must be spread out in ten annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion is 3% and represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity Account represents approximately 10% of the Plan's net assets available for benefits as of December 31, 2024 and 2023 and represents an obligation of TIAA and CREF to repay as amounts come due. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 2024), Standard and Poor's (AA+ as of May 2024), A.M. Best (A++ as of July 2024), and Fitch Ratings (AAA as of August 2024). The Plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

**5. Plan Termination**

Although it has not expressed any intention to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent (100%) vested in their employer contributions.

**6. Tax Status**

The Foundation has adopted an IRS approved volume submitter plan that received an IRS opinion letter dated August 7, 2017. The Plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest**

Certain investments are managed by TIAA and CREF, the Plan's custodian and investment consultant. Accordingly, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants were able to obtain loans that were issued directly from TIAA and CREF to the participant. As security, a portion of the participants account in the Plan serves as collateral for the loan in case of default. Additionally, participants may now borrow from their accounts. These borrowings from participant accounts are recorded as notes receivable from participants in the statements of net assets available for benefits. Both types of loans qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Foundation who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

**8. Non-exempt Party-in-Interest Transactions**

For the 2024 Plan year, the Employer failed to transmit to the Plan contributions for participants totaling \$692,379 (\$432,870 related to the 2024 plan year and \$259,509 related to the 2023 plan year) within the period prescribed by Department of Labor regulations. The Employer is currently in the process of making the necessary corrections.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
