1. Description of Plan Benefits

The following description of the NVR, Inc. Employee Stock Ownership Plan (the “Plan” or “ESOP”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

NVR, Inc. and its affiliated companies (“NVR”, the “Company” or “Employer”) established the ESOP effective January 1, 1994. The ESOP covers substantially all employees of the Company, and is intended to provide eligible employees with an incentive to improve the performance of the Company by providing such employees with retirement benefits in the form of an ownership interest in the Company. The Plan is designed to invest primarily in the common stock of the Company (“Stock”). To facilitate investments, the Plan is authorized to operate as a leveraged ESOP. The Plan is administered by the Profit Sharing Committee (the “Plan Administrator”) appointed by the Company’s Board of Directors (“Board”).

The investments of the Plan are maintained in a master trust with the investments of the NVR, Inc. Profit Sharing Plan (“PSP”). Fidelity Management Trust Company (“Fidelity”) is the trustee and provides recordkeeping services for the Plan. Additionally, Fidelity Investments Institutional Operating Company, Inc., provides certain other recordkeeping services for the Plan. Fidelity maintains a separate account reflecting the equitable share of each plan’s investments within the master trust and reports the Plan’s share of investments to the Plan.

The Plan is intended to operate in accordance with all rules and regulations applicable to Employee Stock Ownership Plans under the Internal Revenue Code (the “Code”). Further, the Plan has been designed to comply with the provisions of the Employee Retirement Income Security Act of 1974, as amended, (“ERISA”) and with the qualification requirements of the Code.

The Plan year begins each January 1st and ends each December 31st (“Plan Year”).

Contributions

The Company’s contributions to the Plan are at the discretion of the Board and are based upon the Company’s profit for the Plan Year. Contributions may be made in cash, in shares of Stock, in other property, or in some combination thereof, as determined by the Company. Employees of the Company are generally able to share in the allocations of employer contributions provided they worked at least 1,000 hours during the Plan Year and were employed by the Company on the last day of the Plan Year. Employee contributions to the Plan are prohibited.

The Board authorized contributions of approximately \$30,200 and \$26,200 in the form of Stock for the 2024 and 2023 Plan Years, respectively. The 2024 and 2023 Plan Year contributions were contributed to the Plan and allocated to participants’ accounts in 2025 and 2024, respectively.

Participant Accounts

Each participant’s account is credited with an allocation of the Company’s contributions, Plan earnings, losses, and forfeitures, if any, resulting from the termination of employment of participants with the Company before a participant is fully vested. Plan forfeitures are not used to reduce the Company contributions. Company contributions and forfeitures are allocated based upon the proportion that the eligible participant’s compensation for that Plan Year bears to the total compensation received for such year by all eligible participants sharing in the allocation, subject to the annual addition limitation and nondiscrimination requirement imposed under the Code. Forfeitures of approximately \$2,000 and \$4,000 in 2024 and 2023, respectively, were allocated to participant accounts in 2025 and 2024, respectively.

Plan earnings are allocated based upon the proportion of the participant's account to the aggregate balance of all participants' accounts.

Vesting

Employees vest in Company discretionary contributions at the rate of 20% per year beginning with the completion of the second year of service. Employees also become 100% vested in their accounts upon reaching age 60 or upon death or total disability.

Account Diversification

Participants are eligible to diversify their vested holdings in Stock when they have completed a minimum of seven years of service ("Eligible Participants"). All Eligible Participants may diversify up to 25% of their ESOP account balance. Upon reaching 50 years of age, Eligible Participants may diversify up to 50% of their ESOP account balance. Upon reaching 55 years of age, Eligible Participants may diversify up to 75% of their ESOP account balance. Eligible Participants under the age of 50, who have been eligible to diversify for five years under the Plan, may diversify up to 50% of their account balance. Diversification provisions allow Eligible Participants to transfer a portion of their account balance from Stock into other available investment options within the Plan and/or take a distribution from the Plan either as a rollover or in cash.

Investment Options

The Plan Administrator selects the number and type of investment options available. Fidelity is responsible for maintaining an account balance for each participant. Each participant instructs Fidelity how to allocate the portion of their account balances that are eligible to be diversified. Fidelity values account balances daily. Each investment fund's income and expenses are allocated to participant accounts daily in relation to their respective account balances. Each account balance is based on the value of the underlying investments in each account.

Loans

Loans are not permitted under the Plan.

Payments of Benefits

Depending on various provisions and restrictions of the Plan, the method of benefit payment can be in the form of a lump-sum distribution or based on a deferred payment schedule. A participant may elect to receive his/her account in either shares of Stock or cash. Benefits are recorded as deductions when paid. Such amounts remaining in the Plan as a result of deferred payments are subject to daily fluctuations in value based on the underlying investments in each account.

Voting Rights

Each participant has the right to direct the trustee as to the manner in which to vote the shares of Stock allocated to the participant's account. To the extent participants do not direct the trustee to vote Stock allocated to their respective accounts, the trustee is authorized to vote those shares. Additionally, the trustee is authorized to vote shares of Stock held by the Plan that are not allocated to participant accounts, i.e. forfeited Stock held in suspense accounts.

Administrative Expenses

Trustee fees are paid from the Plan participants' accounts. Recordkeeping fees and certain administrative expenses are paid by the Plan, from Plan forfeitures. Certain other administrative expenses are paid directly by the Company.

2. Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan activity during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Income

Interest income from investments is recorded on the accrual basis of accounting. Dividend income is recorded on the ex-dividend date. Investment transactions are accounted for on a trade-date basis.

Investment Valuation and Transactions

All investments are carried at fair value.

Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net appreciation and depreciation are measured and recognized in the Statement of Changes in Net Assets Available for Plan Benefits as the difference between the fair value of investments re-measured at the investment sale date or at the financial statement date and the fair value at the beginning of the Plan Year or the original measurement at the investment purchase date if purchased during the Plan Year. Purchase and sale transactions are recorded on a trade-date basis.

Fair Value Measurements

Accounting Standard Codification ("ASC") Topic 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market for the asset or liability, in an orderly transaction between market participants at the measurement date. ASC Topic 820 establishes a fair value hierarchy for those instruments measured at fair value that distinguishes between assumptions based on market data (observable inputs) and the Plan's assumptions (unobservable inputs). The hierarchy consists of three levels:

Level 1 – Quoted market prices in active markets for identical assets or liabilities.

Investments in registered investment companies, shares of the Company's common stock, other common and preferred stock and cash are valued using quoted prices in active markets.

Level 2 – Inputs other than Level 1 inputs that are either directly or indirectly observable.

The Plan has no investments valued using Level 2 inputs.

Level 3 – Unobservable inputs developed using estimates and assumptions developed by the Plan, which reflect those a market participant would use.

The Plan has no investments valued using Level 3 inputs.

Common collective trusts ("CCT") are valued using Net Asset Value ("NAV") as a practical expedient and are not categorized in the fair value hierarchy. NAV is provided by the fund's issuer and is based on the fair value of the underlying investments held by the fund less its liabilities. Participant directed withdrawals or exchanges may be made on a daily basis, with no restrictions. In the event the Plan were to initiate a full redemption of any of the CCTs, the Plan must provide advance notice and for certain of the CCTs, the fund's issuer reserves the right to temporarily delay withdrawal from the CCT in order to ensure that securities liquidations will be carried out in an orderly business manner. The CCTs have no unfunded commitments. As of December 31, 2024, the Plan had not provided the respective trustees with advance notice to terminate the Plan's investment in any of the CCT funds.

- (i) for the entire amount of every contribution received on behalf of the Plan, every benefit payment, or other expense attributable solely to such Plan, and every other transaction relating only to such Plan; and
- (ii) for accrued income, gain or loss, and administrative expense attributable solely to such Plan.

4. Tax Status

The Plan received its latest determination letter on February 28, 2017, which stated that the Plan and its underlying trust qualify under the applicable provisions of the Code and its related trust is exempt from federal income taxes. In the opinion of the Plan Administrator, the Plan, as amended and its underlying trust have operated within the terms of the Plan during the period subsequent to receiving the determination letter and remain qualified under the applicable provisions of the Code. Accordingly, the accompanying financial statements do not include a provision for federal income taxes.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial Plan termination, affected participants will become 100% vested in their accounts.

6. Related Parties and Parties-In-Interest

At December 31, 2024 and 2023, Plan investments of \$74,726 and \$67,763, respectively, are with parties-in-interest as they are investment funds of the trustee and recordkeeper, Fidelity Management Trust Company and Fidelity Investments Institutional Operations Company, Inc.

At December 31, 2024 and 2023, investments held by the Plan included 147,977 shares and 155,053 shares of NVR, Inc. common stock, with a fair value of \$1,210,289 and \$1,085,441, respectively. These qualify as exempt parties-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

8. Subsequent Events

The Company evaluated all subsequent events through August 8, 2025, the date the financial statements were available to be issued.
